**24Oct11 – Additional Information:** On Sunday, 10-16-11, around Noon, Mrs. Dumontet and her dog were seen at the MVP Conoco Service Station off I-94 exit 157 in Bismarck, ND. The dog weighs 15 to 20 lbs, is named Peaches, and was recently groomed with a close haircut.

**21Oct11 - BOLO for Missing Person Traveling from Eastern North Dakota to Shelton, WA**

1. Mrs. Dumontet fueled her vehicle in Grand Forks on Sunday, October 16 at 0722hrs.
2. She was last seen wearing a white colored jacket, black slacks, black shoes and eye glasses. Her hair appears to be a little longer than the photo at left.
3. The truck has chrome nerf bars, black vinyl tonneau cover over the pick-up box, and chrome accent rocker panels on the lower side of the truck.
4. Based on Sunday's wind conditions and fuel mileage information for the vehicle, it is likely Mrs. Dumontet refilled fuel in Bismarck, ND sometime between 11am and 1pm and then again in Miles City, MT.
5. According to the Idaho I-90 Corridor License Plate Reader program, Mrs. Dumontet's vehicle has not traversed I-90 in Idaho.
6. According to family, Mrs. Dumontet has a heart condition.

**20Oct11 - Attempt to Locate/Welfare Check on missing elderly female, Florence Agness DUMONTET**  
Mrs. Dumontet is an 82 year old white female with white hair and blue eyes. She stands 5'0" and weighs 150 lbs. Mrs. Dumontet left her home in Grand Forks County, ND on Sunday morning, Oct 16th, enroute to Shelton, Washington to visit relatives. She was to have arrived at her destination on Monday night, Oct 17. She is generally meticulous about her schedule and stays in touch while she is traveling. She has not been heard from and her cell phone goes directly to voicemail.



Actual vehicle has black vinyl tonneau cover over pickup box.

She is driving a black 2008 Lincoln Mark LT crew-cab pickup **ND/HXY089** of which she is the registered owner. She is traveling with a **cream colored poodle**.

In her past trips to Washington, Mrs. Dumontet has always stayed overnight in Missoula, MT. Likely route of travel to Billings is I-94 and then possibly traveling I-90 to Washington.
