## **Two Video Conference Sites Added for Autism Spectrum Disorder Task Force Meeting on Feb. 15**

BISMARCK, N.D. – Two additional video conference sites have been added for the Autism Spectrum Disorder Task Force Meeting on Wednesday, Feb. 15, 2012, from 10:30 a.m. to 3:30 p.m.

Individuals interested in participating in Dickinson and Williston, N.D., can join the meetings at their local regional human service centers.

The task force was created by the legislature in 2009 to examine early intervention and family support services for individuals with autism spectrum disorder to help them remain in their homes and communities.
