## INTRODUCTION

The Annual Synar Report (ASR) format provides the means for States to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the SAPT Block Grant (45 C.F.R. 96.130 (e)).

Public reporting burden for the collection of information is estimated to average 15 hours for Section I and 3 hours for Section II, including the time for reviewing instructions, completing and reviewing the collection of information, searching existing data sources, and gathering and maintaining the data needed. ### **How the Synar report helps the Center for Substance Abuse Prevention**

In accordance with the tobacco regulations, States are required to provide detailed information on progress made in enforcing youth tobacco access laws (FFY 2011 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth tobacco access rates (FFY 2012 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate State compliance with the statute. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist States<sup>1</sup> by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including State Synar Program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

### **How the Synar report can help States**

The information gathered for the Synar report can help States describe and analyze substate needs for program enhancements. These data can also be used to report to the State legislature and other State and local organizations on progress made to date in enforcing youth tobacco access laws when aggregated statistical data from State Synar reports can demonstrate to the Secretary the national progress in reducing youth tobacco access problems. This information will also provide Congress with a better understanding of State progress in implementing Synar, including State difficulties and successes in enforcing retailer compliance with youth tobacco access laws.

## Where and when to submit the Synar report

The Annual Synar Report (ASR) must be received by SAMHSA no later than December 31, 2012. The ASR must be submitted in the **approved OMB report format**. Use of the approved format will avoid delays in the review and approval process. The chief executive officer (or an authorized designee) of the applicant organization must sign page 1 of the ASR certifying that the State has complied with all reporting requirements.

The State must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- FFY 2012 Synar Survey Results: States that use the Synar Survey Estimation System (SSES) must upload one copy of SSES Tables 1–5 (in Excel) to WebBGAS. States that do not use SSES must upload one copy of ASR Forms 1, 4, and 5, and Forms 2 and 3, if applicable, (in Excel) to WebBGAS.
- Synar Inspection Form: States must upload one blank copy of the inspection form used to record the result of each Synar inspection.
- Synar Inspection Protocol: States must upload a copy of the protocol used to train inspection teams on conducting and reporting the results of the Synar inspections.

Each State SSA Director has been emailed a login ID and password to log onto the Synar section of the WebBGAS site.

*Briefly describe all checked activities:*

Most activities in North Dakota are planned through collaborations at the local level, therefore communities plan different activities based on their level of readiness to address. Some communities have been successful in passing local ordinances to require merchant education training for all locally licensed retailers. Others require merchant and/or clerk education for any outlets failing local compliance checks. Many communities use the media to publicize their compliance inspection results. Fargo has developed one such model, taking out a full-page newspaper ad each quarter and publishing all businesses inspected by who passed and who failed. Bismarck and Minot regularly do press releases as inspections are done.

The funding source for local tobacco programs moved from the ND Department of Health to the Center for Tobacco Prevention and Control Policy (Center). Community mobilization is generally supported by these local tobacco programs funded by the Center only if a local ordinance mandates compliance checks. The ND Department of Health is beginning to work on implementing new retailer tobacco guidelines based on new FDA tobacco retail recommendations. This work has been approved by the CDC to begin working as a pilot project on a local level, with possible statewide implementation possible.

The Division will continue enforcement efforts in the same manner as in question five of Section I in this report. Additionally, the ND Department of Health will continue tobacco prevention and education efforts. Merchant education, community education, media use, and community mobilization will continue. The ND Department of Human Services will issue a public notice announcing the results of the most recent Synar Survey.

The 2009 legislative session funded a Tobacco Prevention and Control initiative (Initiated Statutory Measure No. 3), which was approved by voters in the November 4, 2008 general election. It created a new state agency, the Center for Tobacco Prevention and Control Policy. It also made North Dakota the first state to be funded at the CDC-recommended level for tobacco prevention. As a result of the funded measure, the Department of Health's Tobacco Prevention and Control Program and the Center will cooperate on tobacco prevention and control efforts within North Dakota.

Many community coalitions remain active in promoting stricter ordinances and will continue to conduct compliance checks that are tied to enforcement. These efforts have raised, and will continue to raise, awareness of youth access to tobacco.

North Dakota has 36 of 53 counties that are 'frontier,' with fewer than 6 persons per square mile. Distances, size of communities, and population dynamics affect many aspects of the issues related to decreasing use of tobacco by youth. Communities are losing young adults to outmigration. The youth/aging ratio decreases as older persons remain in their communities and as other older persons return to their roots in North Dakota to live out their retirement. Forty-eight counties have experienced net declines in population over the last two decades. Having an increasing aging population affects distribution of resources as aging adults require more and more, leaving fewer resources for youth. Logistically, youth inspectors and adult escorts must plan to conduct Synar compliance checks over a number of days and travel hundreds of miles by car in order to reach the statewide sample of outlets. Youth inspectors from different areas of the state are employed in order to reduce the number of outlets inspected and miles traveled by each youth. (No technical assistance is needed.)

Tribes are sovereign Nations, therefore, the State is unable to conduct compliance checks on the reservations without permission from tribal authorities. The Department of Health has been attempting to involve the tribes in tobacco prevention and control issues and has been successful in hiring coordinators in each tribal area. In addition, efforts have been made to create a compact with tribal authorities to tax tobacco products. At this time, one tribe has made a compact with the state. The Department of Health will continue to work with North Dakota tribes to further these goals. The Department of Human Services, too, will continue to build relationships with the tribes of North Dakota. (No technical assistance is needed.)

Column 2: 2(a) Report the number of over-the-counter (OTC) outlets in the sampling frame in each stratum.

2(b) Report the number of vending machine (VM) outlets in the sampling frame in each stratum.

2(c) Report the combined total of OTC and VM outlets in the sampling frame in each stratum.

Column 3: 3(a) Report the estimated number of eligible OTC outlets in the OTC outlet population in each stratum.

3(b) Report the estimated number of eligible VM outlets in the VM outlet population in each stratum.

3(c) Report the combined total estimated number of eligible OTC and VM outlets in the total outlet population in each stratum.

*The estimates for Column 3 can be obtained from the Synar survey sample as the weighted sum of eligible outlets by outlet type.*

Column 4: 4(a) Report the number of eligible OTC outlets for which an inspection was completed, for each stratum.

4(b) Report the numbers of eligible VM outlets for which an inspection was completed, for each stratum.

4(c) Report the combined total of eligible OTC and VM outlets for which an inspection was completed, for each stratum.

Column 5: 5(a) Report the number of OTC outlets found in violation of the law as a result of completed inspections, for each stratum.

5(b) Report the number of VM outlets found in violation of the law as a result of completed inspections, for each stratum.

5(c) Report the combined total of OTC and VM outlets found in violation of the law as a result of completed inspections, for each stratum.

## FORM 2 (Optional)

### Appropriate for stratified simple or systematic random sampling designs.

**Instructions for Completing Form 2:** In the top right-hand corner of the form, provide the State name and reporting Federal fiscal year (FFY 2012).

- Column 1: Write in the name of each stratum into which the sample was divided. These should match the strata reported in Column 1(b) of Form 1.
- Column 2: Report the number of outlets in the sampling frame in each stratum. These numbers should match the numbers reported for the respective strata in Column 2(c) of Form 1.
- Column 3: Report the original sample size (the number of outlets originally selected, *including* substitutes or replacements) for each stratum.
- Column 4: Report the number of sample outlets in each stratum that were found to be eligible during the inspections. Note that this number must be less than or equal to the number reported in Column 3 for the respective strata.
- Column 5: Report the number of eligible outlets in each stratum for which an inspection was completed. Note that this number must be less than or equal to the number reported in Column 4. These numbers should match the numbers reported in Column 4(c) of Form 1 for the respective strata.
- Column 6: Report the number of eligible outlets inspected in each stratum that were found in violation. These numbers should match the numbers reported in Column 5(c) of Form 1 for the stratum.
- Column 7: Form 2 (in Excel form) will automatically calculate the stratum RVR for each stratum in this column. The original sample size is determined by inflating the target sample size by the expected eligibility rate ( $r_l$ ) and the expected completion rate ( $r_c$ ), where  $r_l$  is the eligibility (also known as accuracy) rate from the previous year's survey and  $r_c$  is the completion rate from the previous year's survey. The original sample size can be written as:

$$n_o = \frac{n_t}{r_l r_c}.$$

The original sample size has been inflated by a safety margin of 10%.

Each youth must complete a Youth Application form, as well as consent forms signed by their parent or guardian. Each youth inspector and adult supervisor must then attend a training session conducted by the contractor using protocol set forth by the State, which follows the training document developed by CSAP. The contractor must then submit proof to the State that each of the inspectors and supervisors attended a training session, usually in the form of a signed sign-in sheet from the day of the training.
