INSTRUCTIONS FOR CERTIFICATE OF ENDORSEMENT

WHO FILES

The Certificate of Endorsement shall be filed by all candidates seeking to have their names placed on the ballot for federal, statewide, and legislative offices by endorsement of a political party in North Dakota.

WHEN TO FILE

The Certificate of Endorsement shall be filed not more than 150 days or less than 60 days, and before 4 p.m. of the 60th day, prior to any primary or special election. If the Certificate of Endorsement is mailed, it must be in the physical possession of the appropriate filing officer before 4 p.m. of the 60th day prior to the election.

This form must be accompanied with an Affidavit of Candidacy SFN 2703 and Statement of Interests SFN 10172.
