Instructions:

To complete the registration as a Home Inspector, Chapter 43-54 of the North Dakota Century Code requires the applicant to submit the following items to the Secretary of State's office:

1. Registration fee of \$200.
2. Proof of satisfactory completion of an examination on home inspection offered by one of five organizations allowed in N.D.C.C. § 43-54-03(2) and which are listed on the reverse side.
3. Proof of having errors and omissions coverage in effect for the duration of the registration period in the amount of \$100,000 or more dollars covering all home inspection activities

Until a certificate of registration is issued by the Secretary of State's office, an individual may not perform a home inspection for compensation in the State of North Dakota. A violation is a Class B Misdemeanor.

In compliance with the Federal Privacy Act of 1974, the disclosure of a social security number on this form is voluntary. Under state law, this number cannot be disclosed to the public. However, if the number is voluntarily provided, it does assist the Secretary of State's office in maintaining accurate records. The application will not be rejected if the number is not provided.
