### SUPERINTENDENT'S MESSAGE

The North Dakota Highway Patrol (NDHP) is comprised of two components: field operations and administration. Field operations includes four geographic regions and motor carrier operations. Administration includes finance, safety and education, support services, human resources, and the North Dakota Law Enforcement Training Academy (LETA).

The LETA provides basic and advanced training to law enforcement officers from multiple agencies. 922 employees from local, state, tribal, and federal agencies attended training in 2022, and 113 of those graduated from basic training to become newly licensed peace officers in North Dakota.

A variety of specialized assignments and programs contribute to the highway patrol's success including canine officers, crash technicians and reconstructionists, emergency response team members, criminal interdiction team members, drug recognition experts, an aircraft section, and a motor carrier safety assistance program.

State troopers work diligently to eliminate injuries and fatalities that result from traffic crashes, and the NDHP is a primary sponsor of the Vision Zero initiative. Core areas of enforcement include impaired and distracted driving, right-of-way and speed violations, and occupant protection. Troopers investigate complex crashes, enforce all criminal laws, protect highway infrastructure, and conduct commercial motor vehicle safety inspections.

NDHP employees focus on prevention and education efforts to improve driving behavior. In 2022, the NDHP provided 361 safety presentations to a variety of educational institutions and civic groups.

The NDHP is committed to fulfilling our public safety mission and providing professional law enforcement services to North Dakota citizens and the motoring public. Our employees value and respect the trust and authority that has been placed in us.

#### Marcellus Red Tomahawk



The North Dakota Highway Patrol's emblem contains a profile of Marcellus Red Tomahawk, a Teton Dakotah (Sioux) Indian who served as a government officer in the early years of North Dakota's statehood.


Red Tomahawk, a sub-chief, encouraged harmony among all Americans. He lived on his land near the Cannon Ball River on the Standing Rock Indian Reservation south of Mandan. He was considered a champion of his people, a noble American, and a just man.

The North Dakota Highway Patrol officially adopted the profile of Red Tomahawk as the department symbol in 1951. Red Tomahawk was inducted into the North Dakota Native American Hall of Honor in 2016, and he was recognized for his efforts in education, law enforcement, and leadership.





**ORGANIZATIONAL CHART** 


#### NORTH DAKOTA HIGHWAY PATROL ORGANIZATION CHART






### STATEWIDE CRASH STATISTICS TRAFFIC CRASHES BY TYPE-2022
















**CMV: OVERLOAD ENFORCEMENT CONTACTS**

The Northeast Region contains North Dakota's third-largest city, Grand Forks, along with the nearby Grand Forks Air Force Base. Other notable locations include the city of Devils Lake and its namesake lake, which is a popular sport fishing destination throughout the year; the Pembina Port of Entry where Interstate 29 reaches Manitoba, Canada; and the Cavalier Space Force Station near Cavalier, ND. Other population centers include, Rugby, Rolla, Belcourt, Langdon, Walhalla, Cando, Cavalier, Grafton, Park River, Larimore, Northwood, Thompson, Petersburg, Michigan City, Lakota, Mayville, Hillsboro, and New Rockford. The NE Region also shares borders with two Native American nations, the Spirit Lake Nation near Devils Lake, and the Turtle Mountain Band of Chippewa near Belcourt, ND.

Interstate 29 is the primary significant highway through the NE Region, carrying north and south traffic. International commercial traffic comprises a large part of vehicles traversing Interstate 29. US Highway 2 crosses the region east-west and is the next most significant highway.

The NE Region is home to three of the NDHP's Canine Teams, two of which are narcotic detectors and one of which is a tracking canine. The NDHP Canine Team's coordinator and assistant coordinator are posted in the region, as is the NDHP's Crash Reconstruction Team's coordinator.

### REGIONAL REPORTS NORTHEAST REGION

Larger events that occurred in the region included the 39th Annual Devils Lake Volunteer Fire Department Ice Fishing Tournament, a Morgan Wallen concert in Grand Forks, the Devils Run Car Show in Devils Lake, the Greater Grand Forks Fair, the Northern Thunder Airshow at the Grand Forks Air Force Base, weekly car races during the summer in Grand Forks, University of North Dakota Fighting Hawks Hockey, and various other events throughout the region, including at the Spirit Lake and Sky Dancer Casinos. UND Hockey routinely draws sold-out crowds of 11,000-12,000 to the Ralph Engelstad Arena in Grand Forks, equating to nearly 20% of the city's population. The Morgan Wallen concert sold out the Alerus Center in Grand Forks, with more than 20,000 fans in attendance.

Northeast Region team members participated in a number of community outreach and education events: NDSU Lake Region Roundup; Grand Forks High School law enforcement forum; Traffic Incident Management training with Thompson Fire Department and area towing companies; the Cavalier Teen Maze; the Northern Valley Law Enforcement Memorial Police Week Memorial; Alive @ 25 and Route 1000 classes in various locations; North Dakota Boys State; North Dakota Special Olympics Torch Run and Polar Plunge; Thompson Community Action Night; Grand Cities Celebration; Michigan Days; Shop with a Cop; an Opioid Roundtable; car seat checks; career fairs; and other safety presentations.

The Northwest Region contains the larger population centers of Minot, Williston, Watford City, a large portion of the Forth Berthold Indian Reservation and the Minot Air Force Base. The Northwest Region is home to several oil and gas producing counties with consistent commercial motor vehicle traffic and varying population counts and traffic volume dependent on this industry. The Northwest Region is also home to several ports of entry with Canada. Major traffic routes in the Northwest Region consist of Highway 2 (east/west), Highway 85 and Highway 83 (north/south) and Highway 52 (southeast/northwest).

The Southwest Region contains the capital city and the second largest population center in North Dakota, Bismarck-Mandan. Interstate 94 and US Highway 83 intersect in Bismarck, and the CanAm Highway, US Highway 85, linking Texas and Canada crosses the region in the west. With high levels of traffic, regional troopers remain vigilant to keep our roadways and communities safe. Below is a snapshot of the work the officers in the SW Region conducted in 2022:



Larger events that occurred in the region included the Medora musicals, Country Fest in New Salem, McQuade's softball tournament, the state track meet, events at Prairie Knight's casino, Roughrider Days in Dickinson, and Morton – Hettinger – Bowman County fairs. The region led multiple aircraft details for speeders and pursuits and is home to the plane's F.L.I.R. (forward looking infrared) operators. We also are the base to the state's premier man trailing bloodhound that many agencies rely upon.

Community outreach remains a high priority for SW Region members. The NDHP participated in car seat installation and checks, Route 1000 presentations, Alive at 25, three internships, health classes at the middle schools, bike rodeos, bus driver workshops, touch a truck in Dickinson, and National night out.

#### **Regional Efforts**

The Southeast Region continues as the busiest region for nearly all NDHP related job duties because of North Dakota's largest population center, Fargo, and the highest concentration of population across the state. Several major roadways bisect and intersect within the southeast quarter of North Dakota. The area includes hubs for manufacturing, higher education, and medical facilities. The result of the high population and industry is denser levels of personal and commercial motor vehicle traffic. These higher levels of traffic require dedicated enforcement of traffic, criminal, and commercial motor vehicle laws, but also daily crash and calls for service response. NDHP SE Region personnel remain vigilant keeping our roadways and communities safe.



#### **Regional Events**

Larger events that occur in the region include NDSU Bison Football, the Red River Valley Fair, Ribfest (Fargo), the ND Winter Show (Valley City), Big Iron (West Fargo), and the Stutsman County Fair. Countless other events occur across the region in communities big and small. The FargoDome, Scheels Arena, Red River Valley Fairgrounds, The Lights and several other event centers bring major concert events to the Fargo/West Fargo area throughout the year as well. Governor Burgum hosted the ND State of the State Address at the Fargo Theater in February. The FM Diversion construction project is in full swing and has caused traffic disruptions in the Cass County area.

### REGIONAL REPORT SOUTHEAST REGION

#### **Community Engagement Events**

Community outreach and education efforts are a high priority for SE Region members with nearly 2,000 hours spent on community policing efforts during the year. The NDHP participated in National Night to Unite events in August in West Fargo, Jamestown, Finley and Buffalo. Other events included a Sanford Kid's Safety Safari at the Red River Zoo, Sanford Ambulance 1st Responder Appreciation Event in Fargo, Jamestown Park & Rec Kid's Safety Day at the Jamestown Civic Center and Cops N Kids Christmas shopping programs in Fargo, Jamestown, and Carrington. SE Region members participated in the NDHP Toy Drive in Fargo outside Wal-Mart with the Cass County Sheriff's Office, collecting 100's of toys that were donated to a local school program to be donated to local children for Christmas. Motor Carrier Operations continued to support the overall mission of the North Dakota Highway Patrol and the MCSAP Commercial Vehicle Safety Plan to reduce the injury and fatal crash rate with commercial motor vehicles in North Dakota. Motor Carrier Operations was busy with mobile enforcement of traffic laws, size and weight laws, education and outreach, roadside and fixed site inspections, new entrant audits, safety investigations and permitting needs of the active commercial motor carrier industry in North Dakota. Every quarter Motor Carrier Operations scheduled an oil field blitz, a border enforcement day, seatbelt week, and a mobile traffic enforcement day.

## REGIONAL REPORT MOTOR CARRIER OPERATIONS

Community outreach remains a high priority for Motor Carrier Operations. Community engagement events we participated in include No Shave November, Trunk or Treat, No Zone Presentations, ND Motor Carrier Association events throughout the year, ND Highway Patrol Youth Academy, and the North Dakota State Fair. We completed 44 Safety Talks to various organizations, some of these organizations include ND Rural Electrical Cooperative Association, BSC Ag Students, ND Safety Council, Candeska Cikana Community College, Butler, M Bar D, Western Area Power Administration, Mandan Public Works, DOT Districts throughout the state, NDSCS Engineering, and Northern Improvement.

#### New Entrant Program

The New Entrant Program experienced a high volume of North Dakota-based companies requiring a safety audit within 12 months of interstate operation. The New Entrant carrier pool remained steady at approximately 459 carriers, averaging 38 new carriers per month. The program consists of a coordinator and two auditors working in cooperation with the Federal Motor Carrier Safety Administration, providing guidance to new carriers on proper operating procedures to comply with federal motor carrier and hazardous material regulations. The auditors conducted 238 safety audits on North Dakota based carriers with 18 (7 percent) failing the audit. The New Entrant Auditors must complete 32 Level I truck inspections per auditor to retain their certification. A total of 119 CMV Inspections were completed by the three auditors.

#### Permits

In 2022, 157,636 permits were issued for vehicle and load movements traveling through and into North Dakota.

Permits were issued through the permit system and by personnel at the permit office, regions and in the field. We continue to offer guidance and training to the citizens and

# motor carrier industry on the automated system to support its continued use as the method for obtaining oversize and overweight permits in ND.

In 2022, the NDHP issued 126,948 receipt-issued single-trip permits for oversize and overweight movements. This was an increase of 8,544 receipt-issued single-trip permits from 2021. The largest increase was on the actual oversize permit an increase of 6,654.

A total of 15,550 multiple-trip permits were issued in 2022 an increase from 15,123 in 2021 a difference of 427 permits. The number of 10% Durational, Custom Combine and Seasonal permits all increased.

In 2022, 157,636 permits were issued by the NDHP, up from 148,969 in 2021. It is an increase of 8,667 permits. Single trip permits increased by 6,654; multi-trip permits increased by 427; and miscellaneous permits (trip, fuel & temporary registration) increased by 15.

Total revenues collected for oversize/overweight permits in 2022 was \$12,494,508 compared to \$10,874,927 in 2021. This was an increase of \$1,619,581 or 15%. Extraordinary road use fee revenues increased from \$944,715 in 2021 to \$985,610 in 2022. The total number of overloads in 2021 was 1,087 compared to 943 in 2022. A \$10 service fee was assessed on routable single-trip permits. These fees totaled \$1,180,270 in 2021 compared to \$1,265,510 in 2022.

Three North Dakota Basic Training classes and one North Dakota Highway Patrol recruit class graduated in 2022. 113 peace officers completed their North Dakota Peace Officer Standard and Training Board licensure certification through attendance at the Academy. A total of 922 law enforcement personnel received training in 2022.

The Law Enforcement Training Academy continues to offer annual Methods of Instruction, Use of Force, and Emergency Driving trainings. Student numbers increased in 2022 compared to 2021. Online class options were offered during 2022. The third Basic academy incorporated one full week of fully online classwork for the first time in LETA history.

# SUPPORT SERVICES

In addition to the support services division commander, ten full-time and one part-time employees are assigned to the Support Services Division. The division is responsible for property, procurement, planning, project management, research, grant coordination, fleet management, policy development and accreditation. To support this division, the NDHP is assigned two full-time NDITD employees to assist with information technology needs.

#### **Procurement and Property**

Major accomplishments made by procurement and property in 2022 are as follows:

- Selected a new uniform vendor that better meets the needs of officers. Have women's uniforms for the first time. Cost savings overall with new uniforms.
- Installed new in car video and body cameras in all squad cars and with Capitol Security. Body cameras being a benefit to officers and the public.
- Purchased all SIRN radio equipment
- Radars and LIDARS purchased with available grant funding.
- Major revamping of our fleet management strategy was ongoing in 2022 with concentration on following patrol vehicle types: Ford SUV Interceptor, Chevy Tahoe Police, Ford F-250 SuperDuty, and Ford Expedition Dignitary Protection.
- Added a Project and Grants Specialist to the Support Services team.
- Began renovations of the Law Enforcement Training Academy to better serve all agencies training at the LETA. Contractor and plan solidified for LETA remodel.

#### Information Technology

Major accomplishments made by information technology in 2022 are as follows:

- Prior implementation of a new CAD system by NDDES (Hexagon) required continuous attention by the NDHP's assigned NDITD employees throughout 2022.
- Due to the implementation of new in-car and body worn cameras, major changes were made to the NDHP's video storage systems and framework.
- NDHP remained an active member of the of the Statewide Interoperability Executive Committee (SIEC) committee.

#### **Policy Development and Accreditation**

#### Cultural Liaison Officer (CLO)

Major accomplishments made by the CLO program in 2022 are as follows:

- Signed a law enforcement agreement with the Spirit Lake reservation, allowing police powers to NDHP officers on tribal lands in emergent situations.
- Created new driver classes for New Americans in the Fargo area. These classes were translated into 11 different languages.
- Coordinated and put on the first Critical Task Assessment Recruitment Event at the Law Enforcement Training Academy.
- Created and instructed Cultural Awareness Training to NDHP employees with MHA Nation and Spirit Lake Tribe.

## **SAFETY & EDUCATION**

The North Dakota Highway Patrol focuses on public outreach in several different ways. The first way is to educate the public about traffic safety issues. This is obtained through numerous outreach events across the state during the year that involve various public and private organizations. The agency also actively supports the state's Vision Zero Coordinators who focus on events and programs intended to increase public education about the Vision Zero goal of zero motor vehicle fatalities and serious injuries on North Dakota roads.

Agency participation in outreach events is intended to educate the public about law enforcement in general and the work of the patrol specifically and provide opportunities to the public to get to know the men and women of the NDHP. The agency participates in highly publicized enforcement events to highlight various traffic safety issues. During 2022, troopers were involved in over 350 outreach events across the state.

Troopers attended various outreach events throughout the state to promote Vision Zero and the patrol's traffic safety mission.

## **SAFETY & EDUCATION**

The agency educates the public about law enforcement and the work of the NDHP through events and activities such as:

Trooper Kristjan Helgoe was named as Vision Zero's 2022 Traffic Safety Officer of the Year. This award is given to one law enforcement officer each year who has displayed a wellrounded effort for traffic safety through enforcement, community education and training.

Safety and Education coordinates the agency's school bus inspection program. The program is a service provided to schools, upon request, if they are unable to have their buses inspected annually by a qualified individual. During the 2021-2022 school year the patrol received 68 requests and inspected over 500 buses.

The Safety and Education Officer serves as North Dakota's AMBER alert coordinator who oversees the AMBER alert request process in the state. These duties also include working with North Dakota Bureau of Investigation and Department of Emergency Services to approve alert requests and send them out to the public. The past year there was one AMBER Alert request and ten Silver Alert requests.

The Loss Control Committee is chaired by the Safety and Education Officer. This committee reviews department crashes and incidents and looks for ways the agency can make improvements to reduce liability. Safe Driving Awards are given to officers who have 5, 10, 15, 20 and 25 years of driving without a preventable crash.

Traffic Incident Management (TIMS) focuses on a common approach for all first responders to use when dealing with incidents that affect traffic on our roadways. This common approach is meant to reduce secondary crashes and increase safety for the motoring public and first responders. The Safety and Education Officer coordinates training across the state by working with local officials to bring the training to their areas. In 2022 TIMS was taught in several locations to include at the law enforcement training academy and at the North Dakota Fire School in February.

Safety and Education continues to be active on social media to expand our reach and educate the public about the agency and traffic safety related topics. In April, November, and December of 2022 the state experienced severe snowstorms creating blizzard conditions. Safety and Education worked with NDDOT Communications to help inform the public about the severe road conditions and road closures.

### SPECIAL PROGRAMS EMERGENCY RESPONSE TEAM (ERT)

On April 1, 2019, Lt. Adam Dvorak was assigned command of the North Dakota Highway Patrol's ERT (Emergency Response Team). Prior to that assignment, the NDHP ERT had an almost 2-year period of inactivity since the pipeline protests ended in March of 2017.

The following is a timeline of the actions taken by the team in 2022:

#### February 2022

- Additional "Project Find Safe" equipment delivered to and stored in the SW regional office, available to ERT.
- Research into "high cut" ballistic helmets for all members of ERT for tactical tracking.

#### March 2022

- SW squad met and trained in the Badlands near Medora utilizing bloodhound and sUAS as well as tactical tracking.
- Decision made to change structure of ERT from "East and West" to the four geographical regions with a squad leader assigned to each of the four teams.
- Two assistant ERT commander positions removed from structure.
- New "high cut" ballistic helmets shipped/delivered to NDHP ERT.

#### April 2022

- Physical fitness testing and shooting for ERT held in Bismarck.
- Tucker Snow Machines, ERT UTV, and Parks and Rec snowmobiles placed for impending large winter storm.

#### May 2022

• On May 27, the southwest ERT was activated to search for 2 inmates who had escaped from MRCC and fled along the Missouri River; ERT bloodhound utilized.

#### June 2022

- Southeast squad put on alert for activation of murder suspect being surveilled by Fargo Narcotics Task Force.
- On June 18, all ERT were put on alert for possible activation at Capitol for protests for Roe v. Wade decision.
- On June 24, all ERT were put on alert for possible activation for nationwide "Night of Rage".

#### July 2022

• All ERT were put on alert for possible activation for Capitol protests on both July 4 and July 9.

# SPECIAL PROGRAMS K9 PROGRAM

The ND Highway Patrol K-9 program continues to see success due in large part to the cooperation and support between handlers, troopers, supervisors, and headquarters.

#### 2022 Canine Personnel

The ND Highway Patrol K-9 program saw one personnel change in 2022. Trooper Kristjan Helgoe decided to "hang up" his leash and Trooper Gabe Irvis was selected as the new handler for the Southeast Region. Three of the NDHP K-9s also retired in 2022.

In May 2022, K-9 Boudreaux was retired from service after nearly 10 years of service. K-9 Fia retired in May, and K-9 Castor retired in June. K-9 Fia served for approximately 8 years and K-9 Castor served for approximately 7 years. These retired canines were permanently homed with their respective handlers.

Two new canines to added to the program. Trooper Irvis was assigned K-9 Lasta, and Trooper Mlynar was assigned K-9 Huck.

#### **Training and Certification**

As a collective group, handlers maintain sixteen hours of training per month, the industry standard. Regional sergeants and commanders are provided the yearly training schedule at the beginning of the year. Sergeants, commanders and administrative assistants do an outstanding job of placing these dates on schedules. Sergeants have also been doing a good job of adjusting to changes in dates of training as they occur. One east training day and one west training day occur each month.

The departure of Trooper Helgoe from the K-9 program created an open trainer's position. Interviews were conducted and Trooper Mlynar was selected to attend the narcotic detector instructor class provided by Kasseburg Canine Training Center.

# SPECIAL PROGRAMS K9 PROGRAM

In March 2022, Trooper Mlynar traveled to New Market, Alabama, to begin training instruction. During the instructor course, Trooper Mlynar trained with his new K-9 Huck, and K-9 Lasta. Trooper Mlynar also had the opportunity to assist with the training of other teams at that time. Trooper Stern accompanied Trooper Mlynar to Alabama and assisted with his instruction for the first three weeks of the eight-week course.

In May 2022, Trooper Mlynar returned to the state in time for annual spring in-service at Camp Grafton in Devils Lake. Training started at noon on a Monday and ended at noon on Friday that same week. It gets to be a long week, but all teams seem to enjoy being able to concentrate on training for the week. During in-service, scenarios were conducted along with problem solving and proficiencies. Teams from Watford City PD and the BIA were also in attendance at the in-service.

In late May 2022, Trooper Irvis began his handler training with K-9 Lasta. Trooper Mlynar conducted the 5-week training, mostly in Devils Lake. In late June 2022, Trooper Irvis and K-9 Lasta successfully completed their initial certification.

In early August 2022, Trooper Boll and Trooper Stern attended the HITS Canine Conference in Orlando, Florida. There were 3 full days of classroom instruction taught by numerous instructors. The conference is held at a different location each year and the 2023 conference will be in Scottsdale, Arizona.

In August 2022, a training session with all teams was held in Bismarck with a purpose to prepare all teams for upcoming certifications in September.

In September 2022, all narcotic teams traveled to Gillette, Wyoming for annual certification. The certifying official was Retired Gillette Police Department Sgt. Greg Brothers. During the certification process, Trooper Schatz began the process of becoming a certifying official. She will need to assist in the judging of 15 teams during certification. All NDHP teams successfully completed annual certification and were awarded the NDHP-N Certificate. Teams from the Watford City PD and Beulah PD also attended the certification.

In December 2022, the man-trailing teams traveled to Sioux Falls, South Dakota for annual certification. This had originally been planned for September but was rescheduled. The certifying official for the certification was Ret. South Dakota DCI Agent Chad Carpenter. A recent snowstorm made the certification challenging, but both teams successfully completed the certification and were awarded the NDHP-M certificate. In conjunction with the NDHP certification standards, both teams were able to regain certification with INBTI.

# SPECIAL PROGRAMS

During 2022, the narcotic detector training relationship with the Watford City PD continued and a training relationship with the BIA and the Beulah PD began. The mantrailing teams continue to train with the Fargo area K-9 group and a training relationship with the Badlands Search and Rescue team began.

#### **Bloodhound/Man-Trailing Teams Highlights**

The bloodhound/man-trailing teams continue to be available to any agency that needs their services. Many calls are from other agencies who are learning of the bloodhounds' capabilities. This is in large part due to the handlers discussing the program with other agencies. Both teams are valuable resources for the NDHP and for other agencies statewide.

K-9 Boudreaux retired in May 2022 and subsequently Trooper Mayer was able to devote more training time with K-9 Bleu.

Notable case trails for the man-trailing teams in 2022 include:

- Located a suicidal subject.
- Tracked a homicide suspect and helped locate evidence.
- Tracked a suspect who fled from a scene and located evidence to identify the driver.
- Tracked a burglary suspect and located evidence.
- Tracked an attempted murder suspect to an apartment.
- Located a domestic violence victim who left a residence.
- Tracked a missing person to a location where the individual was picked up.
- Tracked a missing person to a river along a 3-day old trail.
- Tracked an escapee from the Youth Correctional Center to where a vehicle was stolen.
- Tracked a subject who fled a vehicle crash and broke into a business.
- Tracked a missing person from a bar and located the deceased subject.
- Tracked a missing person from a rural area and located the deceased subject.

Trooper Mayer and K-9 Bleu attended and completed the FBI's Level 3 HSET training school in Fredericksburg, PA in August 2022. Trooper Mayer has been involved with INBTI and taught a 3-day man-trailing seminar in Wales, UK, in November 2022.

#### Narcotic Detector Team Highlights

The narcotic detector teams spent most of 2022 working the road; assisting other agencies; and training. While replacing and training K-9s, the NDHP was short for the first half of 2022.


### <u>K9 PROGRAM</u>

### 2022 K-9 Equipment

The transition from Chevrolet Tahoes to Ford Explorers began in May 2022. In addition to vehicles, a new kennel system and heat alarm system were installed in the vehicles. Handlers are able to sync their phone to the heat alarm and are given timely updates of temperature and alarms, allowing for a much safer environment for the K-9s.

The NDHP K-9 teams continue to work diligently to improve. The handlers continue to take on extra duties and to maintain their regular duties. The handlers enjoy the challenge of the K-9 program and are always looking for ways to improve themselves and the program. The teams continue to provide valuable assistance to any agency as needed and are willing to provide assistance when asked. The man-trailing teams and narcotic teams are a great asset to the state of North Dakota. The support of the first line supervisors, commanders, and headquarters is essential to our success. The program strives to continue to improve and bring positive feedback to the entire NDHP organization.

#### 2023 Canine Program Goals

- Maintain 16 hours of training per month, per team, and complete annual certifications.
- Continue to build relationships with other agencies and their K-9 teams.
- Invite other agencies to training sessions and attend other agencies' training sessions.
- Plan and coordinate the annual spring in-service.
- Attend available training seminars for man-trailing and narcotic handlers.
- Host a man-trailing seminar to assist other agencies and organizations.
- Plan additional joint training days with east and west handlers.
- Plan and coordinate K-9 specific interdiction details.
- Continue to evaluate and update K-9 Operations Manual as needed.
- Select and train a new narcotic K-9 for the Southwest Region.
- Select and begin training of a man-trailing puppy.
- Select and begin training of a new man-trailing handler for the puppy.
- Develop a narcotic detector instructor course for future development.
- Add a second narcotic detector team to Northwest Region.
- Add a third man-trailing team to Northwest Region.

### NDHP Annual Report 2022

Every year multiple lives are lost in fatal traffic crashes across the state of North Dakota. Each of these cases must initially be treated as a homicide investigation. The North Dakota Highway Patrol Crash Reconstruction Team (CRT) is comprised of officers specifically trained and certified to gather and analyze critical evidence at a crash scene. The services of this team include crash scene response, the recognition and gathering of critical evidence, scientific analysis, professional report writing, and expert court testimony. These services are necessary to secure criminal convictions in cases where such charges are appropriate. The statistical information included in this report supports the effectiveness and need for this team.

### Training:

The field of crash reconstruction is constantly changing with new equipment/software becoming available to measure and analyze crash scenes. It is important that all members of the CRT utilize training they have received and work with the equipment they are issued to keep their skills/knowledge sharp. Trainings take place all over the country and are a good way for members who attend to network and get to know others in the field and learn about different completed reconstructions.

In February, Trooper Thomas Steenstrup passed Part 107 certification through the FAA. Trooper Steenstrup can now operate sUAS at crash scenes for assistance in scene diagramming.

In March, Trooper Jacob Jones and Trooper Travis Nelson attended the IDRR forum training in San Diego, CA. The training focused on human factors and provided information on the 2023 version of the IDRR program.

In May, Trooper Thomas Steenstrup attended online training through IPTM and became certified as a CDR Technician. Trooper Steenstrup can now conduct CDR images for vehicles involved in crashes that the CRT is investigating.

NDHP Annual Report 2022

In July, CRT members met in Bismarck for the annual in-service. Members of the team flew a course with the drone to build proficiency. The course was taken from a training course Trooper Jones and Trooper Nelson attended in 2021 created by NIST.

In July, Trooper Jacob Jones and Trooper Travis Nelson attended a drone demonstration in Sioux Falls, SD. Several drones were on-hand to test and experts were available to talk about each drone as the team may be purchasing new drones in the near future.

In September, Trooper Jacob Jones and Trooper Travis Nelson attended the MATAI annual conference in Des Moines, IA. The conference focused on heavy vehicles and live crashes were conducted at the Iowa Speedway.

In November, Trooper Coby Hubble, Trooper Dan Andersen, and Trooper Andrew Skogen attended CRT technician training in Bismarck where Trooper Jacob Jones and Trooper Travis Nelson were instructors.

#### Training Goals for 2023 include:

- New members added to the CRT team must pass and become certified under Part 107 to operate sUAS.
- There are currently no CRT members trained in the following courses:
  - CMV Crash Reconstruction
  - Occupant Kinematics
  - Energy Methods and Damage Analysis (Crush)
  - Event Data Recorder Analyst (Level 2)
- CRT In-Service training for all members on the team.
- Send primary/part-time analysts of the team to the annual MATAI conference.
- All CRT techs trained to the level of CDR technician for vehicle imaging.
- Send the CRT Supervisor and CRT Coordinator to the reconstruction managers meeting.
- Send crash technicians expressing interest to crash reconstruction training.
- Continue to send members of the team trained to the level of reconstruction to continuing education courses to maintain and enhance skills.

Newer CRT members are encouraged to seek more advanced training to prepare to fill primary CRT slots as they are vacated through retirements or unforeseen circumstances. It is important to continually encourage, train, and mentor these newer members so the program continues to grow and operate smoothly.

# SPECIAL PROGRAMS CRIMINAL INTERDICTION TEAM

Targeting of drug trafficking, specifically criminal highway interdiction efforts, is a main component of successful crime reduction in the United States. Mexican transnational criminal organizations and criminal street gangs are responsible for a vast majority of fentanyl, methamphetamine, cocaine, and heroin trafficked in the United States and into North Dakota. These deadly drugs kill our state's citizens and plague our communities.

From extended research, and closely communicating with our surrounding state's highway patrols (MN, SD, MT, WY), the most effective method to interdict traffickers is with officers specifically dedicated and trained for this mission. In response, the North Dakota Highway Patrol formed a dedicated five-officer criminal interdiction team in August of 2021.

This is a summary of some of the items/quantities seized by the Criminal Interdiction Team in 2022:

- 2.93 pounds of fentanyl
- 726.12 pounds of marijuana
- 23.96 pounds of THC
- 25.70 pounds of methamphetamine
- 1.56 grams of cocaine
- 4.59 grams of psilocybin
- 13 illicit prescription pills
- 4 pistols
- 1 pipe bomb
- 2 vehicles
- \$93,889 cash

### SPECIAL PROGRAMS CRITICIAL INCIDENT RESPONSE TEAM (CIRT)

The NDHP Critical Incident Response Team (CIRT) was formed in January 2022 due to a need for the NDHP to respond to agency personnel needing support due to the stressors encountered through the inherent work of law enforcement. The CIRT team values the mental well-being, psychological resilience, right to confidentiality and respect for everyone receiving services.

Sgt. Matt Johnson serves as the Coordinator of the CIRT team and Trooper Chris Pulver serves as the Assistant Coordinator.

All CIRT members have been trained in peer to-peer, defusals, and debriefs. These critical incidents have been defined per NDHP Policy 6-30. The team responds to sworn and non-sworn personnel who contact a team member to request assistance for an issue of concern, whether it is work-related or personal.

Coordinator Sgt. Matt Johnson contacted the Collaborative Reform Initiative Technical Assistance Center (CRI-TAC) through the US DOJ Community Policing in Action program to request information or assistance in enhancing the CIRT program. These discussions include reformulating Policy 6-30; updating the NDHP wellness manual; resources and trainings that should be available to CIRT members; and policies that can be put in place to determine team personnel issues such as joining or leaving the team.

Fifteen debriefs with 53 hours of dedicated time were logged in 2022. Dedicated time included travel time to some of the debriefs. The CIRT assisted the ND State CISM team as well as the Minot PD, Trenton Rural Fire, Tolna First Responders, Hettinger County Sheriff's Office, Watford City PD, and Bismarck PD.

The goal of the program is to have active, engaged members who are willing to assist their peers. The assistance from CRI-TAC is promising and should help fill in the gaps and aid in constructing an effective team that provides high quality critical incident services with adequately trained members. Policies regarding the operation of the CIRT will be created and implemented.

### SPECIAL PROGRAMS AIRCRAFT PROGRAM

The North Dakota Highway Patrol flight section assists the department in providing effective and efficient services to the citizens of North Dakota. This is accomplished by providing emergency response and continuing to provide the North Dakota Highway Patrol aircraft to support all North Dakota law enforcement agencies.

Throughout 2022, most emergency requests were to assist other law enforcement agencies. Whether providing aerial support to free up resources on the ground, or providing information for officer and public safety, each mission was critical. The aircraft is also beneficial in helping to provide information that could potentially rule out larger areas of land to concentrate efforts in a more precise location.

The NDHP aircraft flew approximately 52 missions during 2022. These missions involved such things as pursuits, search for suicidal persons, blood transfers, criminal interdiction assistance, search for missing people/children, search for murder suspect, search for wanted suspects, and several traffic details.

# SPECIAL PROGRAMS HOMELAND SECURITY

Sergeant Timothy Coughlin serves as the NDHP's Homeland Security Coordinator. The homeland security coordinator's primary duty is the active participation in the North Dakota State and Local Intelligence Center (NDSLIC). NDSLIC is a multidisciplinary, multiagency organization dedicated to gathering, processing, analyzing, and sharing critical information with federal, state, local, and private sector partners. The homeland security coordinator also serves as the Intelligence Liaison Officer.

The homeland security coordinator is tasked with tracking active NDHP asset forfeitures. Six asset forfeitures were added in 2022, for a total of 40 open asset forfeiture cases.

Below is a listing of some of the activities during 2022:

- 10 E-Check background checks for weapon returns from NDHP weapon violation cases
- 1 AMBER Alert request resulting in a successful recovery
- 10 Silver Alert requests
  - Five of the requests were activated with four having successful recoveries. Three of the requests did not meet established criteria, and two of the requests were not issued due to the subject being located prior to the alert being activated.
- 35 Daily Hot Sheets submitted
- 103 Intel Briefing Summaries
- 26 Bulk Cash Smuggling Reports
- 61 DHE/HSIN Intel Alerts

# SPECIAL PROGRAMS CAPITOL SECURITY/DIGNITARY PROTECTION

Sergeant Darcy Aberle serves as the NDHP director of security, and is responsible for security at the Capitol complex. NDHP Capitol Security is comprised of one sworn sergeant, five full-time security officers, and five part-time security officers. Security is also provided for the North Dakota Supreme Court as well as members of the legislative assembly. Security training is held throughout the year for state employees that work at the State Capitol complex.

Sergeant Ryan Duletski serves as the NDHP director of dignitary protection, and is responsible for providing security and protection for the governor, the governor's immediate family, and other officers next in order of succession to the office of governor. The Dignitary Protection Team is comprised of one sergeant and two troopers.

### SPECIAL PROGRAMS CULTURAL LIAISON OFFICER

The Cultural Liaison Officer (CLO) program provides support to indigenous and ethnic groups in North Dakota, the NDHP as a department, individual law enforcement officers, and the governmental staff of North Dakota. Having an individual contact point within the agency has helped simplify, expand, and diversify relationships that benefit all aforementioned groups.

The CLO program provides a basis for the cultivation of relationships and discourse between cultural groups and the NDHP. This has created new working relationships between indigenous and ethnic groups and the NDHP and strengthened existing relationships built by the CLO program.

The CLO program continues to work with tribal nations on law enforcement agreements to enhance public safety for all citizens in North Dakota. These mutual aid agreements simplify and define law enforcement authority and jurisdiction in and around tribal land. The CLO program will work to maintain tribal partnerships to ensure agreements remain in place for all affected parties.

This is an overview of significant items fulfilled during the 2022 calendar year:

- Attended the CLD Fundamentals class that was put on at the Four Bears Casino at MHA by NDLTAP/UGPTI with the assistance of Trooper Anthony Hoaby and Doug Hoopman.
- Attended multiple MHA Transportation Directors meetings to help answer questions and concerns and to help facilitate better communication with ND DOT.
- Coordinated and put on the first NDHP CTA Fitness Recruitment event in January.
- Visited the Fargo PD, Grand Forks PD, Grand Forks SO CLOs on multiple occasions, as well as the Bismarck PD CEOs.
- Daily or weekly communication inter-agency, with tribal nations, and Indian Affairs Commission.
- Hosted or attended meetings with each tribal nation at tribal headquarters and in Bismarck.
- Met with sheriffs that overlap MHA Nation multiple times and conducted meetings with all parties at MHA Judicial Chambers to facilitate agreements.
- One year anniversary of the MHA Law Enforcement Agreement. Held meeting with MHA Chairman Fox, Councilwoman Brugh, Governor Burgum, Attorney General Wrigley, and Colonel Solberg to discuss the first year and continuing use of the agreement.
- Attended multiple powwows throughout the state, including the Standing Rock Powwow where multiple NDHP employees were honored.
- Continued to work with all tribal nations on law enforcement agreements and had meetings with all tribes.

# SPECIAL PROGRAMS CULTURAL LIAISON OFFICER

- Successfully signed and implemented a law enforcement agreement with Spirit Lake Nation at the Strengthening Government to Government Relations Summit.
- Presented at the Strengthening Government to Government Relations Summit.
- Created and conducted a jurisdiction agreement training for the agency, specifically the NE Region.
- Instructed Cultural Awareness at the LETA. Created and instructed LGBTQ Community Considerations for Law Enforcement at the LETA.
- Instructed Cultural Awareness for Minot PD and Bismarck PD.
- Attended the ND LGBTQ+ Summit in Mandan.
- Attended multiple career fairs throughout North Dakota.
- Educated tribal entities on the alerts system. Coordinated communication with tribal entities and Amber Alerts in Indian Country representatives.
- Provided safety talks at multiple tribal schools throughout the state.
- Created Winter Driving course for New Americans and coordinated with Adult Learning Center in Fargo for classes first part of January 2023.
- Worked with Bureau of Indian Affairs and tribal nations on missing person cases, had one Amber Alert with MHA Nation that was activated and one Silver Alert with Turtle Mountain that was activated.
- Facilitated a ND Crime Trends meeting on behalf of the Governor's Office including tribes.

# SPECIAL PROGRAMS HONOR GUARD

**Training:** The Honor Guard trains a minimum of four times each year in accordance with the honor guard operations manual. This was surpassed in 2022 as training occurred before each detail.

**Management:** The team currently has a standardized matrix for guidance for participation which was modeled off the matrix used in Minnesota. The sergeants on the team each lead a detail and are in charge of the training block. Sgt. Tim Coughlin is the head of the firing detail, Sgt. Chris Messer is in charge of the flag detail, and Sgt. Adam Malafa is in charge of the casket detail.

**Staffing**: The ideal strength of the NDHP Honor Guard team is 16 members plus the commander. Three vacancies occurred on the team in 2022 and two were filled. Two staff have requested to be on the team and will be added in 2023: Trooper Reece Burckhard and Security Officer Jodene Suko. Uniforms for the new members have been difficult to obtain and formal training is scheduled in Minnesota in September 2023.

### AWARDS GOVERNOR'S AWARDS FOR EXCELLENCE IN PUBLIC SERVICE

The Governor's Awards for Excellence in Public Service recognizes team members for making a positive difference in the lives of North Dakota citizens through their dedicated work in state government.

**Roaming Bison Award (Team Award):** The NDHP was a recipient of the award as part of the 2022 Spring Storms Response team for their efficient and collaborative response to two major weather events this past spring and going above and beyond to implement solutions, provide critical assistance and save lives.

### STATE RADIO MOBILE OPERATOR OF THE YEAR

The North Dakota State Radio Mobile Operator of the Year Award is given each year to an emergency response partner who uses proper radio etiquette while coordinating with dispatchers and other units and for maintaining professionalism during radio calls. **Trooper Shawn Fulwider** was named the 2022 Operator of the Year. The nominators for the award said, "Shawn is always so helpful in the field. He is always calm and clear on the radio no matter what situation may be going on. We all really appreciate him. We had some great nominees this year again and, as always, the votes are close. We appreciate all our law enforcement."

Trooper Tarek Chase, Trooper Steve Clark, Trooper Grant Lonski, Trooper Kristina Luhman and Sgt. Brian Mehlhoff were all nominated for the 2022 award.

### SAVED BY THE BELT

**Abrielle Schnurr,** Fargo, ND, received the Saved by the Belt award for a crash she survived on Jan. 10, 2022, in Cass County. Schnurr was driving in the left lane of two lanes on northbound I-29 and was in the process of passing a semi when a wrong way driver (southbound in the northbound lane) appeared. The semi moved to the east shoulder and Schnurr swerved to the right and lost control. She steered to the left and over corrected and slid into the median and halfway through the median, the vehicle went into a roll making one complete rotation and landing on its tires. The front driver window shattered completely; the side curtain airbags all the way around went off. The steering wheel airbag went off and the airbag in the left side of the driver seat went off. Driver one was seat belted during the crash and due to wearing a seatbelt only suffered a bump on the head. *Abrielle was nominated for the award by Trooper Kristjan Helgoe*.

### AWARDS COLONEL'S AWARD FOR EXCELLENCE

The Colonel's Award for Excellence is an avenue for the superintendent to award personnel and citizens who are deserving of special recognition. Nominations may be submitted by NDHP employees, and citizens may nominate an employee. The following individuals were presented with an award in 2022.

**Recipient: Pastor James P. Hessler**, Dickinson, ND, for his 28 years of service to the North Dakota Highway Patrol as a department Chaplain. In March 1994, Pastor Hessler, was appointed as an NDHP Chaplain in Dickinson and served the NDHP and citizens of Southwestern North Dakota with distinction and compassion. He provided emotional, moral, and spiritual support to NDHP members and numerous crash victim family members over the years. *Nominated by Sgt. Wade Kadrmas.* 

**Recipient: Kathy Nelson**, Bismarck ND, who showed utmost dedication towards the agency and the citizens of North Dakota. Kathy served the agency as an exemplary steward of NDHP's records, invoices, and grants and kept a watchful and vigilant eye on the administrative paperwork completed by NDHP employees to keep things running smoothly and in accordance with rules and regulations. *Nominated by Lt. Adam Dvorak and Judy Rosendahl.* 

**Recipients: Dave and Dayson Dannewitz**, Minot, ND. The father-son team assisted Sgt. Jeremiah Bohn and Trooper Austin Hilzendeger who became stranded near the US-83 snow gate south of Minot on April 13, 2022. Weather conditions were causing near zero visibility and covering the road with large snow drifts as high as the road closure gate, making it impossible for vehicles to get through. Dave and Dayson helped both Bohn and Hilzendeger dig out their squads, but the conditions made those efforts futile. Ultimately the two gave Sgt. Bohn and Trooper Hilzendeger rides on their snowmobiles. *Nominated by Sgt. Jeremiah Bohn.* 

**Recipient: Michael Mellmer**, Reeder ND. On the evening of April 23, 2022, Trooper Tuhy took a call of a CMV in the ditch on Highway 12 which was blocking both lanes of the highway and the region was in the middle of an extreme blizzard with zero visibility, 40+ mph winds, heavy snow, and ice-covered roads. Trooper Tuhy called Mike Mellmer, who lived nearby for assistance. Mike did not hesitate and within 20 minutes was on scene with a tractor and hooking up to the CMV to clear the traffic hazard and escort the driver to safety. *Nominated by Trooper Craig Tuhy.* 

**Recipients: Richard Reidhammer and Wesley Kern**, Fargo, ND. On June 5, 2022, a motorist suffering a medical emergency lost control of the vehicle which crossed the median, then the eastbound lanes of I-94 and then entered Hobart Lake. Kern and Reidhammer both stopped at the crash scene, entered the water and swam out to the vehicle and pulled the driver from the passenger side door. Kern stayed with the driver and helped him swim to shore. Reidhammer learned there was a dog in the truck and went underwater and retrieved the dog, helping her to shore. *Nominated by Trooper Daniel Andersen.* 

### AWARDS COLONEL'S AWARD FOR EXCELLENCE

**Recipients: Trooper Dan Hanson, Kayla Williams, Elie Williams,** Williston, ND **and Tayla Dean, Cory Landsverk,** Tioga, ND. On July 28, 2022, a single-vehicle crash involving an ATV occurred in rural Williams County in which a male was severely injured. Several people stopped and came to aid the crash victim, contacted 911, and began CPR. Due to the location of the crash, it took a significant amount of time for emergency responders to arrive. The individuals continued to provide life-saving CPR until responders arrived and took over treatment. *Trooper Dan Hanson nominated the citizens involved; Williams County Deputy Tanner Tougas and NDHP Sgt. Michelle Romans nominated Trooper Hanson.* 

**Recipients: Trooper Cameron McCann, Deputy Ross Krause, Nash Heminger, Alyssa Redday,** Fargo, ND. On August 21, Nash Heminger and Alyssa Redday were traveling south on I-29 and exiting at MM 48, while on the ramp, they observed a male pedestrian that appeared in distress. They pulled over and asked the male if he needed assistance when he collapsed on the shoulder of the exit ramp. Alyssa immediately called 911 and Nash began, and continued CPR until Trooper McCann arrived. At one point the male began to breath on his own and was placed into a recovery position, but he stopped breathing a second time. Nash took over CPR while Trooper McCann retrieved his AED. Cass County Sheriff's Deputy Ross Krause arrived and both he and Trooper McCann continued CPR until the Kindred Ambulance Service took over. *Nominated by Captain Bryan Niewind*.

**Recipients: Trooper Andrew Cashin and Fargo Police Officer Joshua Persson**, Fargo, ND. On August 29, 2022, a woman was experiencing a mental health crisis, and was running through traffic and jumping over barriers on the I-29 and 13th Ave. South overpass. She then sat on the guardrail, threatening to jump. Persson and Cashin both provided compassionate assistance and convinced her that her life was worth saving; and then assisted her in coming down from the barrier where she was transported for care by the two officers. *Nominated by Captain Bryan Niewind.* Cashin and Persson also received the NDPOA lifesaving award.

#### Recipients: Richland County Sheriff's Deputy Steven Nelk and Shelby Tschakert,

Wahpeton, ND. On October 22, 2022, Shelby stopped and rendered aid to a motorcycle crash victim on Richland County Road 8, the motorcycle was burning, and Shelby pulled him from the fire and began CPR. Deputy Nelk arrived shortly afterward and assisted with CPR. The driver of the motorcycle had no pulse and their life saving CPR efforts revived the driver. *Nominated by Trooper Cody Nuenthel.* Nelk and Tschakert also received the NDPOA lifesaving award.

### AWARDS COLONEL'S AWARD FOR EXCELLENCE

**Recipients: Sgt. Matt Denault, Trooper Gabe Irvis, Ryan Jamieson, Scott Kaufman, Jake Morton, Willie Walski, and Tygr Palmer,** Fargo, ND. On November 23, 2022, five Fargo District NDDOT employees were repairing the cable median barrier along westbound I-94 near MM 334 in Cass County. A vehicle approached the lane closure at approximately 75 mph and struck the impact attenuator, and striking one worker, Ryan Jamieson, who became pinned against the cable median barrier. Ryan told the others to use a chop saw to cut the cable. Jake Morton called 911 and Tygr Palmer and Willie Walski worked on trying to use a chop saw which wouldn't start. Scott Kaufman got in the other NDDOT pickup and drove it into the median and used the bumper to push on the cable barrier which released enough tension so that Ryan could be moved. Trooper Gabriel Irvis and Sergeant Matthew Denault were the first NDHP personnel and emergency responders on scene. They treated Ryan's leg wound and keeping him awake and talking and continued to monitor Ryan until the Casselton Ambulance arrived. *Nominated by Captain Bryan Niewind.* Denault, Irvis, Jamieson, Kaufman, Morton, Walski, and Palmer also received the NDPOA lifesaving award.

**Recipients: Trooper Jacob Jones and Trooper Rob Moyle**, Bismarck, ND. On December 14, 2022, an 18-year-old male at the Apple Creek rest area near Bismarck had been Face Timing his mother concerned that he had overdosed; the mother called State Radio. Trooper Rob Moyle arrived on scene first and found the male unresponsive, he contacted the mother to get more information. An ambulance was enroute, but due to road conditions, couldn't arrive for 40 minutes. Trooper Jacob Jones arrived on scene and, along with Trooper Moyle, made the decision to transport the male themselves in a squad car, Trooper Jones drove while Trooper Moyle administered Narcan. *Nominated by Sgt. Brian Mehlhoff.* 

Recipients: Greg Corcoran, Eric Sperling, and Shawn Sperling, Garrison, ND.

On December 25, 2022, the McLean County area was experiencing extreme winter weather: low wind chill temperatures, heavy snow, and high winds were creating zero visibility. McLean County dispatch requested assistance for two stranded motorists on the Garrison Dam. Due to the zero visibility, the roadway was blocked, and the stranded motorists had to wait until conditions improved. Once visibility improved, Trooper Christa Kovarik made her way toward the stranded motorists. Upon arriving, she realized ND Parks and Recreation employees, Park Manager Greg Corcoran and Ranger Eric Sperling, along with Shawn Sperling had plowed a path and located the stranded motorists. *Nominated by Trooper Christa Kovarik.*

- **1935:** The North Dakota Highway Patrol was created when the 1935 Legislative Assembly gave the state highway commissioner, with the consent of the governor, authority to appoint a state highway patrol superintendent and assistant superintendent.
- 1936: The state highway patrol superintendent was authorized and empowered to appoint not more than 10 persons to constitute such state highway patrol to be known as "Highway Police." Five men were appointed with a duty to enforce North Dakota laws relating to the protection and use of public highways in the state and the operation of motor and other vehicles upon said highways. These highway patrol officers were vested with all the powers and performance of duties held and performed by peace officers in North Dakota. The jurisdiction of the officers extended throughout the state.
- 1936: In 1936, three additional men were added to the regular staff, bringing the staff total to eight.
- 1937: In 1937 the staff was increased to 12 patrolmen, including the superintendent, which filled the quota allowed by the 1935 Legislative Assembly.
- **1941:** The 1941 Legislative Assembly authorized the Patrol to be increased to 20 men, including the superintendent and assistant superintendent.
- 1947: The authorized strength of the Patrol was increased to 42 uniformed officers.
- 1947: A law was passed making it necessary for all new drivers to take a driver's examination and the responsibility to conduct these examinations fell on the shoulders of the Highway Patrol. Examinations were scheduled and were given throughout the state at strategic places once or twice a month. These examinations included a test of the applicant's eyesight; the ability to read and understand highway signs regulating, warning, and directing traffic; knowledge of the traffic laws of this state; and an actual demonstration of the ability to exercise ordinary and reasonable control in the operation of a motor vehicle.
- 1951: The 1951 Legislature gave the power of appointment of the superintendent and assistant superintendent directly to the governor. It was also mandated each patrolman be bonded by the state and each carry a badge of authority "with the seal of the state in the center thereof;" the words "North Dakota Highway Patrol" emblazoned around the border.
- **1955:** The 1955 Legislature authorized an additional increase in staff, and after comprehensive written and oral examinations were given to approximately 150 applicants, nine men were selected as patrolmen and reported for duty July 1, 1955.
- **1955:** The 1955 Legislative Assembly gave the superintendent of the Highway Patrol power to set up districts as deemed necessary and to designate ranks lower than assistant superintendent. Subsequently, the state was divided into eight districts and a sergeant appointed to supervise the work of the men in each district. This has proved invaluable in coordinating work in the field and the state officers.
- **1957:** The 1957 Legislature granted an increase to 17 men to the Patrol, thereby making the total strength 68. Five of these officers were provided when the department was given the additional responsibility of enforcing Public Service Commission regulations.
- 1959: The 1959 Legislature authorized an additional 10 patrol officers resulting in a departmental total of 78 sworn uniformed officers.
- **1961:** In addition to the superintendent and assistant superintendent, the position of property officer was added to the department staff.
- **1963:** Two men were added to the department with the creation of the Public Safety Division. The staff position of safety director was created, and this brought the number of sworn personnel in the department to 80. District commanders were elevated to the rank of captain, and sergeants were created to serve as their assistants.
- **1964:** The positions of driver license examiner and training officer were created and added to the department staff. The superintendent and assistant superintendent were given the rank of colonel and major, respectively.

- **1965:** The authority of the Highway Patrol was expanded to include the enforcement of criminal laws at all state institutions. Employees were authorized to serve in each of the eight district offices as clerks. The position of operations officer was added to the department staff, and the positions of driver licensing examiner and property officer were abolished.
- **1966:** The position of operations and training officer was added to the department staff, and the existing operations officer and training officers were made his assistants.
- **1967:** Department authority was expanded to include the enforcement of all criminal laws on highway rights-of-way.
- **1969:** The Patrol was given the responsibility of regulating all commercial driver training schools in the state.
- 1970: The department reorganized district boundaries to conform with the governor's regionalization requirements. The assistant superintendent and the operations and training officers were elevated to the ranks of lieutenant colonel and major, respectively.
- 1971: Responsibilities were expanded to include the operation of the Law Enforcement Training Center. Seventeen training programs were offered at the new facility during the first year of operation.
- **1973:** The Legislature authorized a total of 82 Highway Patrol officers. The hiring of the additional officers was predicated on enforcement of Public Service Commission rules and regulations.
- 1975: After completing a special selective traffic enforcement program which consisted of 13 patrol officers funded by the National Highway Traffic Safety Administration, the Legislature authorized the Patrol to increase its strength.
- 1978: The Patrol was authorized to hire an additional seven officers to enforce the 55 miles-per-hour speed limit. National Traffic Highway Safety Administration funded the additional staff for three years.
- **1979:** Trooper Heidi Sand was hired in 1979. She served North Dakota citizens with the NDHP for five years.
- **1982:** Effective May 1, 1982, the North Dakota Highway Patrol relinquished primary responsibility for the administration of driver license examining. Renewal, written, and road test was changed to an instant issue under the supervision of the Highway Patrol.
- **1983:** Although the chief driver's license examiner was a uniformed staff officer, the field examiners were civilian personnel.
- **1983:** Effective July 1, 1983, truck regulatory employees were reclassified as Highway Patrol personnel. Uniformed officers would have the powers of a peace officer after mandated training and being sworn. This brought the Highway Patrol's total authorized strength to 125 sworn officers. The Patrol adopted the Motor Carrier Safety Assistance Program (MCSAP). The safety regulations relate to commercial motor carriers.
- **1985:** Several functions were conducted in 1985 in celebration of the department's golden anniversary. Patrol cars were equipped with distinctive license plates; billboards were posted around the state with a safety message in conjunction with identifying the fiftieth year; an open house was held at the district offices; and a departmental banquet was held in Bismarck on September 14, with current members and many former members of the Patrol in attendance.
- **1985:** A tactical team was created and implemented eventually becoming the emergency response team which primarily focuses on crowd control, search and rescue operations, and dignitary protection.
- 1986: Reports are generated annually to record department activities.
- 1987: Although the Patrol hadn't formally offered driver's license written or road tests since 1982, legislation was enacted removing this responsibility from the Patrol and placing it under the power and jurisdiction of the highway commissioner.

- **1989:** The agency attained national accreditation status from the Commission of Accreditation for Law Enforcement Agencies on July 29, 1989, becoming the first law enforcement agency in the state to become accredited, and also the eighth state agency and the 109th national agency to receive this status.
- **1991:** The position of planning and research officer was added to the department staff.
- **1992:** The Highway Patrol added its first K9 unit to the force. The 1 ½-year-old German shepherd, Shadow, and his handler work out of Linton, ND. Shadow was trained to protect his handler, apprehend people, search buildings and areas, look for evidence, and track. Shadow's assistance was made available to other law enforcement agencies and the public.
- **1992:** The Highway Patrol added two Capitol security officers to assist with enforcement on the capitol grounds and to provide security for the Supreme Court and during the legislative session.
- **1994:** Effective January 1, 1994, the North Dakota Highway Patrol reorganized, moving from eight districts to five districts. Each district is overseen by a district commander.
- **1995:** With the North Dakota Highway Patrol participating in the federal COPS Ahead Program, the agency was authorized to increase sworn officer strength by three, bringing the authorization to 127 sworn officers.
- **1995:** The North Dakota Highway Patrol initiated a special project, "North Dakota 88 Shutdown," in an attempt to keep traffic fatalities below the 88 recorded in 1994. This project involved all law enforcement agencies in the state. Success was met with North Dakota recording 74 traffic fatalities, the fourth-lowest death toll in the state's history.
- **1996:** Two K9 units, both German Shepherds, were added to the force. Thor and his handler work out of Minot. Chase and his handler work out of Hillsboro. The Patrol's three K9 units play an important role in the Highway Criminal Interdiction Program.
- **1997:** The Patrol was authorized to increase the sworn officer strength by five. This brought the total authorization of sworn officers to 132.
- **1999:** A detailed, four-year planning process involving leadership from the governor's office, approval of the legislative assembly, and citizen support became a reality with the addition of a mobile data communications system. Sixty-five patrol vehicles were equipped with a high-tech mobile data communications system. The system utilizes a laptop in a wireless environment with the aid of ten tower sites located statewide. The efficiency of this system is recognized through enhanced officer safety, improved communications, reduced data entry/improved data handling efficiency, and reduced dispatcher workload.
- **2000:** Effective March 1, 2000, the North Dakota Highway Patrol returned to the organizational structure consisting of eight districts with each headed by a district commander.
- 2000: In May, the agency held its first sobriety checkpoint. The checkpoints were initiated in an effort to reduce impaired driving and make highways safer.
- 2001: The Patrol moved into Phase II of the mobile data computer project. This phase included the installation of an additional 20 systems, bringing the total to 95 vehicles equipped with this technology. Five additional tower sites were also included in this phase of the project.
- 2002: The Patrol continued to increase its use of electronic technology with the implementation of the E-Permits Application Phase I project. Several types of commercial vehicle permits for the motor carrier industry (fuel, trip, longer vehicle combination, 10% weight exemption for harvest and wintertime, resident custom combiner) went online.
- **2003:** The Patrol was authorized to increase the sworn officer strength by three. This brought the total authorization of sworn officers to 135.

- 2003: The NDHP added four K9s to the department in May of this year: two male black labs, Tyson (Devils Lake), and Smoke (Bismarck), one male chocolate lab named JJ (Fargo), and one female yellow lab named Bailey (Williston). All K9s are dual-purpose; and are trained for narcotics detection, article searching, and tracking. The status of three of the department's K9s changed: Shadow was retired for medical reasons and was replaced with Ricco (Linton), a male Belgium Malinois. Ricco was also certified for aggression and is the only aggression K9 in the department. Thor was also retired this year due to medical reasons and was replaced by a female yellow lab named Sierra (Minot). Chase and his handler are no longer with the department.
- 2003: Weigh-in-motion technology is a process of screening out legal weight trucks subjecting only potentially overweight trucks to further weighing on portable or fixed scales. Data on vehicle weights is instantaneously made available to troopers through mobile data computers located in their patrol vehicles. This technology was used at four sites on North Dakota's highways. The use of WIM is a joint venture between the NDHP and the NDDOT.
- 2003: On August 30, 2002, Governor John Hoeven issued Executive Order 2002-06 directing the superintendent of the NDHP, in cooperation with the Division of Emergency Management and other state agencies, local law enforcement, and broadcasters, to develop policies and procedures for child abduction incidents. The plan was fully implemented in February 2003.
- 2004: The North Dakota Highway Patrol promoted Lori Malafa to the rank of captain on April 8, 2004. With the promotion, Malafa was assigned as the training director at the Law Enforcement Training Academy in Bismarck. Captain Malafa was also the first female to be promoted to sergeant.
- 2004: A drug recognition expert program was created and implemented to help identify impaired drivers and remove them from our roadways.
- 2004: In April, the NDHP K9 program was expanded to include three additional K9s and handlers, bringing the total to nine teams.
- 2005: Operation Border Shield was developed to assist the US Customs Border Protection and US Border Patrol in the security of the northern border. The program targeted the ports of entry to detect and apprehend criminals and contraband using NDHP K9 teams. K9 teams assisted the immigrations and customs enforcement personnel in searching vehicles and persons during peak travel times identified by Custom Border Protection officials.
- 2005: All security duties for the capitol were placed under the direction of the Highway Patrol. A director of security was appointed with four full-time and four part-time employees assigned to the capitol security function. A new duress alarm system was installed in the Capitol and surrounding state office buildings as well as additional video cameras. In July, capitol security equipped a Smith and Wesson tactical mountain bike with lights and a siren for special events and security patrolling during the summer months.
- 2007: The Patrol was authorized to increase the sworn officer strength by two. This brought the total authorization of sworn officers to 140. (In 2004 and 2006, three authorized non-sworn positions were transferred to sworn positions.)
- 2007: The North Dakota Highway Patrol made an organizational structure change going from eight districts to four regions with all eight of the former district offices remaining in place. Each region is headed by an administrative commander and includes an operations commander. The reorganization also created a new Motor Carrier Operations component which includes personnel involved with commercial motor vehicles.
- 2008: The Highway Patrol purchased a 2007 Cessna T 206 airplane equipped with G1000 Garmin avionics and forward-looking infrared technology (FLIR). The airplane will be used to assist with search and rescue operations; conduct aerial searches after natural and man-made disasters; assist ground officers during pursuit operations; assist various state, local, and federal agencies; transport department personnel; and other law enforcement functions.

- 2010: The ND Highway Patrol celebrated 75 years of service since the agency was created by the 1935 Legislative Assembly.
- **2010:** A crash reconstruction team was created and implemented consisting of crash reconstructionists and technicians to more efficiently process serious crashes. Crash reconstructions assist in both criminal and civil proceedings and help bolster personal responsibility while operating a vehicle.
- 2012: The NDHP received its eighth accreditation award.
- **2013:** An automated routing permitting system was implemented to process routes for oversize and overweight vehicles online.
- **2013:** The ND Highway Patrol honor guard team was created and implemented to assist with special ceremonies and funerals.
- 2013: A bloodhound team was added to the K9 program to assist with human tracking.
- 2014: The agency was reorganized into five divisions with three in field operations (west, east, and motor carrier) and two in administration (support services and administrative services).
- **2015:** The construction of a new emergency vehicle operations driving pad and indoor firing range was completed on land donated by the City of Bismarck. The city also transferred an existing outdoor firing range to the NDHP.
- 2015: The NDHP received its ninth accreditation award.
- 2017: The NDHP purchased a skid car system for improved emergency vehicle operations training. All sworn officers were certified in the use of less lethal munitions, and emergency response team members were certified as grenadiers.
- **2017:** The NDHP supported Morton County with public safety efforts during the construction of the Dakota Access Pipeline.
- **2017:** A cultural liaison officer position was added to the NDHP to assist with strengthening relationships with tribal nations and new Americans.
- 2017: The department of transportation, department of health, and highway patrol were selected as lead agencies for a new Vision Zero initiative in North Dakota. The goal of Vision Zero is zero fatalities and serious injuries on North Dakota roads. To reach that goal, every driver and vehicle occupant must take personal responsibility for their safety.
- 2018: The NDHP received its tenth accreditation award with excellence, successfully obtaining its first "Gold Standard" assessment.
- 2018: The NDHP began a transition to black patrol vehicles with a logo on each door.
- **2018:** The NDHP youth academy was re-instated to help spark interest in the highway patrol and a career in law enforcement for ages 16-19.
- **2019:** The NDHP developed an unmanned aerial vehicle (UAV) program to assist with crash investigations and search and rescue operations. The NDHP was the first state highway patrol agency in the nation to receive a waiver to operate UAVs over people.
- **2020:** The NDHP created a wellness committee focused on physical, social, mental, emotional, and financial health of employees and their family members.
- 2021: The first tribal agreement for mutual law enforcement services was signed with MHA Nation.
- 2021: A five-member criminal interdiction team was created.
- **2022:** The NDHP signed the 30x30 pledge, a nationwide initiative whose goal is to increase the representation of women in law enforcement to 30% by the year 2030.
- **2022:** A tribal agreement for mutual law enforcement services was signed with Spirit Lake Tribe.
