NARRATIVE: A 2023 Ford F-150 driven by Kylee Reviere was traveling northbound on Highway 85 near mile marker 158. Reviere lost control of the vehicle, crossed over center, and into the southbound lane. A 2023 Ford F-150 driven by Clinton Wilson, 2011 Chevrolet Silverado driven by Fernando Ponce, and a 2022 Ford F-250 driven by Juan Alonso Carillo were traveling southbound on Highway 85. Wilson's F-150 collided with Reviere's F-150. Ponce's Chevrolet Silverado and Carillo's 2022 Ford F-250 were subsequently struck by the two F-150's. Reviere sustained minor injuries and was transported by the McKenzie County Ambulance to McKenzie County Health. Wilson sustained minor injuries and was transported by the McKenzie County Ambulance to McKenzie County Health. Ponce and Carillo were not injured.

The crash remains under investigation by the North Dakota Highway Patrol.
