CDL Permit and Driver Training*

FBCC is fortunate to be able to offer CDL driver, safety & permit training to residents on the Fort Berthold Reservation. Students are awarded 1 credit for safety & permit training class, and 8 credits for CDL Driver training class.

We have had a total of 33 students register for the classes. A total of 30 students have gone through the safety, permit class, and 10 students went through the CDL Driving training, upon which 6 have successfully completed and obtained their CDL License. 4 students are still working on obtaining their license. We have 3 students that are in the driver training and will take their driver tests the end of June, and we have 3 students ready for the July class.

Safety permit training classes are held every two weeks by the safety/permit trainer, Kenny Lyson. The Project Manager takes care of the paperwork and coordinating the classes.

Hours are spent setting up classes, following students through the application process, which curtails background checks, physicals, drug tests, and making sure all applications are complete, and sent to Center for Transportation Safety. They must have paperwork two weeks before students are eligible for the driving training.

We are seeing an increase in the number of students enrolled this summer, as more jobs become available.

One of the students owns their own trucking company and have hired on two students who have obtained their CDL License. Two, work for Oil and Gas trucking companies located on the Fort Berthold Reservation, as well as Kansas Johnson who was our first female to obtain her CDL License, and the other one works driving water truck for another Oil & Gas company.

We have had request for students who have successfully obtained their CDL License from Fort Berthold Headstart Programs, as they are in need of bus drivers.

Attached are the dates of Safety/Permit training classes, and CDL Driver training classes that were held, as well as list of Advisory Board members.

CDL Training

To date we have had 34 students take part in the CDL training, in the permit class and the driving. 31 have taken the CDL permit class and received 1 credit, and 8 have completed the class for 8 credits. 6 students have received their CDL License, and others 2 are waiting to take driving test again. The majority of the students have been tribal members and TERO has paid for their class, Job Services has picked up the students not qualifying under TERO. The 477 Program handles the drug tests, which must be done before student can drive.
