

Work Completed during Period Covered by Report:

The Beulah Bay North Side Expansion Project entailed installing nine individual camping sites for RV's and twelve camping sites for RV's that have the capability to offer group camping. This included trenching lines to proposed area, installing underground electrical cable, transformer and 50/30 amp pedestals. The area was also enhanced with new tree plantings in accordance with the Corp of Engineers tree planting guidelines. Due to high demand for camping that we receive from surrounding areas, this project allowed the park district to help alleviate vacancy issues during holidays and busy weekends.
