The OHF Working Grassland Partnership II (WGPII) has 17 signed agreements covering 8,702 acres. The WGP II has obligated \$500,634.51 of OHF cost-share (60%) with \$333,756.34 in landowner cost-share (40%). The WGP has paid out \$130,980.26 in livestock and bird friendly development practices to date. The Trust has provided habitat lease payments to expiring CRP contracts for 3,729.87 acres in the amount of \$140,555.50. All agreement holders have been informed about public access options.
