**NOTICE OF CIVIL PENALTY
AND RIGHT TO REQUEST A
HEARING**

WHEREAS, on June 28, 1999, the Commissioner issued a Cease and Desist Order against Alliance Trust and Clifton Wilkinson, based on several violations of North Dakota securities laws; and,

WHEREAS, on June 28, 1999, the Cease and Desist Order was sent to Clifton Wilkinson, the trustee of Alliance Trust, and the Cease and Desist Order was received by Mr. Wilkinson on July 1, 1999; and,

WHEREAS, respondent did not provide a request for hearing, nor did respondent deny any facts relied upon by the Commissioner underlying the Cease and Desist Order dated June 28, 1999; and,

WHEREAS, on July 23, 1999, the Commissioner issued an additional Cease and Desist Order against Alliance Trust, Clifton Wilkinson, Integrowth Financial Group, Inc. and Steve Hiltbrand, based on several new violations of North Dakota securities laws, and violations of the Cease and Desist Order dated June 28, 1999; and,

WHEREAS, on July 23, 1999, the second Cease and Desist Order was sent to Clifton Wilkinson, the trustee of Alliance Trust, Integrowth Financial Group, and Steve Hiltbrand; and,

WHEREAS, the Cease and Desist Order was received by Mr. Wilkinson on July 26, 1999 and the Cease and Desist Order was received by Integrowth Financial Group and Steve Hiltbrand on or before July 27, 1999.

NOW, THEREFORE, it is hereby Ordered that respondents, Alliance Trust and Clifton Wilkinson are hereby assessed and shall make payment to the Commissioner, a **civil penalty in the amount of \$20,000** for the violations set forth in the Cease and Desist Order dated June 28, 1999, and a **civil penalty in the amount of \$40,000** for the violations set forth above and in the Cease and

Desist Order dated July 23, 1999. The payment of the civil penalties assessed herein are due and payable immediately upon receipt of this Order.

NOTICE OF RIGHT TO REQUEST HEARING

YOU ARE NOTIFIED that pursuant to §10-04-12 N.D.C.C. you may request a hearing before the Securities Commissioner if such a request is made in writing WITHIN TEN (10) DAYS AFTER THE RECEIPT OF THIS ORDER. The respondent has the right to be represented by legal counsel at the hearing.




