**ORDER FOR PERMANENT  
INJUNCTION AND FOR  
RELEASE OF FUNDS**

**CIVIL NO. 09-08-C-2084**

The Court, having issued its Ex Parte Order for Preliminary Injunction and Prehearing Writ of Attachment on April 22, 2008; and the Sheriff having levied on the bank accounts of the Defendants pursuant to said Writ of Attachment and having deposited with the Clerk of the District Court the sum of \$10,674.13; and the parties hereto, by and through their respective counsel, having entered into a Stipulation on file herein;

NOW, THEREFORE, IT IS HEREBY ORDERED: That Defendants, whether acting directly or through any agent, employee, partner, officer, director, subsidiary, division or other device, be and hereby are restrained and enjoined from:

1. Offering for sale or selling in North Dakota the subject investment, promissory notes, or any other investment interest however denominated, unless and until such investment has been registered with the Securities Commissioner.



2. Offering for sale or selling investments in North Dakota unless and until they have registered with the Securities Commissioner as broker-dealers or agents.
3. Engaging in any investment advisory activities unless and until they have registered with the Securities Commissioner as investment advisors or investment advisor representatives.
4. Engaging in any scheme or artifice to defraud investors, or otherwise engaging in a fraudulent or deceptive act while offering for sale or selling securities or investments in North Dakota or to North Dakota residents.

IT IS FURTHER ORDERED that the funds deposited with the Clerk of District Court in the amount of \$10,674.13, and interest accrued, if any, be released to the North Dakota Securities Department for reimbursement of \$4,350.00 in delinquent premium payments previously advanced by the Department to Protective Life Insurance Company, and for payment of any additional premiums necessary to keep Protective Life Insurance Company, policy number FK2462329 in effect during the life settlement process, and the balance, if any, to the North Dakota Investor Restitution Fund (Fund # 262), for the purpose of repaying aggrieved investors.


