NORTH DAKOTA FIELD INSPECTED SEEDS

CERTIFIED SEED

The following list includes fields, which were inspected by the STATE SEED DEPARTMENT in 2008 for the production of Foundation, Registered or Certified seed. To be eligible for final certification, seed produced from these fields must be sampled, tested, and inspected after conditioning. **FIELD INSPECTED SEED IS NOT CERTIFIED SEED** until final certification has been granted and the seed has been properly tagged with the official certification tag, or has been approved for bulk certification and a bulk certified or registered seed certificate granted by the State Seed Department.

BULK CERTIFICATES AND CERTIFICATION TAGS ARE INVALID WHEN THEY ARE IMPROPERLY USED.

CLASSES OF SEED

Foundation seed shall be so handled as to most nearly maintain specific genetic identity and purity. It shall be the source of Registered and/or Certified seed classes.

Registered seed is one generation from Foundation seed and so handled that it meets the standard for Registered seed. Seed is eligible for one generation in this class.

Certified seed shall be the progeny of Foundation, Registered, or Certified seed that is so handled that it will meet certification standards.

Certified seed transported in interstate commerce must comply with the rules and regulations under the Federal Seed Act and with the seed laws and regulations of the state into which it is transported and sold.

All certified seed issued bulk certificates or tags has been grown, conditioned, sampled and tested according to the rules and regulations as outlined in the State Seed Department Bulletin No. 51 (Revised 2004).

Prospective buyers of seed from fields listed in the bulletin should contact the growers or seedsmen for price quotations and the quantity of seed available or desired. Complaints in cases of misrepresentation, mislabeling or violation of the regulations under which certified seed is produced and marketed should be made to the State Seed Department.

For more complete and detailed description of the varieties listed, publications of the various agricultural experiment stations should be consulted.
