**Subject:** Kindred Sales and Gross Receipts Tax  
**Date:** January 31, 2012

*Effective April 1, 2012, the city of Kindred has adopted an ordinance to impose a one and one half percent (1-1/2%) city sales, use, and gross receipts tax.* The Kindred city tax is in addition to the state sales, use and gross receipts tax currently in place. In addition to this new tax, the following applies:

- Will be reported under local tax code 230
- Includes \$50 Maximum Tax (Refund Cap)
- No additional exemptions other than allowed by state tax law
- Does not provide a limited liability for contractors (see the Local Option Taxes Guideline for information on this limited exemption: <http://www.nd.gov/tax/salesanduse/pubs/guide/gl-21847.pdf>)
- Does not exempt contracts awarded prior to effective date
- Does not provide for permit holder compensation
- No sunset date is provided
- Proceeds are intended for city infrastructure improvements and infrastructure improvements for the park district

The Office of State Tax Commissioner has contracted with the city of Kindred to administer the city sales and gross receipts tax. Tax is computed by multiplying the taxable purchase by the tax rate and carrying the product to the 3<sup>rd</sup> decimal place. If the 3<sup>rd</sup> decimal place is 5 or greater, round up; if it is 4 or less, round down. Effective April 1, 2012, the combined state and city rates within the city limits of Kindred will be as follows:

- General sales and use tax: 7 percent (5% state + 1-1/2% city + 1/2% county)
- New farm machinery: 5 percent (3% state + 1-1/2% city + 1/2% county)
- New farm irrigation equipment: 5 percent (3% state + 1-1/2% city + 1/2% county)
- Coin-operated amusement: 7 percent (5% state + 1-1/2% city + 1/2% county)
- New mobile homes: 5 percent (3% state + 1-1/2% city + 1/2% county)
- Lodging:
  - Hotel, Motel and Tourist Court Accommodations, and Bed & Breakfast Accommodations licensed under North Dakota Century Code ch. 23-09.1:  
7 percent (5% state + 1-1/2% city sales + 1/2% county)
- Restaurant (sale of food and non-alcoholic beverages): 7 percent (5% state + 1-1/2% city sales + 1/2% county)
- Alcoholic Beverages:
  - Off-sale alcoholic beverages: 9 percent (7% state + 1-1/2% city gross receipts + 1/2% county)
  - On-sale alcoholic beverages: 9 percent (7% state + 1-1/2% city gross receipts + 1/2% county)
