**RESOLUTION**

A RESOLUTION ANNEXING CERTAIN TERRITORY AND INCORPORATING THE SAME WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF CROSBY, PURSUANT TO THE PROVISIONS OF CHAPTER 40-51.2 N.D.C.C.

Be it ordained by the City Council of the City of Crosby, County of Divide, State of North Dakota as follows:

**PREAMBLE**

1. A petition in writing has been presented to the City Council of the City of Crosby, signed by the owner of real property of the territory herein described requesting annexation of its property to the City of Crosby;
2. Notice of the filing of the petition for annexation will be given by one publication once a week for two (2) consecutive weeks in The Journal prior to final approval of the ordinance.
3. It appears that annexation of the territory herein described will promote the public health and safety, enhance the tax base of the municipality, and allow for the orderly development of the city; and
4. The annexation of such territory is deemed necessary for the welfare of the property owner thereof and of this city as a whole.

NOW THEREFORE, be it ordained by the City Council of the City of Crosby, County of Divide, State of North Dakota, as follows:

**SECTION ONE  
ANNEXATION OF TERRITORY**

There is hereby annexed to the City of Crosby, County of Divide, State of North Dakota, and incorporated within the corporate boundaries thereof, the following territory contiguous or adjacent to the present boundaries of the city:

Township 163 North of Range 97 West of the 5<sup>th</sup> P.M.

Section 29: All that part of the S ½ NW ¼ lying South of the Minneapolis, St. Paul and

The corporate limits of the City of Crosby are hereby modified and increased so as to include and embrace within the corporate limits of the City of Crosby, the territory described in Section One hereof, and such territory is hereby declared to be a part of the City of Crosby.


## SECTION THREE ACCURACY OF MAP OF ANNEXED TERRITORY
