

ORDINANCE NO. 4320

AN ORDINANCE TO ANNEX LOT 6, BLOCK 1, DANK'S SECOND RESUBDIVISION TO THE CITY OF GRAND FORKS, NORTH DAKOTA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND FORKS, NORTH DAKOTA, THAT:




