

ORDINANCE NO. 4353

AN ORDINANCE TO ANNEX ALL THOSE PARTS OF LAND PLATTED AS HIGHLAND POINT THIRD ADDITION AND HIGHLAND POINT FIFTH RESUBDIVISION TO THE CITY OF GRAND FORKS, NORTH DAKOTA, NOT PREVIOUSLY ANNEXED AND THE WESTERLY 140 FEET OF THE EASTERLY 550 FEET OF THE SOUTH HALF OF THE NORTHEAST QUARTER OF SECTION 21, TOWNSHIP 151 NORTH, RANGE 50 WEST OF THE FIFTH PRINCIPAL MERIDIAN, GRAND FORKS COUNTY, NORTH DAKOTA. AREA CONTAINS 1,791,967.6 SQUARE FEET OR 41.14 ACRES, MORE OR LESS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND FORKS, NORTH DAKOTA, THAT:

Section 1.

The following territory is hereby annexed to the City of Grand Forks, North Dakota, together with the full width of all platted streets and public rights-of-way contiguous thereto:

ALL THOSE PARTS OF LAND PLATTED AS HIGHLAND POINT THIRD ADDITION AND HIGHLAND POINT FIFTH RESUBDIVISION TO THE CITY OF GRAND FORKS, NORTH DAKOTA, NOT PREVIOUSLY ANNEXED AND THE WESTERLY 140 FEET OF THE EASTERLY 550 FEET OF THE SOUTH HALF OF THE NORTHEAST QUARTER OF SECTION 21, TOWNSHIP 151 NORTH, RANGE 50 WEST OF THE FIFTH PRINCIPAL MERIDIAN, GRAND FORKS COUNTY, NORTH DAKOTA.

SAID TRACT CONTAINS 1,791,967.6 SQUARE FEET OR 41.14 ACRES, MORE OR LESS, AND IS AS SHOWN ON THE ATTACHED MAP, WHICH IS BY REFERENCE MADE A PART HEREOF.

Section 2.

This ordinance shall be in full force and effect after its passage and approval as provided by law.
