

ORDINANCE NO. 4366

AN ORDINANCE TO ANNEX ALL THE PROPERTY PLATTED AS JF RESUBDIVISION NOT PREVIOUSLY ANNEXED INTO THE CITY OF GRAND FORKS ACCORDING TO THE PLAT THEREOF ON FILE AND OF RECORD IN THE OFFICE OF THE COUNTY RECORDER, GRAND FORKS COUNTY, NORTH DAKOTA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND FORKS, NORTH DAKOTA, THAT:

Section 1.

The following territory is hereby annexed to the City of Grand Forks, North Dakota, together with the full width of all platted streets and public rights-of-way contiguous thereto:

ANNEX ALL PARTS OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 8, TOWNSHIP 151 NORTH, RANGE 50 WEST OF THE PRINCIPAL MERIDIAN NOT PREVIOUSLY ANNEXED TO THE CITY OF GRAND FORKS, NORTH DAKOTA.


