ORDINANCE NO. 1384

AN ORDINANCE FOR THE ANNEXATION OF ALL OF TITAN ADDITION EXCEPTING THEREFROM ALL THAT PORTION PREVIOUSLY ANNEXED AS DESCRIBED IN THE CITY RESOLUTION RECORDED AS DOCUMENT #X32323, ALL WITHIN THE NE 1/4 OF SECTION 4, TOWNSHIP 139 NORTH, RANGE 64 WEST, STUTSMAN COUNTY, NORTH DAKOTA

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JAMESTOWN, NORTH DAKOTA, that the following ordinance is hereby amended and re-enacted to read as follows:

SECTION I. Findings by City Council.

The City Council hereby finds that the following facts and conditions exist with regard to the land described in section II of this ordinance:

1. That a petition, signed by owners of all the property to be annexed, was filed with the City of Jamestown and that said described property is adjacent to the boundaries of the City of Jamestown.
2. That said petition specifically requests that the property described in Section II be annexed to the City of Jamestown, that due and proper notice of a filing of such petition and notice of public hearing thereof was given pursuant to the requirements of Section 40-51.2-05 of the North Dakota Century Code, and that said public hearing was held and there were no legal protests to such annexation.

SECTION II. Annexation Ordered.

That the following land is hereby annexed to the City of Jamestown, North Dakota:

All of Titan Addition excepting therefrom all that portion previously annexed as described in the City Resolution recorded as Document #X32323, all within the NE 1/4 of Section 4, Township 139 North, Range 64 West, Stutsman County, North Dakota

The City Administrator of the City of Jamestown is hereby ordered and directed to file and record a copy of this ordinance, certified by the Mayor of the City of Jamestown, together with a copy of an accurate map of the annexed area attached thereto with the Stutsman County Recorder.




