

ORDINANCE NO. 877

AN ORDINANCE ANNEXING CERTAIN ADJOINING LANDS TO THE CITY OF MANDAN, NORTH DAKOTA, AND EXTENDING THE CORPORATE BOUNDARIES THEREOF.

BE IT ORDAINED BY THE BOARD OF CITY COMMISSIONERS OF THE CITY OF MANDAN, NORTH DAKOTA, AS FOLLOWS:

WHEREAS, The owner of the hereinafter described properties which are contiguous to the City of Mandan, North Dakota, but not embraced within the limits thereof, has filed a written petition praying that such territory be annexed to the City of Mandan, and the governing body of said City pursuant to due notice thereof duly held a public hearing with respect to such petition.

Section 1. Property Annexed. The following described lands situated in the County of Morton and contiguous to the corporate limits of the City of Mandan, North Dakota, are hereby added to, taken into, annexed and made a part of the City of Mandan, to-wit:

All of Evergreen Heights Second Addition to the City of Mandan.

Section 2. Corporate Boundary Extended. That on the taking effect of this ordinance, the corporate limits and boundary lines of the City of Mandan shall thereafter include said lands.


