

ORDINANCE NO. 946

AN ORDINANCE ANNEXING CERTAIN ADJOINING LANDS TO THE CITY OF MANDAN, NORTH DAKOTA, AND EXTENDING THE CORPORATE BOUNDARIES THEREOF .


BE IT ORDAINED By the Board of City Commissioners of the City of Mandan, North Dakota, as follows:

WHEREAS, Mark and Judith Grewatz, the owners of the hereinafter described property which is contiguous to the City of Mandan, North Dakota, but not embraced within the limits thereof, has filed a written petition praying that such territory be annexed to the City of Mandan, and the governing body of said City pursuant to due notice thereof duly held a public hearing on September 3, 2002, with respect to said petition.

**SECTION 1. Property Annexed.** The following described lands situated in the County of Morton, State of North Dakota, and contiguous to the corporate limits of the City of Mandan, North Dakota, is hereby added to, taken into, annexed and made part of the City of Mandan, namely:

Beginning at the northeast corner of Lot 5, Block 3, Bahm's First Addition, Morton County, North Dakota; thence north 89°30'00" west along the north boundary of said Lot 5 a distance of 285.68 feet to the northwest corner of said Lot 5; thence north 89°30'00" west along the westerly extended north boundary of said Lot 5 a distance of 40.00 feet to its intersection with the centerline of 14<sup>th</sup> Ave. SE; thence south 00°30'00" east along said centerline a distance of 300.00 feet to its intersection with the westerly extended south boundary of said Lot 5; thence south 89°30'00" east along said westerly extended south boundary a distance of 40.00 feet to the southwest corner of said Lot 5; thence south 89°30'00" east along said south boundary a distance of 285.68 feet to the southeast corner of said Lot 5; thence north 00°30'00" west along the east boundary of said Lot 5 a distance of 300.00 feet to the point of beginning. 30 - 307000

**SECTION 2. Corporate Boundary Extended.** Upon the taking effect of this Ordinance, the corporate limits and boundary lines of the City of Mandan shall thereafter include said lands.


