

ORDINANCE NO. 950

AN ORDINANCE ANNEXING CERTAIN ADJOINING LANDS TO THE CITY OF MANDAN, NORTH DAKOTA, AND EXTENDING THE CORPORATE BOUNDARIES THEREOF.

BE IT ORDAINED By the Board of City Commissioners of the City of Mandan, North Dakota, as follows:

WHEREAS, Steve Thilmony, the owner of the hereinafter described property which is contiguous to the City of Mandan, North Dakota, but not embraced within the limits thereof, has filed a written petition praying that such territory be annexed to the City of Mandan, and the governing body of said City pursuant to due notice thereof duly held a public hearing on October 29, 2002, with respect to said petition..


SECTION 1. Property Annexed. The following described lands situated in the County of Morton, State of North Dakota, and contiguous to the corporate limits of the City of Mandan, North Dakota, is hereby added to, taken into, annexed and made part of the City of Mandan, namely:

Lot 9 and Lots 12-18, Block 3, Lincoln Ridge Estates and their adjoining right-of-way, more fully described as follows:

Beginning at the northwest corner of Lot 18, Block 3, Lincoln Ridge Estates; thence southerly along the west boundary of Lots 18-14 of said Block at a bearing of S01°03'13"E a distance of 487.69 feet to the northwest corner of Lot 13 of said Block; thence southeasterly along the west boundary of said Lot 13 at a bearing of S08°56'51"E a distance of 147.72 feet to the southwest corner of said Lot 13; thence southeasterly along the southwest boundary of Lot 12 of said Block at a bearing of S60°30'04"E a distance of 187.22 feet to the southwest corner of Lot 9 of said Block; thence northeasterly along the south boundary of said Lot 9 at a bearing of N69°30'00"E a distance of 180.84 feet to the southeast corner of said Lot 9; thence northwesterly along the east boundary of said Lot 9 at a bearing of N36°42'19"W a distance of 112.15 feet to the northeast corner of said Lot 9, said point being a point on the east boundary of East View Place SE; thence

northerly along said east boundary on a curve to the left having a radius of 60.00 feet an arc distance of 115.86 feet; thence northerly continuing along said east boundary on a curve to the right having a radius of 1115.37 feet an arc distance of 238.27 feet; thence northerly continuing along said east boundary at a bearing of N01°03'13"W a distance of 157.50 feet; thence northerly along the northerly extended west boundary of Lot 1 of said Block 3 at a bearing of N01°03'13"W to its intersection with the north boundary of said Lincoln Ridge Estates; thence westerly along said north boundary at a bearing of S88°57'41"W to the point of beginning.

SECTION 2. Corporate Boundary Extended. Upon the taking effect of this Ordinance, the corporate limits and boundary lines of the City of Mandan shall thereafter include said lands.


