ORDINANCE NO. 4555

AN ORDINANCE ANNEXING A CERTAIN PARCEL OF LAND
LYING IN SECTION 3, TOWNSHIP 138 NORTH,
RANGE 49 WEST, IN CASS COUNTY, NORTH DAKOTA

WHEREAS, A Petition for Annexation has been submitted by the owners of not less than three-fourths of the property described in said Petition for Annexation to the City of Fargo, Cass County, North Dakota, in accordance with Section 40-51.2-03 N.D.C.C.; and,

WHEREAS, Public notice of the submission of such Petition has been given by publication in The Forum as required by Section 40-51.2-05 N.D.C.C.; and,

WHEREAS, Said Section 40-51.2-03 N.D.C.C. requires that such annexation be accomplished by ordinance,

NOW, THEREFORE,

Be It Ordained by the Board of City Commissioners of the City of Fargo:

Section 1. The following described property located in Section 3, Township 138 North, Range 49 West, Cass County North Dakota, is hereby annexed to the City of Fargo, Cass County, North Dakota:

Tract One:

West Half (W1/2) of the Northwest Quarter (NW1/4) of Section 3, Township One Hundred Thirty-Eight (138) North, Range Forty-Nine (49) West, and,

Tract Two:

A strip of land ten (10) rods wide north and south extending across the south side of the East Half (E1/2) of the Northwest Quarter (NW1/4) of Section 3, Township One Hundred Thirty-Eight (138) North, Range Forty-Nine (49) West.

Section 2. Effective Date.

This ordinance shall be in full force and effect from and after its passage and approval.
