





AS AMENDED JUNE 20, 2011**

**RESOLUTION EXTENDING THE CORPORATE LIMITS OF THE
CITY OF VALLEY CITY AND ANNEXING TO THE CITY OF VALLEY CITY
CERTAIN TRACTS AND PARCELS OF LAND**

BE IT RESOLVED BY THE BOARD OF CITY COMMISSIONERS OF THE CITY OF VALLEY CITY, BARNES COUNTY, NORTH DAKOTA:


