

ORDINANCE NO. 947

**ORDINANCE RELATING TO THE ANNEXATION OF
A TRACT OF LAND LOCATED AT I-94 AND EXIT 294, LEGAL
DESCRIPTION OF AUDITOR'S LOTS 1 OF SECTION 26, 1 OF SECTION
27, AND 5 OF SECTION 23, EAST OF THE REPLAT OF THE
GREENLINE ADDITION TO THE CITY OF VALLEY CITY FOR
VALLEY CITY - BARNES COUNTY DEVELOPMENT CORPORATION**

WHEREAS, A duly signed petition has been presented to the Board of City Commissioners of the City of Valley City, Barnes County, North Dakota, pursuant to Section 40-51.2-03 of the North Dakota Century Code, as amended; and

WHEREAS, Notice of the filing of said petition has been duly given by publication, as provided for by Section 40-51.2-05 of the North Dakota Century Code, as amended, by publishing notice thereof in the Valley City Times-Record as required by law.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF CITY COMMISSIONERS OF THE CITY OF VALLEY CITY, BARNES COUNTY, NORTH DAKOTA:

Section 1. That the boundaries of the City of Valley City, Barnes County, North Dakota, be and they are hereby extended so as to include and to incorporate within the corporate limits of the City of Valley City, Barnes County, North Dakota, the following tract of land:

Auditor's Lot Number 1 of the N1/2 of the NW 1/4 of Section 26, Township 140 North, Range 58 West, Barnes County, North Dakota, and

Auditor's Lot Number 1 of the NE 1/4 of the NE 1/4 of Section 27, Township 140 North, Range 58 West, Barnes County, North Dakota, and

Auditor's Lot Number 5 of the SE 1/4 of the SW 1/4 of Section 23, Township 140 North, Range 58 West, Barnes County, North Dakota.


Section 2. That the President of the Board of City Commissioners of the City of Valley City, North Dakota, shall file and record a certified copy of this ordinance together with an accurate map of the annexed area with the Register of Deeds in and for Barnes County, North Dakota.

Section 3. This ordinance shall take effect and be in full force from and after its second reading, final adoption and approval by the President of the Board of City Commissioners and after a certified copy of the same together with a map of said area annexed is recorded in the office of the Register of Deeds in and for Barnes County, North Dakota.
