RESOLUTION 11-56

WHEREAS, the City of Williston duly passed a Resolution of Annexation at the regular meeting of the City Commission held on April 12, 2011, a copy of which is marked exhibit "A", annexed hereto and by reference made a part hereof as much as if the same were recited herein in its entirety; and

WHEREAS, said Resolution was published in the official newspaper of the City of Williston, North Dakota on April 15 and 22, 2011; and

WHEREAS, notice of Resolution was mailed to the owner of each parcel of real property within the area to be annexed at the person's last know mailing address; and

WHEREAS, thirty days has now elapsed from the date of the first publication of such Resolution as evidenced by the hereto for referred to Affidavit of Publication; and

WHEREAS, said Resolution came on for hearing in the City Hall on May 24, 2011 at 7:30 p.m.; and

WHEREAS, protests were not filed by more than one fourth (1/4) of the territory proposed to be annexed;

RESOLUTION OF ANNEXATION

BE IT RESOLVED BY THE BOARD OF CITY COMMISSIONERS OF THE CITY OF WILLISTON;

WHEREAS, the City of Williston, Williams County, North Dakota, is a municipal corporation, organized and existing under the laws of the State of North Dakota; and

WHEREAS, there is contiguous and adjacent to the City of Williston a tract or parcel of land hereinafter specifically described, containing approximately 51 acres, more or less, which tract or parcel of land is not presently a part of the City of Williston.

NOW, THEREFORE, BE IT RESOLVED, by the Board of City Commissioners of the City of Williston, North Dakota, that the boundaries of the City of Williston be, and they hereby are, extended so as to include and incorporate within the corporate limits of the City of Williston, Williams County, North Dakota, the following described land, to-wit:

BE IT FURTHER RESOLVED, by the Board of City Commissioners of the City of Williston, North Dakota, that this Resolution be published in the official newspaper for the City of Williston once each week for two successive weeks, that notice of the Resolution be mailed to the owner of each parcel of real property within the area to be annexed at the person's last-known mailing address, and a hearing be held on May 24, 2011, at 7:30 p.m. in the City Commission Room, City Hall, Williston, North Dakota. The owners of any real property within the territory proposed to be annexed, within 30 days of the first publication of such resolution, may file written protests with the City Auditor protesting against the proposed annexation.

Commissioner Cymbaluk moved the adoption of the foregoing resolution. The motion was seconded by Commissioner Klug. On roll call vote of the Commissioners, the following Commissioners voted "AYE": Bogar, Klug, Cymbaluk, Koeser and the following Commissioners voted "NAY": None. Absent and not voting: Bekkedahl.





Annexation Description

A tract of land lying in the east 1/4 of Section 20 and the west 1/4 of Section 21, Township 154 North, Range 101 West of the 5th Principal Meridian, Williams County, North Dakota more particularly described as follows:

Commencing at the southwest corner of said Section 21; Thence northerly along the west line of said Section 21 a distance of 374.74 feet to the north right of way line of US Highway 2 & 85 and the Corporate Limits of the City of Williston and the Point of Beginning; Thence easterly along the north right of way line of US Highway 2 & 85 and the Corporate Limits of the City of Williston a distance of 33.00 feet; Thence northerly along a line 33.00 feet east of and parallel to the west line of said Section 21 to the northern east west 1/4 1/4 line of said Section 21; Thence easterly along the northern 1/4 1/4 line of said Section 21 to the western 1/4 1/4 line of said Section 21; Thence northerly along the western 1/4 1/4 line of said Section 21 to the north line of said Section 21; Thence westerly along the north line of said Section 21 to the northwest corner of said Section 21; Thence continuing westerly along the north line of said Section 20 a distance of 33.00 feet to a point; Thence southerly along a line 33.00 feet west of and parallel to the east line of said Section 20 to the north 1/4 1/4 line of said section 20; Thence westerly along the north 1/4 1/4 line of said Section 20 a distance of 47.00 feet to a point; Thence southerly along a line 80.00 feet west of and parallel to the east line of said Section 20 to the north right of way line of US Highway 2 & 85 and the Corporate Limits of the City of Williston, Thence easterly along the north right of way line of US Highway 2 & 85 and the Corporate Limits to the City of Williston a distance of 33.00 feet, plus or minus, to the Point of Beginning.
