- ▶ Community Based Outpatient Clinics: in Dickinson, the providers are credentialed and training is scheduled and in Jamestown, a contract is finalized for space.
- ▶ In the process of hiring for a Native American mobile van for mental health care on reservations.
- ▶ Operation Iraqi and Enduring Freedom coordinator – Deb Kunkel, (701) 239-3787
- ▶ Over 1,300 veterans enrolled in November 2006
- ▶ Budget is on a continuing resolution, the proposed budget is at \$104 - \$107 million.

▶ Mobilization Fact Sheet

Informational update on mobilization and deployment of the Guard throughout the world.

▶ 2007 –2009 Initiatives

**Tuition Assistance** - \$2 million dollars needed for goal of 100% tuition assistance. Schools waive 25% of tuition and the Guard pays the remaining 75% with state or federal dollars. Good tool for recruiting and retention.

**Veterans Bonus Program** - discussion on why active duty does not receive bonus.

**State Funding for Social Workers** – federal funding can no longer be used so general funding sought to keep this service going.

**Child Custody** – Because of deployment, soldiers are finding the custody arrangement is being changed. The Guard feels the soldiers should not be penalized because they are deployed.

**Recruiting & Retention** – shortage of junior officers

**Funeral Protest Restrictions** – Passed in the House and headed to the Senate.

▶ The economic impact of the military in North Dakota is estimated at \$1 billion dollars a year.

▶ National Emergency Grant - \$1 million dollars to North Dakota to assist in the impact of the cutbacks on Grand Forks Air Force Base.

▶ Crisis in workforce – lowest unemployment rate in nation (under 3%) and high labor participation rate (72.5%) along with aging population is resulting in a shortage of workers.

▶ Governor's goal is to increase annual average wage in North Dakota.

▶ Two new veterans representatives hired, one in Minot and one in Fargo

Presentation on status of Veterans Home – Brad Maasjo & Mark Johnson.

Life Safety issues at the Home have necessitated requesting funds for major renovations at the Home or, preferably, a new Veterans Home. Presentation outlined plans for building on the grounds.

**Workforce Development Council Update – Lyle Schuchard.**

We have a position on the Planning Committee. The Talent Initiative Program recognizes veterans as a targeted group. The Program is to increase skills so veterans can get into better employment positions. Various sources will be contacted to get information needed for the program. P-16 Education Workforce recommends: all-day kindergarten, school attendance to a minimum 183 days from 173 days, and raising high school graduation requirements to 25 credits from the current minimum of 21. The tougher requirements would include four years of language arts and four years of math.
