Minutes of the spring meeting of the ND association of county veteran service officers held in conjunction with the spring training session Bismarck ND March 23-25, 2015

The spring meeting of the ND assoc. of county veteran service officers was called to order at 4:12 pm by president Dean Johnson.

President Johnson called for treasurers report, sec/trea. Kubischta reported that we have a current balance of \$3721.00 , but noted the spring meeting expense were not in yet. President Johnson called for a motion to accept treasurers report, motion made by James Paulus second by Dave Daley, motion carried approved as given.

Legislative committee report was given by Jerry Samuelson. Senate bill SB2346 was discussed . Warren Tobin was there and reported he and Trish Hodney had that bill introduced which would eliminate the language that requires vso must be accredited by navsco. Commissioner Wangen was asked to discuss this bill, he said he was leaving it up to the association to take what action they wished , he was not going to go and testify for or against it at the legislature , this was the question that tore this group apart 6 years ago and would not be involved in seeing that happen again, but would answer any questions any cvso had about it. There was a lot of discussion, lots of good questions pro and con on this bill. All members were given ample opportunity for input. Ron Crowley made a motion that the nd assoc. Of county veteran service officers draft a resolution that we are in favor of SB 2346 as was written and passed by the senate 92-0 and that this resolution be delivered to the chairman of the ND house veterans affairs committee chairman. Lynn Price seconded this motion, vote was taken by show of hands 20 votes in favor 18 against motion passed.

Fall meeting will be in Fargo at the Cambria Inn Oct 5,6,7 2015. The dates for the spring meeting to be held in 2016 at comfort Inn in Bismarck were discussed. March 21,22,23 2016 were picked.

President Johnson asked if anyone else had any other business to bring up, being none , he asked for a motion to adjourn meeting Henry Gerving made a motion to

adjourn meeting second was made by James Paulus, motion carried meeting adjourned at 5:00 pm
