## **FIELD SERVICES**

# **Regional Human Service Centers**

- Are located in Bismarck, Devils Lake, Dickinson, Fargo, Grand Forks, Jamestown, Minot, and Williston and have satellite clinics located in Grafton, Rolla, Valley City, Watford City, and at Off Main in Fargo, and also provide services part-time at outreach offices and via telehealth
- Provide community-based services either directly or through contracts using intensive in-home services, community outreach and tele-behavioral health services

# Outpatient Clinical and Community Services Include:

- **Emergency Services** including 24-hour crisis lines, mobile crisis support, crisis psychotherapy and residential services, social and medical detoxification services, and State Hospital admissions screening
- Chronic Disease Management for individuals with severe behavioral health disorders. Services include targeted case management, addiction counseling, psychotherapy, psychosocial rehabilitation, medication management, and residential, transitional, and supported housing services
- **Specialized Services** including Intellectual Disability program management, vocational rehabilitation, adult protective services, regional supervision of child welfare services and court-ordered psychological assessment

# State Hospital (Jamestown)

- Inpatient services for adults with mental illness and substance use disorders whose needs exceed local resources
- Psychiatric rehabilitation services for adults with persistent and serious mental illness
- Transitional living services for adults with persistent and serious mental illness
- Evaluation and treatment services for civilly committed sexually dangerous individuals
- Residential addiction treatment services provided by the Tompkins Rehabilitation Center through contract with the Department of Corrections and Rehabilitation for inmates preparing for community release

# **Life Skills and Transition Center** (Grafton)

- Is a comprehensive support agency serving people with developmental disabilities on campus, in supported living arrangements, and in communities across the state
- Residential Services (for people whose needs exceed community resources)
  - Includes clinical and medical services, Secure Services program, and Youth Transition Services program
- Vocational Services (includes work and day activities)
- Outreach services
  - o Independent Supported Living Arrangement program
  - CARES Clinic (PT, OT, adaptive equipment, medical services, etc. for people with disabilities living in the community)
  - Intellectual Disabilities Behavioral Health Services (behavioral consultation and support to sustain people in communities)
