2017 HB 1038 (Section 3)

 SECTION 3. DEPARTMENT OF HUMAN SERVICES - LONG-**TERM CARE SERVICES - REPORT TO LEGISLATIVE** MANAGEMENT. The department of human services shall review services and related funding provided within its long-term care division for the 2015-17 and 2017-19 bienniums. The department of human services shall report to the legislative management during the 2017-18 interim on the levels of funding provided for and spent on nursing home services and home- and community-based services by program during these time periods and shall provide recommendations on options to increase the number and level of services and funding provided for home- and community-based services for the 2019-21 biennium.

Money Follows the Person Grant

- DHS received grant in 2007 from the Centers for Medicare and Medicaid Services (CMS).
- Purpose: to move eligible individuals from institutions to community settings.
- Funds are used for:
 - One-time moving costs
 - Transition coordination services
 - 24-hour nursing back-up services
 - Community-based services

SPED & Ex-SPED

State funded programs under which Qualified Service Providers (QSPs) are reimbursed by the Department for the provision of certain services provided to eligible elderly and disabled persons




These services are designed to assist individuals to remain in their own homes and communities

Financial Eligibility

- Income and Asset Based Sliding Fee Scale
- Resources of \$50,000 or less
 - Resources are cash or similar assets that can be readily converted to cash and include residences owned by the applicant other than the applicant's primary residence



SPED

Functional Eligibility

- Impaired in 4 ADLs or at least 5 IADLs totaling 8 or more points or if living alone totaling at least 6 points or
- If under age 18, meet nursing facility level of care screening criteria and
- Impairments must have lasted or are expected to last 3 months
- Impairment is not the result of an intellectual disability or a closely related condition or mental illness

Functional Eligibility

- Not severely impaired in ADL's: Toileting, Transferring, Eating and
- Severely Impaired in 3 of the 4 IADI's
 - Meal Preparation
 - Housework
 - Laundry
 - Medication Assistance or
- Have health, welfare, or safety needs requiring supervision or structured environment
- The applicant/client's impairment is not the result of an intellectual disability or a closely related condition but may be related to mental illness



HCBS Case Management

- Person centered process that assesses an individual's needs, explores service options, determines if a client qualifies for HCBS, and provides a link between community resources and qualified service providers (QSPs)
- Requires a minimum of four contacts with client per year
 - Two must be face-to-face visits in the home

HCBS Case Management

- Statute requires County Social Services to administer SPED & Ex-SPED
 - There are approximately 73 County
 HCBS Case Managers statewide
 - County Social Services bill directly for case management for eligible recipients and are currently reimbursed:
 - \$230.61 for an assessment
 - \$118.21 for a collateral contact
