



The mission of Free Through Recovery (FTR) is to improve healthcare outcomes and reduce recidivism by delivering high-quality community behavioral health services linked with community supervision. FTR began accepting referrals on January 10 and services began on February 1, 2018.




2. The majority of people referred to the program come from the Fargo area (41%), followed by Bismarck (27%).

Referrals by Region




3. FTR is addressing a variety of behavioral health needs, including substance use disorder, mental illness, and co-occurring substance use/mental health disorders. Of the 448 participants in FTR, 170 of them have co-occurring disorders.

FTR Admissions by Behavioral Health Need






4. FTR is designed to serve people in the criminal justice system at moderate-to-high risk of committing new crimes. The majority of referrals to FTR are for people who fit into these categories.




5. An LSI-R score of 34 or higher, indicating moderate-to-high risk of recidivism, qualifies an individual for the FTR program, though the FTR clinical administrator is overriding this requirement for people with high behavioral health needs.






6. The majority of Individuals who have been referred to Free Through Recovery are white (397), followed by those who are Native American (145).




7. White males make up the largest percentage of Free Through Recovery referrals, followed by White females. Native American females represent slightly more referrals (74) than Native American males (71).






8. 305 individuals who have been referred to Free Through Recovery are in the 31-50 age range, followed by 236 individuals who are in the 18-30 age range.




9. There have been a total of 95 discharges from Free Through Recovery. The majority of individuals declined or stopped participating in FTR (38), followed by those who were re-incarcerated (29).





10. Various community agencies and organizations comprise the Free Through Recovery providers. As of February, 2018 there were 11 total providers. This number has grown and there are currently 23 Free Through Recovery providers located across the state.



Outcome Monitoring


FTR providers began tracking outcome metrics for participants in March 2018. In order for providers to receive performance pay, participants must meet 3 of the 4 outcome metrics. The outcome metrics providers are reporting on are as follows;

- Is the participant living in a residence that is supportive of their recovery?
- Is the participant actively seeking or participating in employment?
- Is the participant demonstrating effort to reduce their substance use or the harm associated with their use and/or improve their mental health functioning?
- Did the participant avoid law enforcement involvement resulting in arrest, criminal charge, or probation violation resulting in initiation of revocation?




11. Overall, from March through July 2018, providers earned incentive pay for 71% of their participnts meeting 3 of the 4 outcome measures.

- 12. Overall (from March-July 2018), positive outcomes were achieved by:
 - 69% of the participants in the Recovery domain,
 - 74% of the participants in the Housing domain,
 - 74% of the participants in the Employment domain, and
 - 76% of the participants in the Law Enforcement domain.
