FUNCTIONAL ELIGIBILITY CRITERIA FOR MEDICAID

- Be impaired in at least one of the following ADLs (its often bathing)
 - Bathing
 - Dressing
 - Eating (can't be severely impaired)
 - Toileting (can't be severely impaired)
 - Continence
 - Transferring (can't be severely impaired)
 - Inside mobility

OR

- Be impaired in at least three of the following IADLs
 - Meal Preparation
 - Housework
 - Laundry
 - Taking medication

FUNCTIONAL ELIGIBILITY CRITERIA FOR MEDICAID

- Same functional eligibility criteria as someone who chooses to live in their own home and needs assistance
 - If they choose to stay in their home, will wrap services around them to meet their needs

- Don't meet Nursing Facility level of care
- Facility is not required to provide 24-hour medical or nursing services



Department of Health is responsible for licensing and surveys



49 enrolled with North Dakota Medicaid
Facility may not enroll all licensed beds with Medicaid



16 are physically co-located with or ran by a nursing facility



11 are physically co-located with or ran by an assisted living facility

Basic Care Facilities

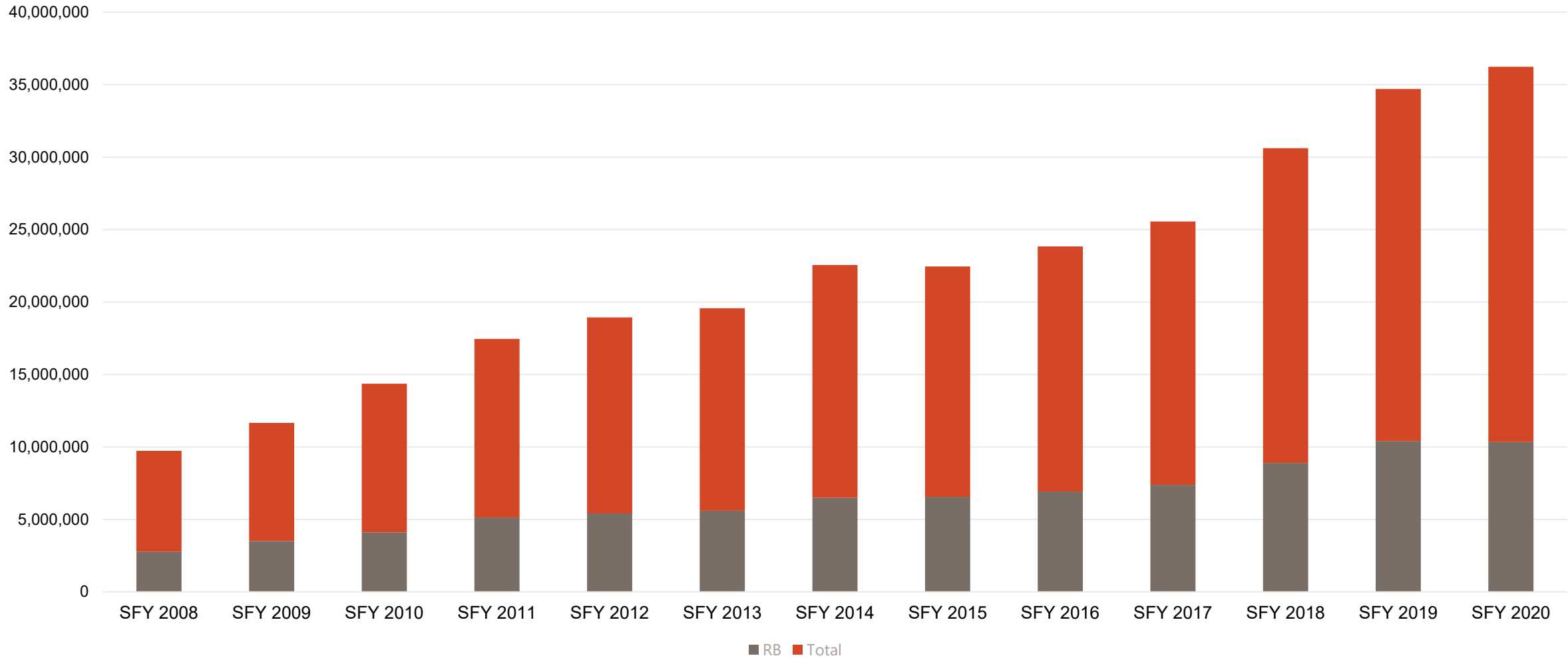
BASIC CARE RATES

- Rates are effective July 1
- Cost reports are submitted annually
- Limits for Direct Care and Indirect Care
- No Rate Equalization
- One daily rate for all residents in the facility regardless of care needs
- Rates range from \$78.63 - \$186.68 per day
 - Personal Care rate range \$36.37 - \$99.88 per day
 - Room and Board rate range \$36.45 - \$112.91 per day

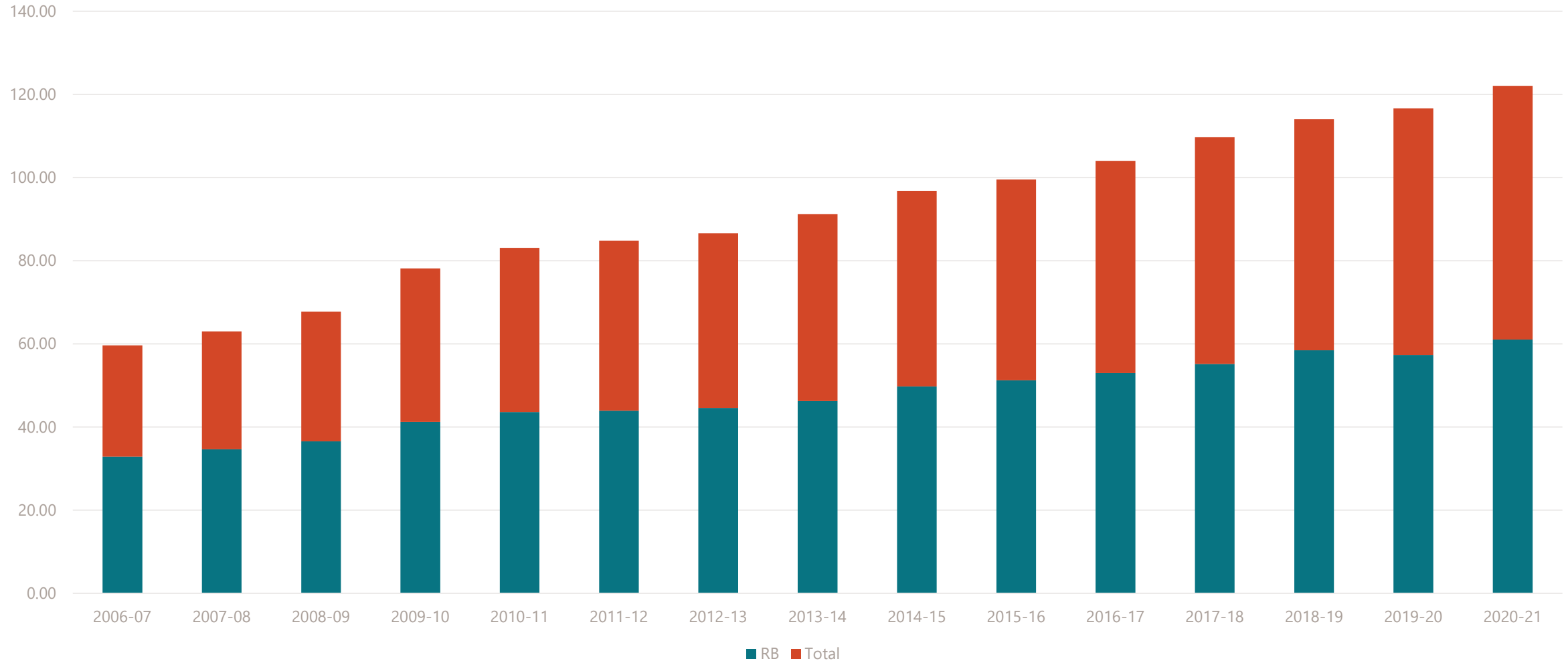
BASIC CARE PAYMENT – TWO COMPONENTS

- Personal Care Rate
 - Medicaid funded
 - For ADL and IADL assist
 - Salaries and fringe benefits only
 - Must be provide for at least 15 minutes per day
 - No bed hold payment
- Room and Board Rate
 - **State Funded**
 - Supplies and Property costs
 - Allocated costs for non-hands on care
 - Bed hold payment applicable

NUMBER OF PEOPLE SERVED

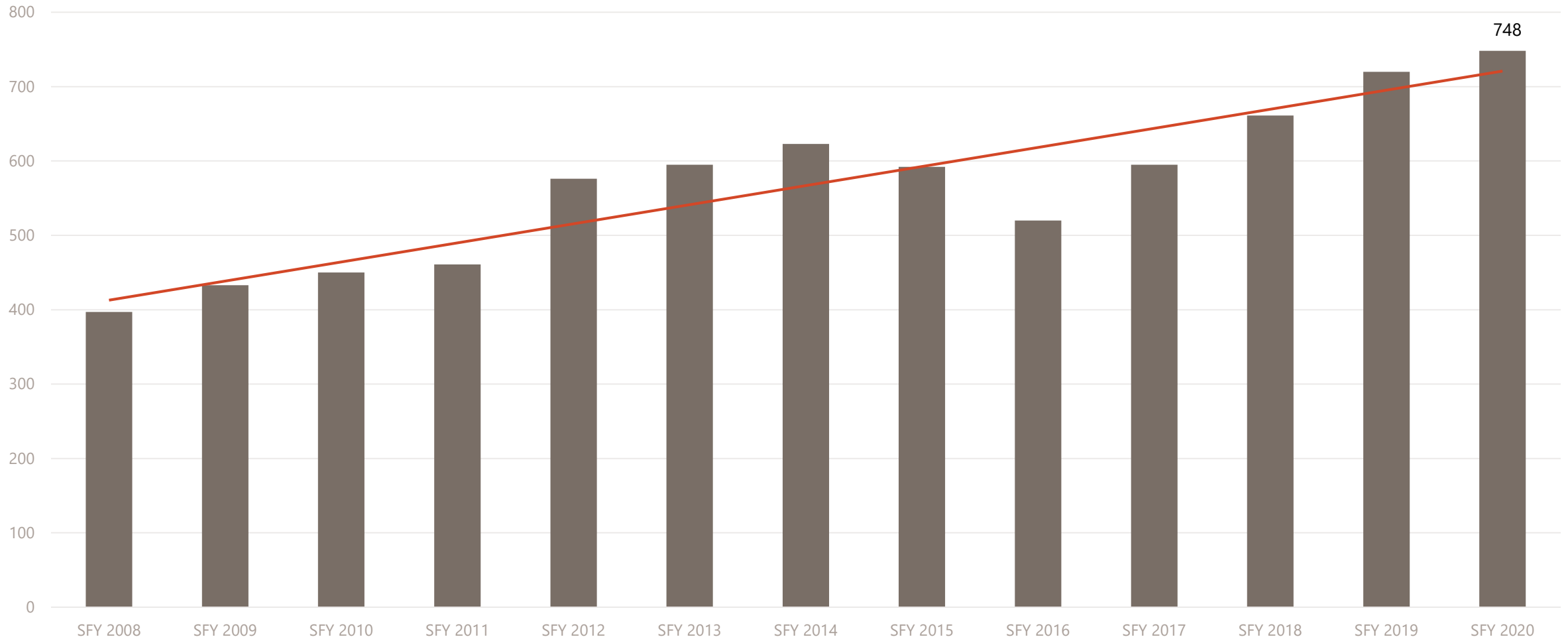
