We have reviewed the cash basis Annual Financial Report for Tower City Rural Fire Protection District for the year ended February 28, 2022. - Required fund breakouts are reported.

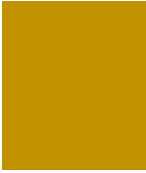
During the basic review, we identified that bank balances did agree to total balances reported on the Annual Financial Report.
