Dear Ms. Wallen,

We performed a special examination of the Solen Public School District for the period October 31, 2016 through October 31, 2018 – excluding the period of January 1, 2018 through September 30, 2018, as there was a lapse in insurance coverage. Ms. Magdalene Fasthorse (Red Bear) was the former Business Manager at Solen Public School District. Our responsibility was to report on Solen Public School District's limited records.

Based on our examination, we noted the following:

- There were unsupported payroll checks issued to Ms. Magdalene Red Bear, which exceeded her contracted salary. Unsupported payroll checks totaled \$32,511.15.
- Solen Public School District's credit card was used to pay for electric and fuel oil bills where the service address was that of Ms. Magdalene Fasthorse, totaling \$3,526.20. The credit card was also used to pay for a 43-day car rental, with Ms. Magdalene Red Bear as the renter. The car rental totaled \$2,563.73, after insurance. Questioned credit card transactions totaled \$6,089.93.

The total amount in question is \$38,601.08. Detailed schedules of the questioned amounts are presented on the following pages. The North Dakota Insurance Reserve Fund should take whatever action may be necessary regarding this matter.
