We performed a special examination of the Emerado Park District for the period June 1, 2019 through July 31, 2020. a former employee was the former bookkeeper at Emerado Park District. These records are the responsibility of the Emerado Park District's management.

Based on our examination, we noted the following:

- There were 2 unsupported payroll checks to a former employee, which exceeded her approved salary. Unsupported payroll checks totaled \$554.10.
- Emerado Park District's debit card was used by a former employee to pay for personal expenses totaling \$11,986.94.
- A pancake benefit was held by the Emerado Park District. A former employee did not deposit benefit proceeds totaling \$352 into the Emerado Park District's bank account.

The total amount in question is \$12,893.04. Detailed schedules of the unsupported payroll checks and questioned debit card expenses are presented on the following pages. The North Dakota Insurance Reserve Fund should take whatever action may be necessary regarding this matter.
