We have reviewed the cash basis Annual Financial Report for the Scranton Park District for the year ended 2023. This review was done under the authority of North Dakota Century Code 54-10-14. These reviews are limited in scope and are not completed under the Generally Accepted Auditing or Attestation standards issued by the American Institute of Certified Public Accountants. Therefore, we do not express an opinion over the financial information included in this report.

This review was limited to verifying the following:

- Long-term debt reported agrees to debt statements.
- Required fund breakouts are reported.
