Basic Review Summary

We have reviewed the cash basis Annual Financial Report for Grenora Rural Ambulance District for the year ended June 30, 2024. This review was done under the authority of North Dakota Century Code 54-10-14. These reviews are limited in scope and are not completed under the Auditing or Attestation standards issued by the American Institute of Certified Public Accountants.

This review was limited to verifying the following:
