Message

From the Commissioner



I appreciate Governor Kelly Armstrong's reappointment, allowing me to continue in my role as commissioner. Serving the State of North Dakota in this position is an honor. The work of state regulators is an important aspect of the North Dakota economy, as a stable and safe financial system fosters consumer confidence. North Dakota banks and credit unions continue to thrive, serving their communities well. Although the financial landscape is always evolving, our mission to ensure a safe and sound financial industry remains constant.

In 2025, the North Dakota legislature granted us continuing appropriations, where our budget is now approved by the State Credit Union and State Banking Boards. The Department is funded through assessments and fees paid by the entities it regulates. This change gives the boards, which include representatives of those entities, greater input into how their funds are allocated. It enables us to respond in a timely manner to the needs of the financial industry and our citizens. Maintaining a consistent state regulatory framework is essential to safeguarding and supporting our local economies, even when federal priorities shift.

In recent years, we have seen tremendous growth in non-depository licenses and many new innovations and financial products continue to emerge in the marketplace. In February 2025, Jan Murtha joined our department as deputy over the non-depository division. With this industry growth, we continue to explore new ways to improve efficiency. Results of these efforts include strengthened collaboration with other states to supervise multi-state companies and the recent adoption of a data security model law to enhance oversight and better protect North Dakota citizens.

To ensure consistent and fair regulation for our institutions, we engage in policy discussions at the national level. In 2023 and 2024, I had the privilege to serve as the Chair of the Conference of State Bank Supervisors (CSBS). This role expanded opportunities to work closely with other states and federal agencies. We were honored to host regulators from multiple states in Medora for the CSBS annual strategic planning meeting. I continue to serve as Chair of the CSBS Legislative Committee and as a member of its Board. I also served on the FDIC Regulatory Advisory Board until it sunset in 2024 and currently represent state bank regulators on the Financial Stability Oversight Council (FSOC) under the U.S. Treasury Department. In addition, Assistant Commissioner Corey Krebs serves on the National Association of State Credit Union Supervisors (NASCUS) Board. This involvement ensures that North Dakota interests are represented on the national stage.

As part of our financial literacy efforts, we began hosting the LifeSmarts competition for North Dakota high schools, which is a great way for students to learn about financial responsibility. We are proud of how well North Dakota teams compete at the national level!

Due to increased reports of financial fraud across the state, our educational efforts will continue to expand so we can provide timely and useful information to consumers. Keeping our North Dakota citizens' financial wellbeing in mind, while also preserving access to financial services, gives us purpose.

Thank you for the continued trust placed in our department. We remain committed to upholding the integrity of North Dakota's financial system and to serving our citizens with transparency, diligence, and care. I look forward to the work ahead and to collaborating with our partners across the state and nation to ensure a resilient financial future for North Dakota.

Our History

In 1887, the Office of Public Examiner was established to supervise the books and financial accounts of several public, educational, charitable, penal, and reformatory institutions of Dakota Territory, with public examiners appointed by the Governor.

1889

North Dakota becomes a state.

1893

The act establishing the Office of Public Examiner is repealed and an act providing for a State Examiner is enacted. The Governor is to appoint, and the Senate confirm the State Examiner, who shall examine the books of the Secretary of State, State Auditor, State Treasurer, Clerk of the Supreme Court, Commissioner of Insurance, County Treasurer, County Auditor, Board of County Commissioners, the general public, educational, charitable, penal, and reformatory institutions.

1905

The Banking Board is created to have charge and control over all associations carrying on the business of banking, savings banks, and trust companies under North Dakota law. This board consisted of the Governor, Secretary of State, and Attorney General.

1935

An act for the organization of credit unions is approved and placed under the supervision of the State Banking Board.

1943

Composition of the State Banking Board changed to two members appointed by the Governor and the State Examiner who serves as Chair. The Attorney General serves as Ex-officio, attorney for the Board.

1945

State Credit Union Board established consisting of two members appointed by the governor and the State Examiner who serves as Chair. The Attorney General serves as Ex-officio, attorney for the Board.

1960

Oversight of small loan companies is assigned to the office.

1969

The name of the Office of the State Examiner was changed to the Department of Banking and Financial Institutions, and the position of State Examiner changed to Commissioner.

Examination of state agencies, educational, charitable, penal, reformatory, county offices, cities, parks, and school districts was transferred to the State Auditor's Office.

The State Banking Board was expanded to five members.

The Department was assigned oversight of collection agencies.

1973

The Department was assigned oversight of sellers of checks.

1975

The Department was assigned oversight of consumer finance companies.

1979

The Department assigned oversight of money brokers.

The State Banking Board was expanded to 7 members, and the State Credit Union Board expanded to 5 members. The Commissioner serves as Chair of both Boards.

1997

Law governing small loan companies combined into consumer finance company law.

2001

The name of the Department of Banking and Financial Institutions changed to the Department of Financial Institutions.

Department was assigned oversight of deferred presentment service providers.

2005

The Department was assigned oversight of money transmitters.

2009

Law governing consumer finance companies was combined into money broker law.

2011

The Department was assigned oversight of debt settlement service providers.

2019

The Department embarks on an initiative to modernize laws and administrative rules, introducing bills which were passed by the legislature.

2021

The Department continues the initiative to modernize laws and administrative rules, introducing bills which were passed by the legislature.

2023

The Department embarks on an initiative to ensure state oversight is strong to prevent federal government preemption of state law, combining it with the modernization initiative, introducing bills which shored up state oversight of regulated entities, which were passed by the legislature.

Model money transmission law passed creating consistency across the nation, assigned the department oversight of virtual currency transmission, and reduced red tape as part of the Governor's Red Tape Reduction initiative.

Law governing money brokers was bifurcated, creating industry specific law for mortgage lenders and other non-depository lenders. This also modernized parts of the law and was part of the Governor's Red Tape Reduction initiative.

Department was assigned oversight of mortgage servicing companies. The law incorporates prudential standards creating consistency across the nation.

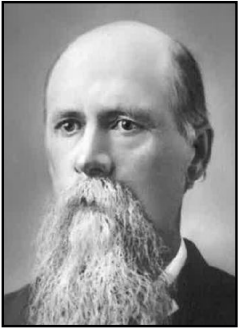
The State Banking Board and the State Credit Union Board were assigned Department budgeting authority as part of ongoing appropriations structure.

Department was assigned oversight of cooperative financial institutions, creating chartering options for mutual banks.

Clarified Department oversight of crypto currency kiosks.

Department was assigned oversight of data security standards for non-depositories. The law incorporates model law standards, creating consistency across the nation.

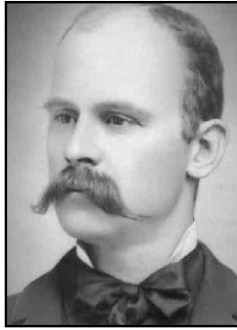

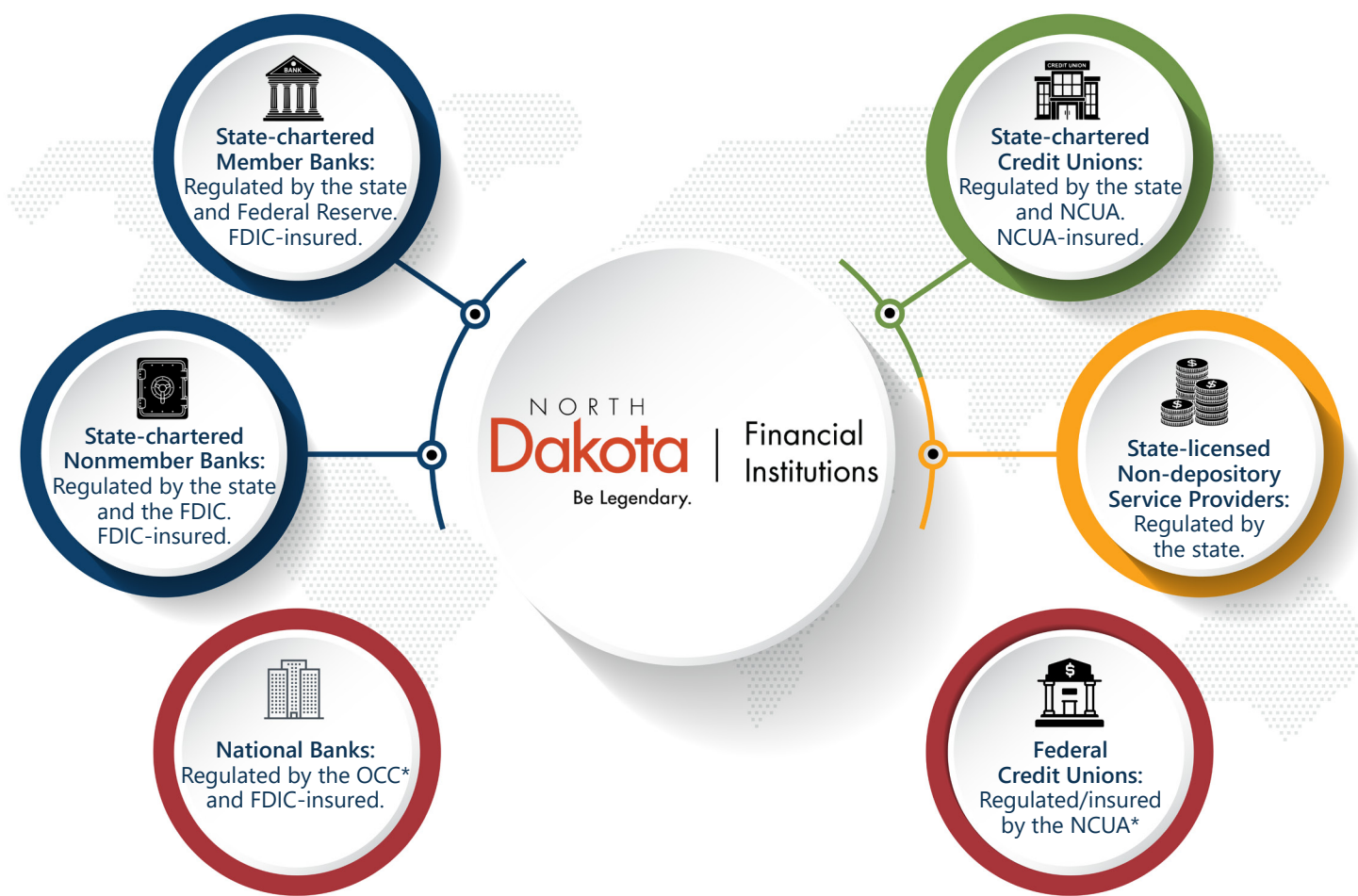

The State Banking Board works in conjunction with the Department of Financial Institutions and has charge of executing the Department's mission, including all laws relating to state-chartered banks and trust companies. The Commissioner of the Department of Financial Institutions and the State Banking Board provide supervisory authority over North Dakota state-chartered banks. All members of the Board are appointed by the Governor, with the chair being confirmed by the North Dakota Senate. The Commissioner serves as chair of the Board, and the Assistant Commissioner serves as the non-voting secretary of the Board. Four Board Members must have experience in an executive capacity in management of a state bank for at least five years; one member must have experience in an executive capacity in management of a state bank or a national bank for at least five years; and one member is from the public. These members represent different stakeholders within the financial system.

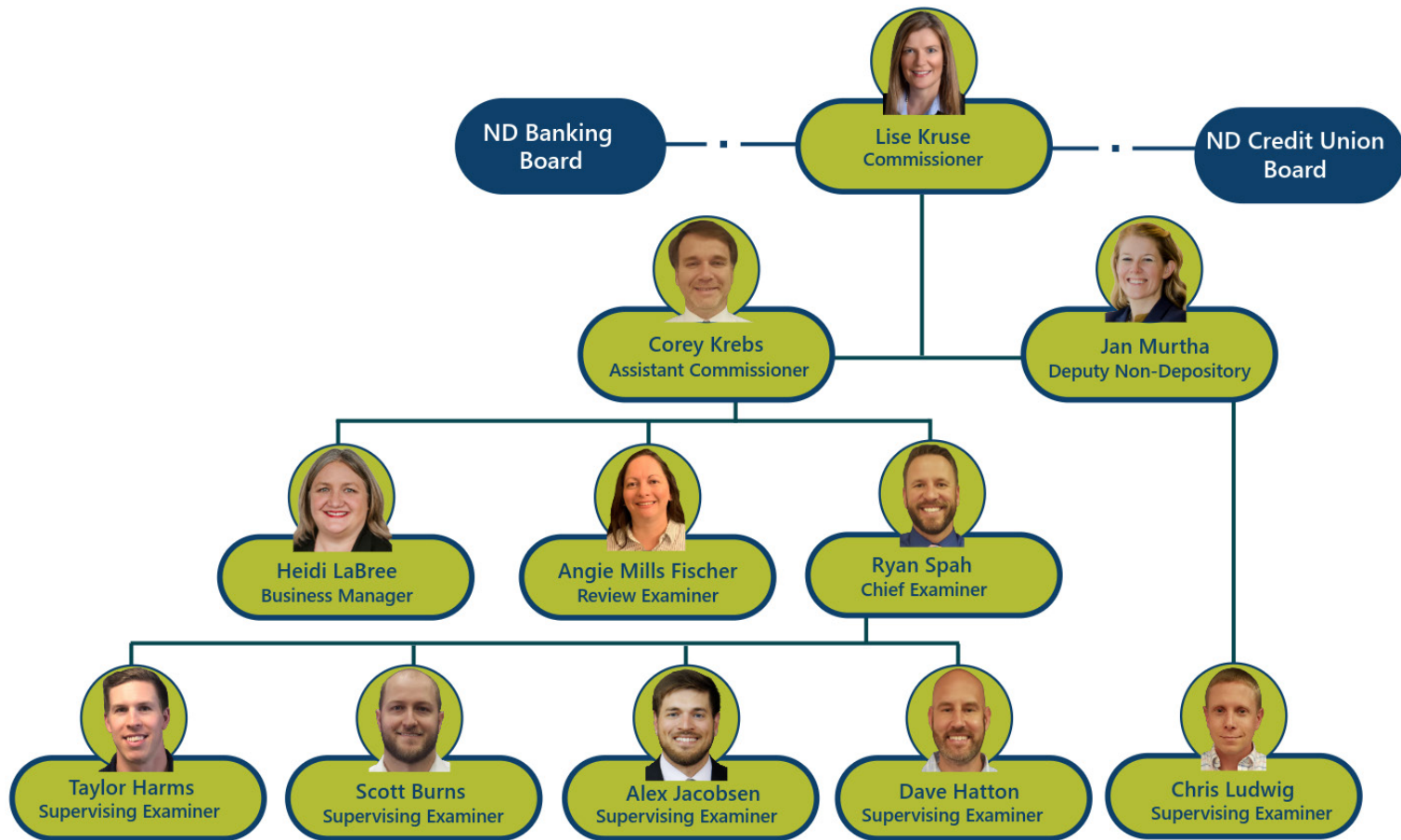

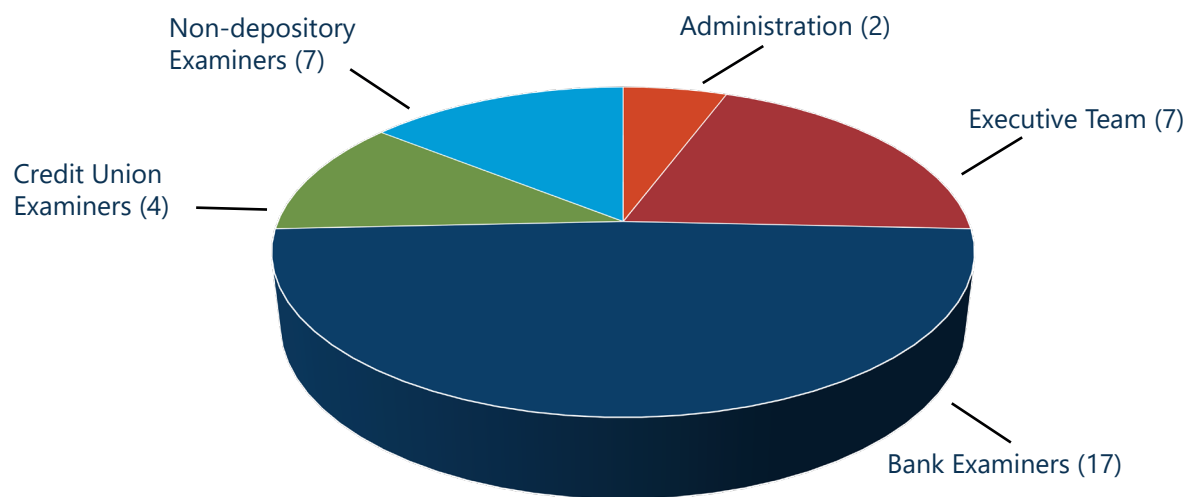

The State Credit Union Board works in conjunction with the Department of Financial Institutions and has charge of executing the Department's mission, including all laws relating to state-chartered credit unions. The Commissioner of the Department of Financial Institutions and the State Credit Union Board provide supervisory authority over North Dakota state-chartered credit unions. All members of the Board are appointed by the Governor, with the chair being confirmed by the North Dakota Senate. The Commissioner serves as chair of the Board, and the Assistant Commissioner serves as the non-voting secretary of the Board. Three Board Members must have experience in an executive capacity in management of a state credit union for at least five years; one member must have experience in an executive capacity in management of a state credit union or a national credit union for at least five years; and one member is from the public. These members represent different stakeholders within the financial system.

Connections

Representing North Dakota's Financial Interests at the National Level

August 2023: The Department hosted the Conference of State Bank Supervisors (CSBS) Strategic Planning event in Medora. Fifty-eight members from 27 states participated! It was a great opportunity to showcase our beautiful state.

October 2023: Pictured right, commissioner Kruse provided opening remarks at the 2023 Community Banking Research Conference held in St. Louis, emphasizing the vital role of community banks in sustaining and enriching local communities across the U.S., particularly in rural areas. Highlighting the strength of the dual-banking system and the importance of federal-state regulatory collaboration, she shared personal insights into how community banks go beyond financial services by funding essential amenities, supporting local causes, and stepping up in times of crisis. She underscored the need for tailored, transparent regulation that avoids unnecessary burdens, especially in light of recent regional bank closures, and called for continued storytelling and collaboration to preserve and strengthen the community banking model.

May 2025: At the Mortgage Policy Summit in Washington, D.C. Commissioner Kruse participated in a panel discussion highlighting how regulators and industry leaders can embrace innovation to enhance oversight, streamline compliance, and support responsible modernization.

April 2024: In a landmark move to strengthen mortgage industry oversight, the Department participate in a formal information-sharing agreement between the Conference of State Bank Supervisors (CSBS) and the Federal Housing Finance Agency (FHFA). The memorandum of understanding (MOU) enhances collaboration between state and federal regulators overseeing nonbank mortgage companies. As CSBS Board Chair, North Dakota Commissioner Lise Kruse was the first state regulator to sign, highlighting the state's leadership in financial regulation. The FHFA, regulator and conservator of Fannie Mae and Freddie Mac, joins state regulators with full authority over nonbank mortgage firms. This agreement improves coordination on market trends, risk management, and consumer protection. This milestone showcases North Dakota's commitment to financial stability and national policy leadership, advancing a more resilient housing finance system for the nation.



Information sharing between state regulators and federal supervisors is common sense given our shared interest in a vibrant, stable mortgage marketplace. Community Involvement

Statewide Partnerships: We're proud to collaborate with the North Dakota Bankers Association (NDBA), the Independent Community Banks of North Dakota (ICBND), and the Dakota Credit Union Association (DakCu). These partnerships strengthen our shared commitment to a safe, sound, and thriving financial system across North Dakota. Through ongoing engagement, we support education, innovation, and community-focused banking that benefits citizens statewide.

LifeSmarts: The Department has the pleasure of hosting, facilitating and participating in the LifeSmarts competition, engaging 54 students from five schools in the state-level event, up from 44 students in 2024. The program continues to empower young people with practical knowledge in areas such as personal finance, consumer rights, and technology. At the national level, North Dakota teams delivered outstanding performances: The Money Hounds from Litchville-Marion earned second place in 2025, while Jamestown tied for fifth, both placing in the top 16. In 2024, The Money Hounds also reached the top 16, tying for fifth nationally. These achievements reflect the dedication of our students and educators, and the growing impact of LifeSmarts across the state.

Take Your Child to Work Day: The Department had a great time teaching financial literacy to about 25 elementary-aged children. The Department of Financial Institutions, along with the Bank of North Dakota and the Department of Water Resources, spent the afternoon teaching and learning from these kids. This special observance occurs every April.

Zoo Boo: Department employees and their families enjoy volunteering their time at the Zoo Boo in October. It is a fun way to provide financial literacy tools (and candy) to kids of all ages!



Accomplishments & Activities

Digital Assets/Virtual Currency

The emergence of virtual currency and digital assets has sparked considerable curiosity among North Dakota citizens and the financial industry. Therefore, the department issued guidance to banks and credit unions to clarify regulatory expectations, as well as outlining risks to consider prior to engaging in the activity. The department also sponsored model law legislation for money transmission, which included transmissions involving virtual currencies.

Industry Oversight

The department remained vigilant to ensure companies doing business in North Dakota are financially sound and operate in accordance with the law. Forty bank, seven trust, twenty-six credit union, and 152 non-depository financial institution examinations were conducted during the biennium. Additionally, financial data was monitored on an ongoing basis for changing financial conditions. Removal orders, where individuals are prohibited from working for a financial institution, were issued against five individuals to guard the public against those who have engaged in fraud and other prohibited activities.

National Engagement

Effective local control is only possible if federal laws do not preempt state law and enforcement authority remains with state governments. The department remains engaged with federal regulators and lawmakers to ensure oversight of the financial industry includes state insight into the local economy. The Commissioner serves on the board of the Conference of State Bank Supervisors (CSBS) and was nominated to represent the states on the Financial Stability Oversight Council. The Assistant Commissioner serves on the board of directors of the National Association of State Credit Union Supervisors (NASCUS) and was appointed to the Joint Supervisory Working Group of the National Credit Union Association (NCUA). Through these associations and appointments, the department regularly engages with our federal agency counterparts such as the Federal Deposit Insurance Corp. (FDIC), the Federal Reserve system, the Consumer Financial Protection Bureau (CFPB), and the NCUA to ensure North Dakota interests are represented.

Outreach

Department officials are often asked to speak at various events and to different groups to share insight and educate. These include meetings of the Risk Management Association members, the Independent Community Bankers of North Dakota Agriculture lending school, and local colleges and universities. Department staff have presented citizen-facing fraud seminars and sponsored financial literacy training events.



We hosted both a bank and credit union summit to facilitate communications with regulated industries.

Networked Supervision

State banking agencies coordinate with one another to ensure seamless oversight of banks and credit unions with operations in multiple states. Non-depository financial institutions have grown and represent a significant segment of the financial industry, and the need for greater state coordination to oversee this sector has grown with it. Prudential standards establishing capital, liquidity, and board governance requirements for mortgage servicers and a model law for money transmitters were adopted into North Dakota law in 2023, and we have worked to implement these standards over this past biennium. These new laws ensure consistent supervision across the nation and enhanced protection for consumers. The department is participating in "One Company, One Examination" and multi-state examination initiatives, which leverages the work of other states' agencies to improve efficiencies, reduce duplication and regulatory burden, and ensure effective oversight of the financial industry. The department was an early adopter of the State Examination System (SES) software, ensuring a common modern platform is used across the nation for seamless examinations of the regulated industries.

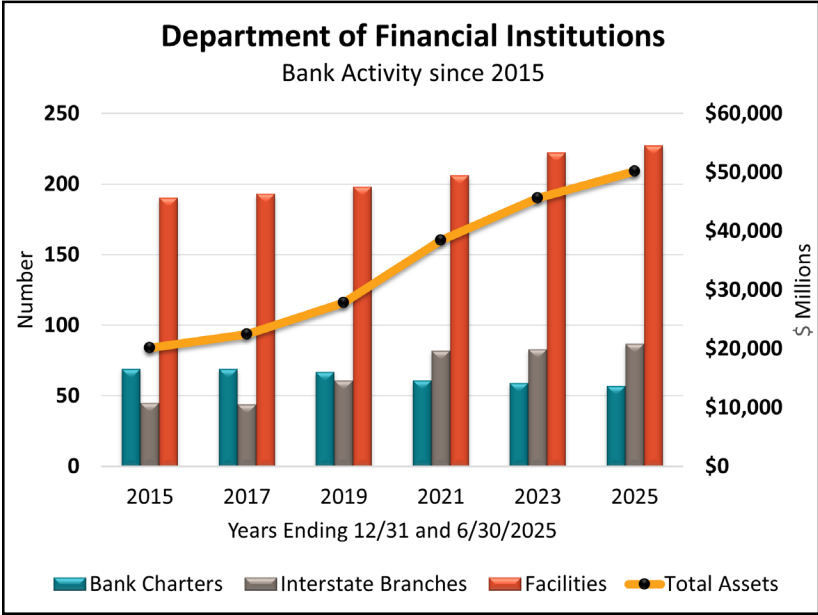
Modernization Initiative

The Department continued the strategy of modernizing laws and rules to ensure they meet the needs of the industry and North Dakota citizens and to eliminate unnecessary regulatory burdens where possible. This initiative helps limit the risk of federal preemption and enhances efforts to improve multi-state coordination. Several department bills were passed in 2025 updating outdated state laws, clarifying the applicability of law, and reestablishing a state charter for cooperative financial institutions.



North Dakota State-Chartered Bank Operations

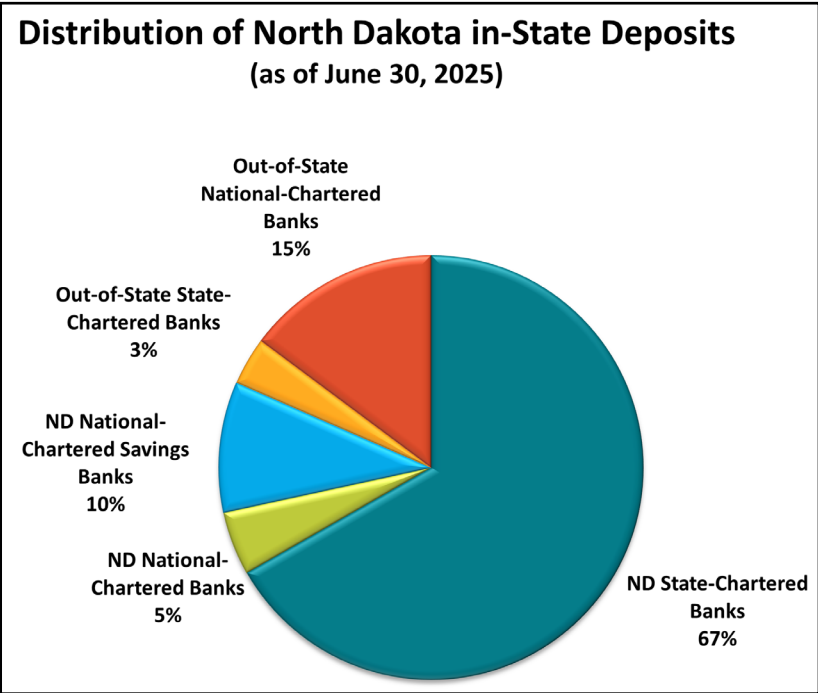
The financial services industry continues to expand rapidly. Total state-chartered bank assets increased \$4.6 billion, or 10%, over the biennium to \$50.2 billion. During that time, the number of bank locations increased by 5, or 2%, to 227. Out-of-state branches grew by 5% to 87 locations. All of this growth occurred while the number of individual state-chartered banks declined by 3% to 57. Despite consolidation and merger activity, state-chartered banks are growing, serving more communities, gaining market share, and becoming more complex. Even with significant growth, the industry has maintained a healthy financial position and remains well-capitalized.



North Dakota State-Chartered Market Share

Banks overseen by the department continued to gain market share. At the end of the biennium, North Dakota state-chartered banks held 67% of total bank deposits, up from 66% in the previous biennium and 56% in 2015.

North Dakota ranks higher than any other state (and Washington, D.C.) when it comes to banks and credit unions per capita. The state has roughly 64 banks and credit unions for every 100,000 residents.

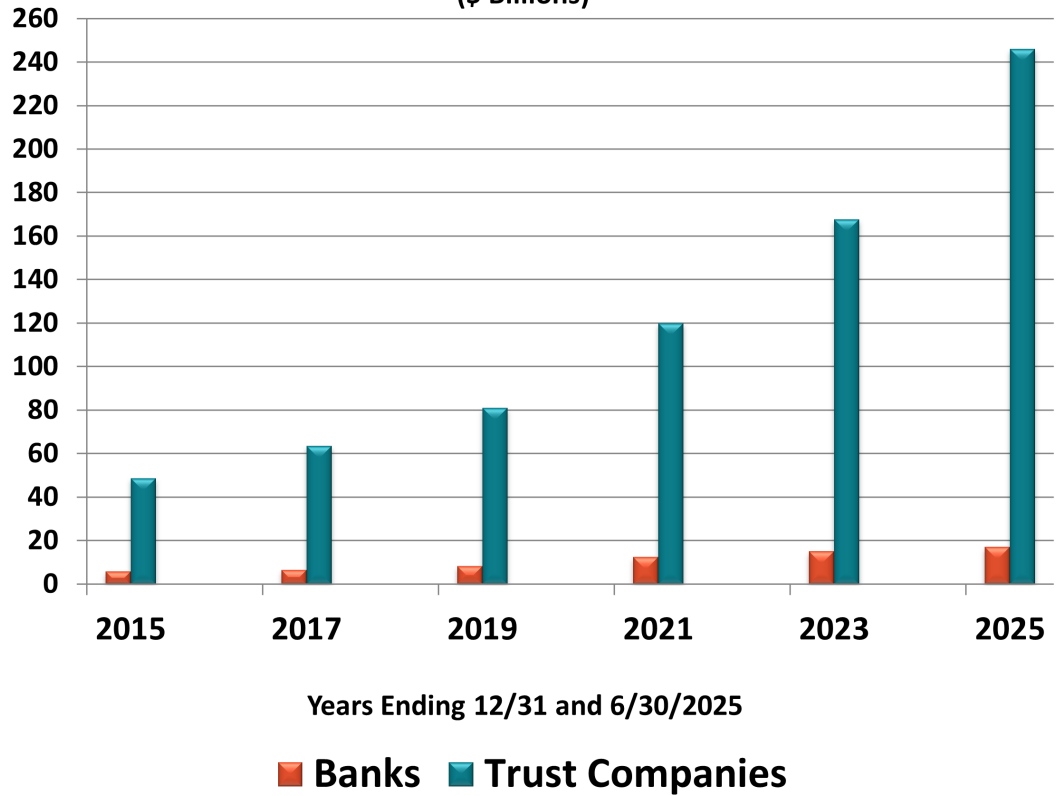


North Dakota State-Chartered Trust Operations

Trust activity among North Dakota banks and trust companies grew over the biennium. Total fiduciary assets under management rose 89% to \$263 billion.

These assets were held by four independent trust companies and 13 banks with trust powers.

(\$ Billions)

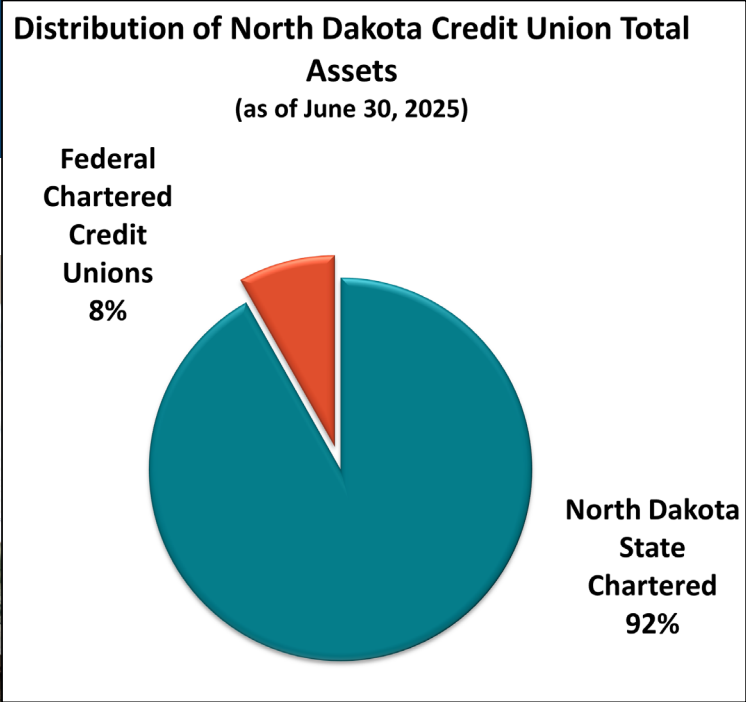
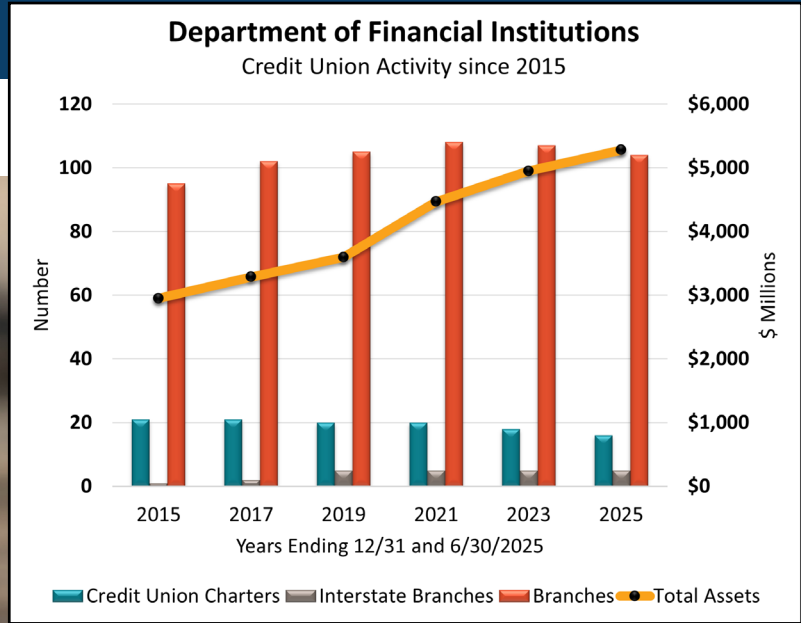


North Dakota State-Chartered Credit Union Operations

Credit unions continued to grow in size and complexity over the biennium. Assets increased by 10% to \$5.3 billion. The number of credit unions declined by 13% to 16, with three fewer branch locations, totaling 104. The number of interstate branches remained steady at five. Despite consolidation and merger activity, state-chartered credit unions expanded their market share. Even with this growth, they maintained a healthy financial posture and a well-capitalized equity position.

North Dakota State-Chartered Credit Union Market Share

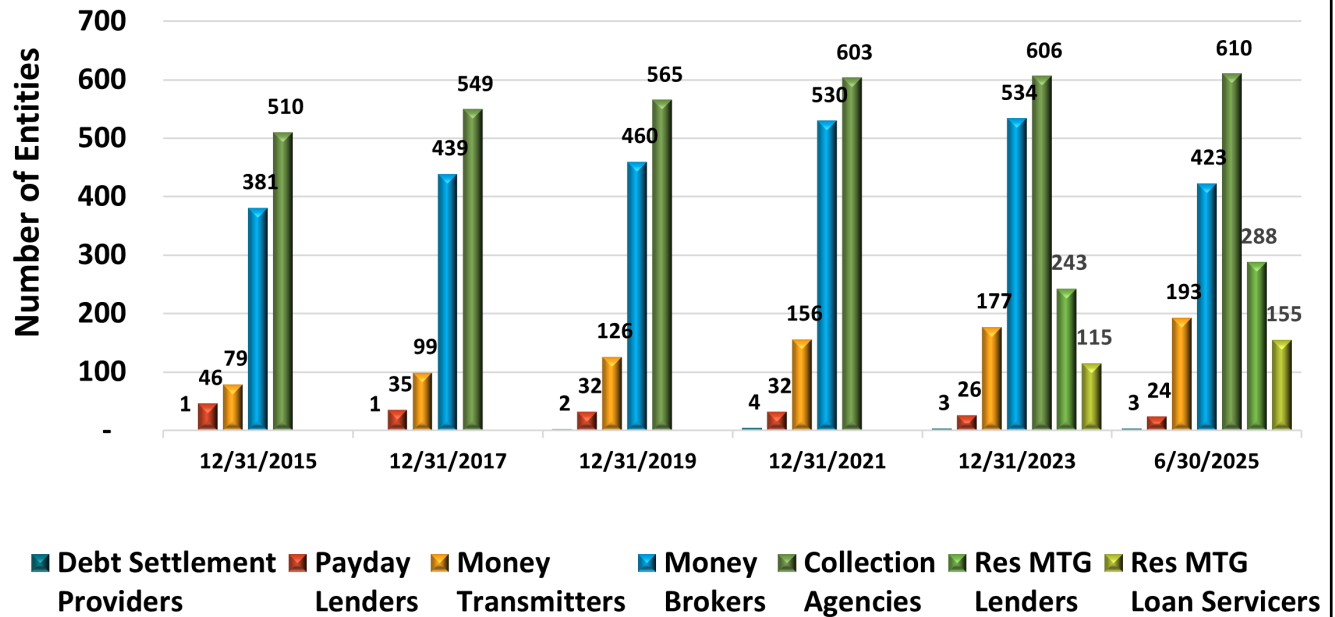
Credit unions overseen by the department continued to gain market share. At the end of the biennium, North Dakota state-chartered credit unions held 92% of total credit union assets, up from 91% in the previous biennium.

Non-depository financial institutions continued to grow in both the number of licensees and the sophistication of their product offerings. Certain industry sectors, such as mortgage lending, are now dominated by non-depository institutions rather than traditional banks. While not shown in the graph above, the number of licensed mortgage loan originators ranged from 2,295 in 2015 to a peak of 7,588 in 2021 and now totals 4,187. Non-depository licenses also include many companies considered financial technology (fintech) firms, which are delivering innovative products to North Dakota citizens. Several fintechs are partnering with traditional banks to offer complex products to a broader customer base. Although banks still dominate the financial industry, emerging non-depository financial corporations are experiencing significant growth, acting as market disruptors and introducing both new risks and opportunities to the financial services sector.

Short & Long-term Goals



Preempt preemption – Ensure strong state oversight to prevent federal government preemption of state laws and state oversight of the financial industry.

Provide a consistent legal framework for regulated industries by adopting model state laws and prudential standards.

Engage with federal agencies and participate in regulatory trade organizations.

Limit regulatory duplication by coordinating between states through the “one company, one exam” initiative.

Modernize supervision. Update regulations and examinations to ensure relevance and reduce outdated or unnecessary regulatory hurdles.

Perform timely and impactful examinations in accordance with accreditation standards to ensure the financial services industry remains strong and vibrant.

Construct an oversight program for cybersecurity standards and crypto kiosks established by legislation in 2025.

Enhance financial literacy programming to better reach youth, new Americans, and underbanked populations.

Improve communications with the industries overseen.



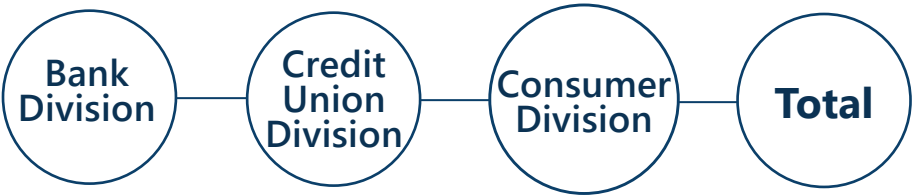
