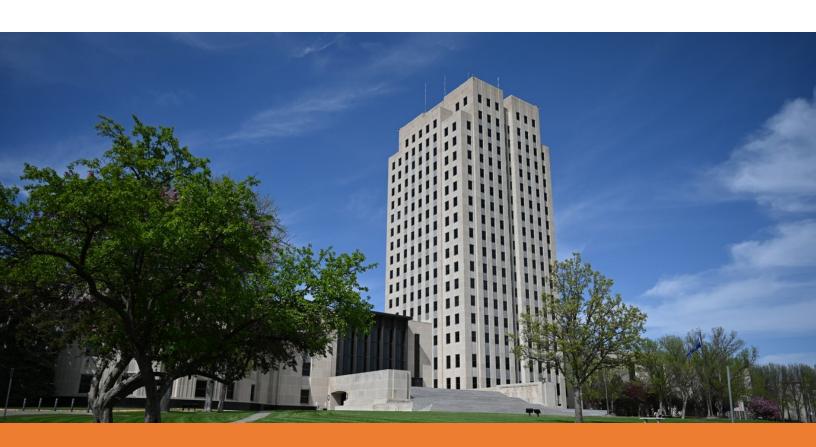

North Dakota Department of Financial Institutions

MESSAGE FROM THE COMMISSIONER



It continues to be an honor and privilege to serve in the capacity of commissioner of this department. In the department's 136th year, it is amazing to see that our purpose has remained consistent. In his 1914 report, my predecessor S.G. Severtson commented on the importance of banks operating safely, stating that banks are the "custodian of the savings of children and hard-working people." This statement is still true and relevant as our purpose is to ensure the safety and soundness of our financial institutions, which results in the ability of our citizens to access financial services with confidence. Since every citizen uses some form of financial service, whether it is with our banks, credit unions, or one of our many nonbank licensees, our department's work impacts every citizen in North Dakota.

I truly believe the dual banking system in the United States is what makes our economy the greatest in the world. The dual banking system allows for federal and state partnerships in supervision of our banks and credit unions. That partnership includes local insight and is what helps our community financial institutions thrive. Community financial institutions are the backbone of the communities they serve, providing services to local farmers, businesses, and entrepreneurs – making our economy resilient.

In the last few years, financial institutions have faced interesting and unique challenges. Cybersecurity and fraud are continual threats facing the financial industry. The COVID-19 federal stimulus provided liquidity in the system, where institutions invested in assets that were affected by rising interest rates. Managing interest rates and liquidity poorly, along with the speed of social media-induced bank runs, caused bank failures on the coasts in the spring of 2023. Throughout, our local institutions have remained stable, well-capitalized and in sound financial condition. In North Dakota we have not experienced a bank failure for over 30 years, and the only reason we have fewer banks today is due to consolidations.

Our department has seen significant growth in nonbank licensees in recent years. To ensure we remain vigilant in our oversight, in 2023 we introduced, and our legislators passed, a model law for money transmitters and a law requiring licensing and oversight of mortgage servicers. Looking to the future, we will address cybersecurity concerns by introducing model law legislation in 2025 for nonbanks. For banks and credit unions, we will encourage the use of a state regulator-developed tool to help institutions prepare in the event of a ransomware attack. As fraud is prevalent, we are continually seeking ways to enhance financial literacy education for our citizens. Starting in 2024, our department will host the LifeSmart program, which is a competition for North Dakota high schools on financial literacy. Our commitment is to further our mission of ensuring a safe and sound financial industry, to the benefit of North Dakota citizens.



Accomplishments & Activities

Digital Assets/Virtual Currency

The emergence of virtual currency and digital assets has sparked considerable curiosity among North Dakota citizens and the financial industry. Therefore, the department issued guidance to banks and credit unions to clarify regulatory expectations, as well as outlining risks to consider prior to engaging in the activity. The department also sponsored model law legislation for money transmission, which included transmissions involving virtual currencies.

Industry Oversight

The department remained vigilant to ensure companies doing business in North Dakota are financially sound and operate in accordance with the law. Forty bank, seven trust, twenty-six credit union, and 152 non-depository financial institution examinations were conducted during the biennium. Additionally, financial data was monitored on an ongoing basis for changing financial conditions. Removal orders, where individuals are prohibited from working for a financial institution, were issued against five individuals to guard the public against those who have engaged in fraud and other prohibited activities.

National Engagement

Effective local control is only possible if federal laws do not preempt state law and enforcement authority remains with state governments. The department remains engaged with federal regulators and lawmakers to ensure oversight of the financial industry includes state insight into the local economy. The Commissioner was elected to the board of directors and is currently chairing the Conference of State Bank Supervisors (CSBS). The Assistant Commissioner was elected to the board of directors of the National Association of State Credit Union Supervisors (NASCUS). Through these associations, the department regularly engages with our federal agency counterparts such as the Federal Deposit Insurance Corporation (FDIC), the Federal Reserve system, the Consumer Financial Protection Bureau (CFPB), and the National Credit Union Administration (NCUA) to ensure North Dakota interests are represented.

Outreach

Department officials are often asked to speak at various events and to different groups to share insight and educate. These include meetings of the Risk Management Association members, the Independent Community Bankers of North Dakota Agriculture lending school, and local colleges and universities. The Commissioner is on the FDIC Advisory Committee of State Regulators and as the current Chair of

CSBS, has had the privilege of speaking nationally, including the closing comments at the 2022 Community Bank Research Conference held at the St. Louis Federal Reserve Bank.

Networked Supervision

State banking agencies coordinate with one another to ensure seamless oversight of banks and credit unions with operations in multiple states. Non-depository financial institutions have grown and represent a significant segment of the financial industry, and the need for greater state coordination to oversee this sector has grown with it. Prudential standards establishing capital, liquidity, and board governance requirements for mortgage servicers and a model law for money transmitters were adopted into North Dakota law in 2023. These new laws ensure consistent supervision across the nation and enhanced protection for consumers. The department is participating in "One Company, One Examination" and multi-state examination initiatives, which leverages work of other states' agencies to improve efficiencies, reduce duplication and regulatory burden, and ensure effective oversight of the financial industry. The department was an early adopter of the State Examination System (SES) software, ensuring a common modern platform is used across the nation for seamless examinations of the regulated industries.

Staffing

The department has an excellent team of talented examiners and support staff. The past five years has seen the retirement of key personnel and intense competition within the labor market for those with financial training. While it has been challenging, existing staff have stepped up to fill vacant key management positions, and recruitment efforts have successfully filled open examiner positions with top candidates. This has allowed the department to continue to meet its mission while rebuilding the examination team.

Modernization Initiative

The Department continued the strategy of modernizing laws and rules to ensure they meet the needs of the industry and North Dakota citizens and to eliminate unnecessary regulatory burdens where possible. This initiative helps limit the risk of federal preemption and enhances efforts to improve multi-state coordination. Several department bills were passed in 2023 updating outdated state laws and were part of the Governor's Red Tape Reduction initiative. Additionally, administrative rules were updated to improve processes and reflect changes in federal law.





House Bill 1008

Department Budget Bill:

- Appropriations of \$9,856,379, excluding OMB bill funding.
- Authority for 35 full time employees.
- Legislative amendment added creating a legislative study looking into alternative appropriation methods for the department.

House Bill 1068

Bill creating supervision framework for mortgage servicers:

- Filled a gap in oversight as non-bank servicers now represent 60% of servicing market.
- Incorporates prudential standards for liquidity, capital, and board governance into North Dakota law.
- Reduces risk of federal preemption by establishing a sound and consistent state oversight process.

Senate Bill 2090

Bill addressing mortgage lenders:

- Enacted law specific to mortgage lenders, clarifying rules applicable to mortgage lenders versus other nonbank lenders.
- Removed unnecessary duplication with other laws.
- Simplifies and creates consistency with other laws related to administrative remedies.
- Clarifies industry exemption from the law.
- This bill was part of the Governor's Red Tape Reduction Initiative.

Senate Bill 2092

Bill to improve legal consistency and credit union liquidations:

- Simplifies and creates consistency with other laws related to administrative remedies.
- Changed law for voluntary liquidation of a credit union to be consistent with current state and federal processes.
- Relocated the voluntary liquidation law to a different section covering similar issues.

Senate Bill 2119

Bill related to money transmission:

- Adopted model money transmission law, creating consistency across the nation.
- Adopts a framework for overseeing virtual currency transmission.
- Reduces risk of federal preemption by establishing a sound and consistent state oversight process.
- This bill was part of the Governor's Red Tape Reduction Initiative.

- ❖ Build an oversight program for mortgage servicing; authority established by legislation in 2023.
- Improve financial literacy program to better reach youth, new Americans, and underbanked populations.
- ❖ Improve communications with the industries overseen.
- ❖ Introduce model law establishing cybersecurity standards for nonbank industry.

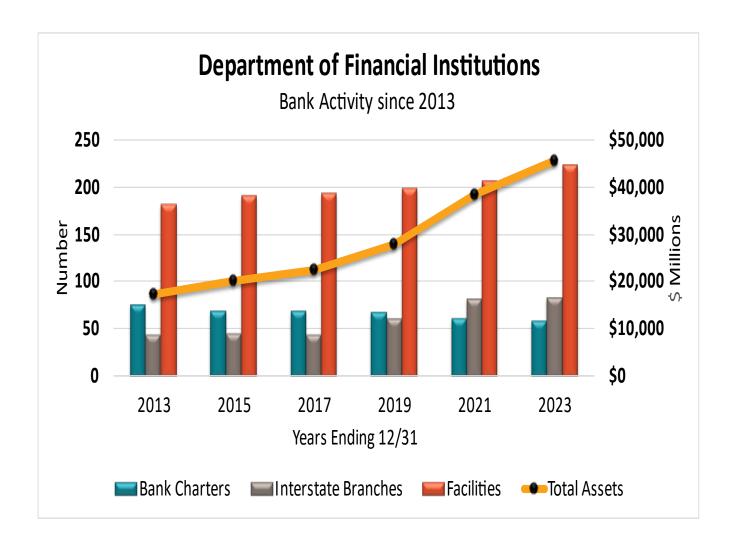

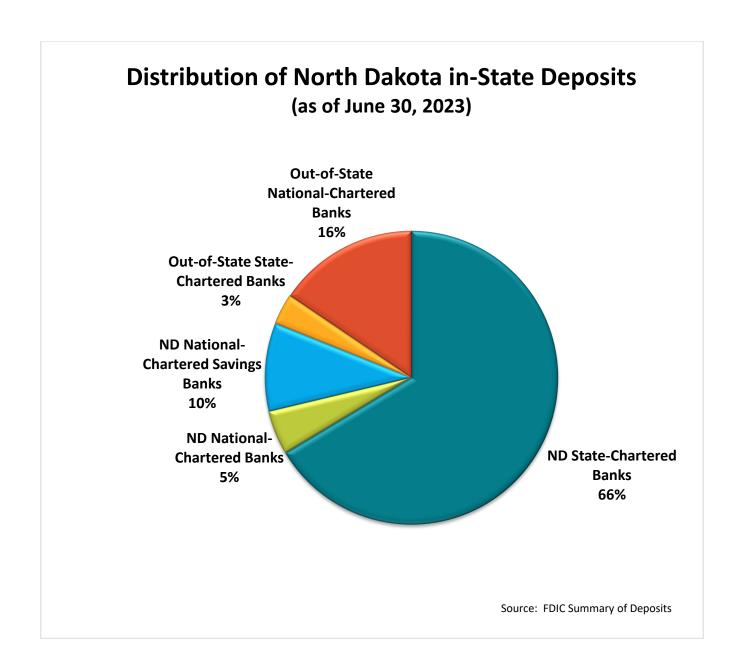
North Dakota State-Chartered Bank Operations

The financial services industry continues to expand rapidly. Total state-chartered bank assets increased \$8.1 billion, or 21 percent, over the biennium to \$45.6 billion. During that time, the number of bank locations increased by six, or three percent, to 222 locations. Out-of-state branches increased six percent to 83 locations. All of the growth occurred while the number of individual state-chartered banks declined five percent to 59. Despite consolidation and merger activity, state-chartered banks are growing, serving more communities, gaining market share, and also becoming more complex. Even with the significant growth, the industry has maintained an overall healthy financial position and remain well-capitalized.



North Dakota State-Chartered Bank Market Share

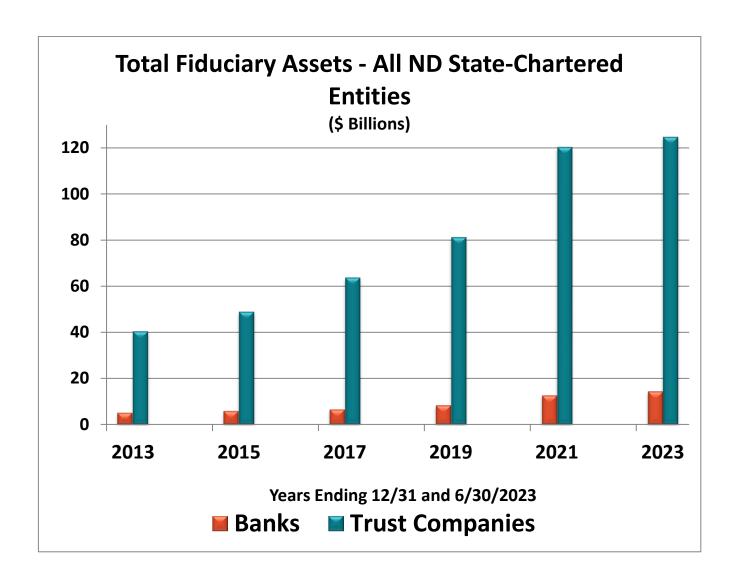
Banks overseen by the department continue to gain market share. North Dakota state-chartered banks held 66 percent of total bank deposits at end of this biennium, up from 63 percent last biennium, and 53 percent in 2013.





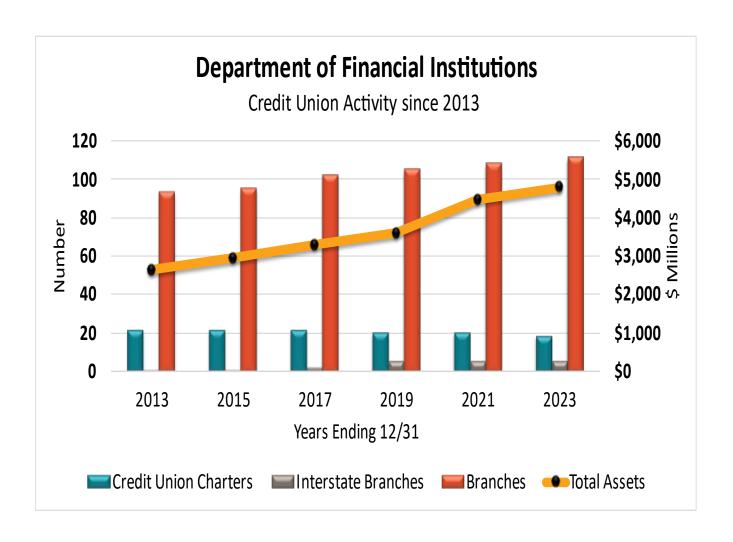
North Dakota State-Chartered Trust Operations

Trust activity of North Dakota banks and trust companies grew over the biennium. Total fiduciary assets under management increased 28 percent to \$139 billion. These assets were held by four independent trust companies and 13 banks with trust powers. This includes one additional bank with trust powers over that period.



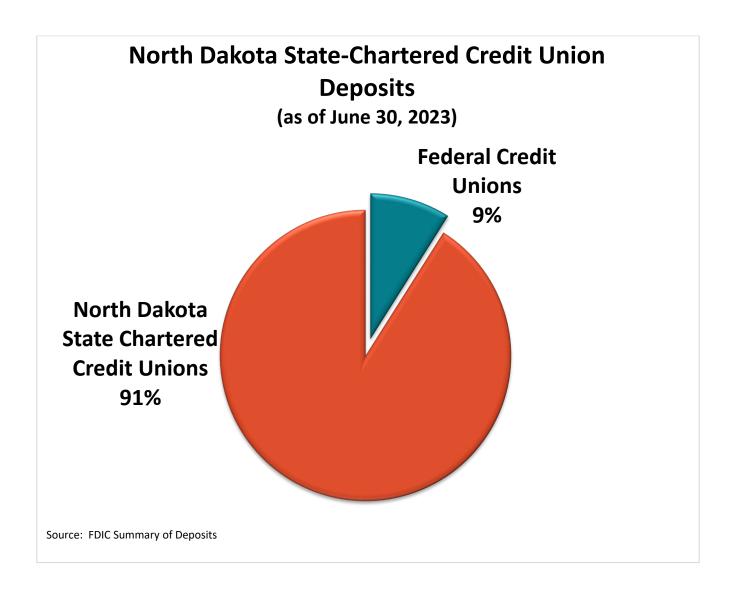
North Dakota State-Chartered Credit Union Operations

Credit unions are also increasing in size and becoming more complex. Credit union assets increased 12 percent over the biennium to \$4.8 billion. The number of credit unions declined ten percent to 18 while three branch locations were added for a total of 111. The number of interstate branches remains at five. Despite consolidation and merger activity, state-chartered credit unions are growing and gaining market share. Despite the growth, credit unions maintained a healthy financial posture resulting in a well-capitalized equity position.



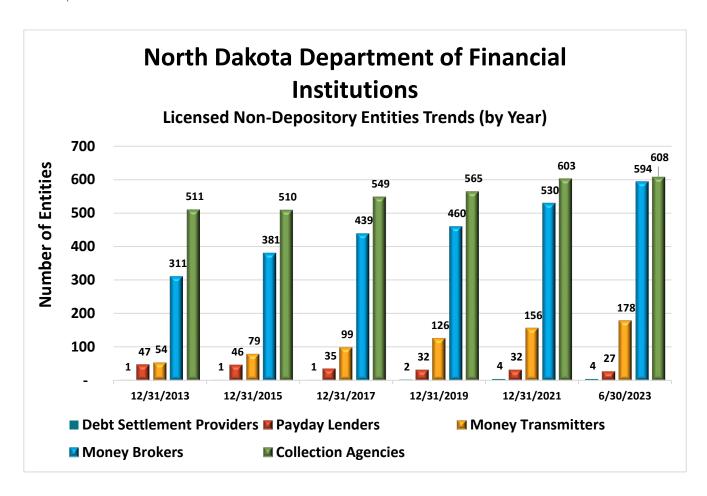
North Dakota State-Chartered Credit Union Market Share

Credit Unions overseen by the Department continue to gain market share. North Dakota state-chartered credit unions held 91 percent of total credit union deposits at end of this biennium, up from 90 percent last biennium, and 84 percent in 2013.



North Dakota Non-Depository Financial Institutions

Non-Depository financial institutions continue to grow both in the number of licensees, as well as in the sophistication of their product offerings. Certain industry sectors, such as mortgage lending, are now dominated by non-depository institutions rather than traditional banks. The non-depository licenses also include many companies considered Financial Technology (FinTech) firms, who are providing their innovative product offerings to North Dakota citizens. A number of FinTechs are partnering with traditional banks to offer complex products to a greater number of customers. While the financial industry is still largely dominated by banks, new non-depository financial corporations are experiencing significant growth, can be considered market disruptors, and present both new risks and opportunities within the financial services sector. The dramatic failures of cryptocurrency related companies witnessed this biennium are examples of these risks.



Available Publications

Bulletin – The Bulletin is published every month and available on the Department's website, as well as emailed to those who subscribe to the updates on the Department website.

Department Brochure – The Department Brochure is distributed to prospective employees as an information source about the Department and its function.

Financial Literacy Brochures – The Financial Literacy Brochures are available to the public as an information source regarding scams, credit scores, and credit cards versus debit cards.

Newsletter – The Department Newsletter is published periodically and emailed to state-chartered banks and credit unions.



Schedule of State Banking and Credit Union Board Meetings – The Department posts an annual schedule, as well as any changes or revisions, of board meetings on the Secretary of State's Public Meeting Notice website. The schedule is also posted to the Department's website.

State Banking Board Minutes – Banking Board meetings are held every other month beginning in January. Minutes of the Open Session are available to the public.

State Credit Union Board Minutes – Credit Union Board meetings are held quarterly beginning in March. Minutes of the Open Session are available to the public.

History of the Department

- The Office of Public Examiner established to supervise the books and financial accounts of several public, educational, charitable, penal, and reformatory institutions of Dakota Territory, with public examiners appointed by the Governor.
- 1889 North Dakota becomes a state.
- The act which established the Office of Public Examiner is repealed and an act providing for a State Examiner is enacted. The Governor is to appoint, and the Senate confirm the State Examiner, who shall examine the books of the Secretary of State, State Auditor, State Treasurer, Clerk of the Supreme Court, Commissioner of Insurance, County Treasurer, County Auditor, Board of County Commissioners, the general public, educational, charitable, penal, and reformatory institutions.
- 1905 The Banking Board is created to have charge and control over all associations carrying on the business of banking, savings banks, and trust companies under the laws of North Dakota. This board consisted of the Governor, Secretary of State, and Attorney General.
- 1935 An act for the organization of credit unions is approved and placed under the supervision of the State Banking Board.
- 1943 Composition of the State Banking Board changed to two members appointed by the Governor and the State Examiner who serves as Chair. The Attorney General serves as Exofficio, attorney for the Board.
- 1945 State Credit Union Board established consisting of two members appointed by the governor and the State Examiner who serves as Chair. The Attorney General serves as Exofficio, attorney for the Board.
- 1960 Oversight of small loan companies assigned to the office.
- 1969 The name of the Office of the State Examiner was changed to the Department of Banking and Financial Institutions, and the position of State Examiner changed to Commissioner.
- 1969 Examination of state agencies, educational, charitable, penal, reformatory, county offices, cities, parks, and school districts was transferred to the State Auditor's Office.
- 1969 The State Banking Board was expanded to 5 members.
- 1969 Department assigned oversight of collection agencies.
- 1973 Department assigned oversight of sellers of checks.



History of the Department

Department assigned oversight of consumer finance companies. 1975 1979 Department assigned oversight of money brokers. 1979 The State Banking Board was expanded to 7 members, and the State Credit Union Board expanded to 5 members. The Commissioner serves as Chair of both Boards. 1997 Law governing small loan companies combined into consumer finance company law. 2001 The name of the Department of Banking and Financial Institutions changed to the Department of Financial Institutions. 2001 Department assigned oversight of deferred presentment service providers. 2005 Department assigned oversight of money transmitters. 2009 Law governing consumer finance companies combined into money broker law. 2011 Department assigned oversight of debt settlement service providers. 2019 Department embarks on an initiative to modernize laws and administrative rules, introducing bills which were passed by the legislature. 2021 Department continues the initiative to modernize laws and administrative rules, introducing bills which were passed by the legislature. 2023 Department embarks on an initiative to ensure state oversight is strong to prevent federal government preemption of state law, combining it with the modernization initiative, introducing bills which shored up state oversight of regulated entities, which were passed by the legislature. 2023 Model money transmission law passed creating consistency across the nation, assigned the department oversight of virtual currency transmission, and reduced red tape as part of the Governor's Red Tape Reduction initiative. 2023 Law governing money brokers was bifurcated, creating industry specific law for mortgage lenders and other non-depository lenders. This also modernized parts of the law and was part of the Governor's Red Tape Reduction initiative. 2023 Department assigned oversight of mortgage servicing companies. The law incorporates

prudential standards creating consistency across the nation.
