The regular meeting of the State Banking Board was held in the Office of the Commissioner, Department of Financial Institutions, 1200 Memorial Highway, Bismarck, North Dakota. Chair Kruse called the meeting to order at 1:00 p.m., Friday, September 23, 2022.

APPROVAL OF MINUTES

Chair Kruse indicated the Board received copies of the minutes of the regular meeting held on July 6, 2022.

It was moved by Member Schmid, seconded by Member Foster, and carried by a vote of 7 to 0 to approve the minutes of the regular meeting held on July 6, 2022.

PEOPLES STATE BANK, WESTHOPE – APPLICATION FOR TYLER ENGSTROM, DARIN BOHL, AND CURTIS MOUM, AS A GROUP ACTING IN CONCERT, TO ACQUIRE CONTROL FO 25% OR MORE OF THE VOTING STOCK OF PEOPLES STATE HOLDING COMPANY, WHICH OWNS 100% OF PEOPLES STATE BANK, BOTH OF WESTHOPE, ND

TRUCOMMUNITY BANK, GARRISON – REQUEST FOR APPROVAL TO AMEND ARTICLES OF INCORPORATION AND APPROVAL TO RESTATE THE ARTICLES OF INCORPORATION Chief Examiner Ryan Spah reviewed the memorandum. The complete application was received August 26, 2022.

There were no comments or questions from the Board.

It was moved by Member Jahner, seconded by Member Schollmeyer, and carried by a vote of 7 to 0 to approve the amended and restate articles.

Turtle Mountain State Bank, Belcourt, ND, established an LPO at 201 Missouri Dr., Mandan, ND. Bell Bank, Fargo, ND, established LPOs at 626 4th St N., Stillwater, MN; 1222 SE 47th St, Cape Coral, FL; and 4101 Charlotte Ave, Nashville, TN.
