### BANK BUDGET UPDATE

Assistant Commissioner Krebs gave an overview of the Department's budget. He stated the Department expenditures, and that what is remaining for the biennium are tracking within budget. Commissioner Kruse stated that there will be a joint meeting of the State Credit Union Board and the State Banking Board in June of 2025 to discuss the Department budget, in response to the approval of the alternate appropriations bill.
