First Western Bank & Trust, Minot, ND—Application to establish an interstate branch at 3001 N Alma School Road, Chandler, AZ.

Paxos Trust Corporation, LLC d/b/a Paxos, LLC, New York, NY—Request to use the word "trust" in the registered trade name. Applicant will use the trade name "Paxos, LLC" in ND to eliminate confusion because the entity is not operating as a trust company in ND.

United Valley Bank, Cavalier, ND—Request for an extension to establish a facility at 3300 Jacks Way, Fargo, ND from 11/8/2025 to 2/28/2026.

Grant County BanCorporation, Inc., Carson, ND—Application for Michael Schmid to join the Schmid Family Shareholder Group and to acquire 25% or more of the voting stock of Grant County BanCorporation, Inc., which controls 100% of Grant County State Bank, Carson, ND.

Bravera Bank, Dickinson, ND—Application to merge VISIONBank, Fargo, ND with and into Bravera Bank.

Columbia Bank, Lake Oswego, OR—Request to use the word "bank" in the registered trade name.

Bell Bank, Fargo, ND—Application to establish an LPO at 4719 Banning Ave, White Bear Lake, MN.
