Testimony Department of Human Services Human Services Interim Committee Representative Chuck Damschen, Chairman June 19, 2014

Chairman Damschen, members of the Human Services Committee, I am Alex C. Schweitzer, Director of Field Services and Superintendent of the Life Skills and Transition Center of the Department of Human Services. I am here today to testify on the programs and services of the Life Skills and Transition Center.

Life Skills and Transition Center (LSTC) Programs:

The LSTC provides services for individuals with developmental and intellectual disabilities (Intermediate Care Facility-DD/ID). The LSTC provides residential services, which include medical and clinical programming, vocational services, and outreach services.

Residential Services at the LSTC include:

- Secure Services Program serves individuals with developmental and intellectual disabilities who have sex offending behaviors and for other individuals from the campus that require a more secure living environment. These individuals require long-term care.
- Health Services Program serves individuals with developmental and intellectual disabilities who are totally dependent on staff to complete daily cares and have medical concerns that require nursing staff accessibility 24 hours per day. Also, in this program are a small

number of individuals diagnosed with profound developmental disabilities and dual sensory disabilities (vision and hearing). These individuals require long-term care.

- Behavioral Services Program serves individuals with developmental and intellectual disabilities who also have psychiatric diagnoses and significant challenging behaviors. Some of these individuals may also have less severe medical needs.
- Youth Transition Services Program (YTS) serves young people
 with intellectual disabilities between the ages of 16-25 who have
 difficulty finding housing and services in the community. The LSTC
 provides short-term services to these individuals until a community
 placement can be found.

Vocational Services at the LSTC include:

Work Activity Program - serves individuals at vocational work sites
throughout the campus and in the community. Special emphasis is
placed on individualizing work and activities for each resident's
particular need and to integrate them into community work sites
whenever possible.

Outreach Services at the LSTC include:

Independent Supported Living Arrangement Program (ISLA) –
LSTC staff support individuals in local community housing so they can
live independently.

- Professional Services Institute LSTC provides outreach services for the community. Behavioral health care has been the initial focus area, but the LSTC, is receiving more requests to address complex health care needs statewide.
 - Outreach Program the Clinical Assistance, Resource, and Evaluation Service (CARES) team provides support services in the community to prevent admissions and readmissions and to assist in transitioning people from the LSTC.
 - CARES Clinic the CARES Clinic is a team of professionals who specialize in providing services for people with disabilities who live in the community. Examples of services provided are physical therapy, occupational therapy, speech therapy, adaptive equipment services, dental services, and medical services.
 - Intellectual Disabilities Behavioral Health Service this is a team of applied behavioral analysts who deliver behavioral assessment and intervention services to people with developmental and intellectual disabilities throughout North Dakota.

Life Skills and Transition Center Census:

The transition goal, by July of 2015, is to reach a campus population of 60 adults in the ICF-DD/ID program and 10 youth in the YTS. In addition, the goal is to serve 13 adults in the ISLA program in the Grafton community.

As we continue transition, the people remaining at the LSTC, have higher acuity and require significant behavioral, clinical and medical interventions.

Life Skills and Transition Center Buildings:

Total square footage on the campus is 1,323,511, with 801,253 square feet of pedestrian tunnels.

The LSTC currently receives lease payments of \$69,615.86 per year from the above listed entities.

Unused and Underutilized Buildings: (Green Key on Map)

- New Horizons Building (vacant space)
- Cottage 4 (vacant space)
- Pleasant View Building (slated for demolition)
- Refectory Building (slated for demolition)

The current emphasis of the LSTC is to lease space to community entities in the New Horizons Building. Also, as we continue to transition residents our emphasis will be to fill space that will become available in the Health Services Center and the Professional Services Building.

A committee of local community leaders is considering a legislative request to purchase and develop the Prairie View Building into affordable rental housing for the community. If this rental project becomes a reality, the current tenants from the Prairie View Building would be relocated to the New Horizons Building.
