Chairman Lee and members of the Health Services Committee, I am Tina Bay, Director of the Developmental Disabilities (DD) Division of the Department of Human Services (Department). I am here today to provide information about DD initiatives and the rate payment methodology.

DD Initiatives

The DD division is currently in the process of drafting the renewal of the DD traditional home and community based services (HCBS) waiver. This waiver, which has the capacity to serve 5,680 people, expires on March 31, 2019. To continue providing these HCBS services, the waiver must be submitted to the Centers for Medicare and Medicaid Services (CMS) no later than January 1, 2019. The division hosted public meetings in May and June to gather feedback from stakeholders. Changes that will better address the needs of clients with significant medical needs and those transitioning from an institution are being considered, along with the comments from the public meetings. Prior to the waiver being submitted to CMS, a public comment period will be available.

Additionally, the DD division and other divisions within the Department continue to look at solutions to address the gaps in services identified in the technical assistance report. As mentioned in previous hearings, consideration is being given to the creation of a children's waiver, changes to eligibility and additional services being added to existing waivers.

DD Rate Payment Methodology

The steering committee has had two meetings since the April 1, 2018 implementation. At the request of the steering committee, two subcommittees, one for quality measures and the other for outliers, will meet prior to the August meeting. The purpose of the quality measures subcommittee is to develop a quality measure that will track employment services. The outlier sub-committee will look at the outlier denials to determine if it is appropriate to make recommendations to change the current criteria. Attached is an updated summary of the outlier activity.
