## **Educational Seminars for Direct Care Workers to be Held in Southwest North Dakota**

Qualified service providers are friends, neighbors, family members, and others who provide in-home care to older adults and people with disabilities so they can continue to live in their own homes and communities.

The meeting will include an interactive online demonstration on how to complete enrollment forms and billing documents, an overview of programs and services available through the department that support independent living, and a review of provider rates and reimbursement requirements. There will also be a discussion about how to become a qualified service provider, as well as the responsibilities associated with being a caregiver.
