The council meets quarterly to hear reports and to advise the N.D. Department of Human Services' Division of Vocational Rehabilitation on issues relating to policy and strategic planning, and promoting increased employment opportunities for people with disabilities. The council consists of 15 members appointed by the governor including people with disabilities, community rehabilitation providers, independent living centers, representatives from various tribal and state agencies, and statewide business leaders.
