## **Traumatic Brain Injury Advisory Committee to Meet July 2**

BISMARCK, N.D. – The N.D. Department of Human Services' Traumatic Brain Injury Advisory Committee will meet on Tues., July 2, 2013, from 1:30 to 4:00 p.m. by means of three video conference sites in North Dakota.

The committee meets quarterly to advise the department on program and policy developments to help meet the needs of individuals with traumatic brain injuries and their families.
