## N.D. Autism Spectrum Disorder Task Force to Meet Dec. 10

BISMARCK, N.D. - North Dakota's Autism Spectrum Disorder Task Force will meet Wednesday, Dec. 10, 2014, from 10:30 a.m. to 3:30 p.m. Central Time using eight video conference meeting sites across the state.
