Autism Spectrum Disorder Task Force to hold Nov. 14 meeting

BISMARCK, N.D. – North Dakota's Autism Spectrum Disorder Task Force will meet Monday, Nov. 14 from 10 a.m. to 4 p.m. Central Time, in Bismarck and via video conference sites across the state to review developments in services for children with autism spectrum disorders and their families.

The advisory group meeting is open to the public and will originate from the North Dakota Department of Human Services' Prairie Hills Plaza location in the Prairie and Rose Room, 1237 W. Divide Ave., Suite 1A, in Bismarck.
