Developmental Disabilities Home and Community Based Services (HCBS) Provider Survey

Background: The HCBS Provider Survey is for Developmental Disability (DD) licensed providers who offer residential and day services to people with intellectual and developmental disabilities. This survey was developed by the DD Division with input from providers and stakeholders. It will be implemented to evaluate providers, to ensure individuals are receiving quality services as identified in their plan, to assess provider compliance with state, federal, and HCBS requirements, and to develop strategies for improvement where issues are identified.

Current services in the survey include: congregate care (CC), family care options III (FCO III), individualized supported living arrangement (ISLA), minimally supervised living arrangement (MSLA), supported living arrangement (SLA), transitional community living facility (TCLF), and day habilitation service (day supports).

People receiving services, legal decision makers, family members, advocates, licensed developmental disabilities services providers (program coordinators, quality assurance, CEO's), DD program managers and administrators, and others interested in the survey or who will be involved with the implementation.
